BACKGROUND

At its meeting of 12 September 2012, City Council approved a new structure for its <u>Advisory Committees</u>, which aligns these committees with the Term of Council Priorities. Subsequently on July 8, 2015, City Council approved the <u>Term of Council Priorities</u> for the 2014 – 2018 Term of Council.

Departmental staff were instrumental in assisting the French Language Services Advisory Committee in preparing it 2015-2018 work plan. As a result, City Council approved the Committee's work plan on October 14, 2015.

DISCUSSION

The French Language Services Advisory Committee reviewed its 2015-2018 work plan and determined that some dates and activities required amending as described below:

- Objective 1: Support the development of a fully bilingual program and promotional activities for the City of Ottawa celebrations surrounding the 150th anniversary of Canada's Confederation in 2017.
 - Activities 1 and 2 Removed 2018 dates
- Objective 2: Support the growth of Francophone and Francophile businesses in Ottawa
 - Activity 1 Timelines have changes to be consistent with the meeting agendas
 - Revised department/branch names to reflect new titles
- Objective 3: Approach that helps increase the provision of recreational activities in French

Activity 1 (NEW) – Provide advice to the Elections Office on developing training and promotional material related to the active offer of services in both languages as well as provide additional strategies to recruit a great number of staff able to communicate in French at voting places for the 2018 municipal elections.
