FOR THOSE WHO ARE ABLE TO, COULD YOU PLEASE RISE FOR A MOMENT OF PERSONAL REFLECTION AND REMAIN STANDING AS COUNCILLOR HARDER INTRODUCES OUR NATIONAL ANTHEM. >> REMAIN STANDING AND COUNCILLOR HARDER WILL INTRODUCE OUR NATIONAL ANTHEM. >> THANK YOU, MR. MAYOR. GOOD MORNING. TODAY WE WILL HAVE A BIT OF A DIFFERENT NATIONAL ANTHEM IN THAT WE ARE GOING TO PLAY A RECORDING DONE BY BIG SOUL PROJECTS. THIS GROUP IS OTTAWA'S LARGEST COMMUNITY CHOIR, WHOSE 150 MEMBERS SHARE SONGS OF HOPE, LOVE AND PEACE TO PROMOTE A SENSE OF JOY AND EMPOWERMENT. THEIR MOTTO, LIFTING YOU HIGHER, APPLIES TO BOTH CHOIR MEMBERS AND AUDIENCES TO LEAVE A PERFORMANCE FEELING LIFTED SPIRITUALLY AND EMOTIONALLY BY THEIR FRESH, UPBEAT BAND OF CHORAL MUSIC. ESTABLISHED IN 1997 AND UNDER THE DYNAMIC LEADERSHIP OF ROXANNE GOODMAN, SINCE 2008, BIG SOUL PROJECT USES THE VOCAL ENERGY OF A LARGE CHOIR WITH THE SMOOTH SOUND OF A TALENTED HOUSE BAND CALLED DEEP GROOVE. BIG SOUL PROJECT HAS GAINED A REPUTATION FOR ITS ABILITY TO ENTERTAIN AND INSPIRE. THEIR INCREDIBLE ON STAGE ENERGY AND ENTHUSIASM HAVE AUDIENCES SINGING IN THEIR SEATS AND DANCING IN THE AISLES. THEY FEATURE MEMBERS FROM ALL AREAS OF THE CITY, AND IF YOU LOOK REALLY CLOSELY AT THE VIDEO, YOU MIGHT JUST SEE WHAT SOME MEMBERS OF COUNCIL DO AFTER THEY ARE NO LONGER ELECTED. I'M PLEASED TO SHOWCASE THEM FOR YOU HERE THIS MORNING. LET'S HAVE A LISTEN. [Applause] >> AND THAT WOULD HAVE BEEN CLAUDE DOUCET THAT YOU SAW IN THE CHOIR. >> I'D NOW ASK MR. GLENN MOONEY AND OSGOODE COUNCILLOR GEORGE DAROUZE TO COME FORWARD FOR THE PRESENTATION OF THE MAYOR'S CITY BUILDER AWARDS. [SPEAKING IN FRENCH] >> WELCOME. I'M ALSO VERY PLEASED TO WELCOME THE FRIENDS AND FAMILY OF MR. MOONEY, INCLUDING HIS WIFE PAM WHO JOINS US HERE TODAY. THE MAYOR CITY BUILDER AWARD RECOGNIZES EXTRAORDINARY COMMITMENT TO MAKING OUR CITY A BETTER PLACE TODAY AND THROUGHOUT THE FUTURE THROUGH OUTSTANDING VOLUNTEERISM AND EXEMPLARY ACTION. I'M HONOURED TO PRESENT THIS AWARD TODAY TO MR. GLENN MOONEY, THE DIRECTOR OF CAMP QUALITY OF EASTERN ONTARIO, A NATIONAL CHARITABLE ORGANIZATION, DEVOTED TO PROVIDING FREE CAMP EXPERIENCES AND YEAR-ROUND PROGRAMMING FOR CHILDREN WITH CANCER. THE INCREDIBLE OPPORTUNITY TO CREATE A PROGRAMME OF EMPOWERMENT, ENCOURAGEMENT AND MOST IMPORTANTLY FUN FOR THESE AMAZING KIDS. GLEN PROJECTS A WARM, CHEERFUL ATTITUDE TO THE CAMPERS, PARENTS, VOLUNTEERS AND EVERYONE HE INTERACTS WITH. HE RESOLVES CONFLICTS AND HANDLES OTHER DIFFICULT SITUATIONS WITH REMARKABLE PATIENCE AND ADMIRABLE TACT. HE LOVES PEOPLE, WORKS HARD AND ALWAYS TRIES TO LIFT THE SPIRITS OF THOSE AROUND HIM. (End of Translation) >> ON BEHALF OF YOUR COUNCILLOR GEORGE DAROUZE AND THE ENTIRE CITY COUNCIL AND NUR COMMUNITY TO CONGRATULATE YOU AND KEEP UP THE WORK GOOD WORK. CONGRATULATIONS. [Applause] >> THANK YOU, MR. MAYOR AND COUNCIL, FOR AN AMAZING HONOUR. THIS WEEK AS I THOUGHT OF COMMUNITY, I THINK WE NEED NOT LOOK ANY FURTHER THAN "THE EVENING NEWS" TO SEE THIS COMMUNITY PULL TOGETHER. I THOUGHT OF HOW COMMUNITY HAS HELPED US, SO PAM AND I AND A BUNCH OF FRIENDS STARTED SOMETHING, WE DIDN'T KNOW WHAT WE WERE DOING, ABOUT 18 YEARS AGO, AND THIS COMMUNITY STEPPED UP AND \$5, \$10, AND \$20 INCREMENTS HELPED US CREATE A WHOLE LOT OF SMILES ON SOME AMAZING KIDS THAT REALLY DESERVE A LOT OF SMILES. VOLUNTEER-WISE, EVERYBODY IN THIS ORGANIZATION'S A VOLUNTEER, FROM OUR NURSES TO DOCTORS. THE PEOPLE THAT ARE HERE TODAY TO HELP US ORGANIZE THIS. THE MOST UNIQUE PART OF CAMP IS THAT EVERY CAMPER IS PAIRED WITH

WHAT WE CALL A COMPANION. COMPANIONS, TYPICALLY 19 TO EARLY 30-YEAR-OLDS, IT'S NEAT. IF YOU WENT TO CAMP AND YOU HAD YOUR OWN COUNCILLOR FOR THE FULL WEEK FOCUSED ON MAKING IT BE A FUN EXPERIENCE AND HELPING YOU GROW, THAT'S WHAT THIS IS ALL ABOUT. AND WHEN I REFLECT ON THAT I GET TO SPEND TIME WITH SOME PRETTY AMAZING YOUNG ADULTS AND THE ONE THING I OFTEN HEAR PEOPLE SAY IS WE'RE IN TROUBLE WITH THE NEXT GENERATION. I CAN ASSURE YOU, WE'RE NOT IN TROUBLE. WE'RE IN VERY GOOD HANDS IN THIS COMMUNITY WITH THE YOUNG PEOPLE THAT ARE COMING UP IN THIS, IN OUR COMMUNITY. THANK YOU VERY MUCH. MAYOR. >> HERE. >> YOU HAVE A QUORUM. >> TODAY HUNDREDS AND THOUSANDS OF PEOPLE WILL BE GOING ABOUT THEIR ROUTINE ACROSS OUR DAILY CITY BUT THAT'S NOT THE CASE FOR HUNDREDS OF OUR FELLOW RESIDENTS IN FITZROY HARBOUR. CUMBERLAND, BRITANNIA, AND CRYSTAL BEACH, WHOSE LIVES HAVE BEEN GREATLY AND DIRECTLY IMPACTED BY THE FLOODING OF THE OTTAWA RIVER. THESE RESIDENTS OUR FRIENDS AND OUR NEIGHBOURS NOW HAVE TO GET ON WITH THE TOUGH TASK OF REBUILDING THEIR HOMES AND REBUILDING THEIR LIVES. THESE WILL BE TOUGH TIMES FOR THESE RESIDENTS. THERE WILL BE, OF COURSE, THE PHYSICAL TOLL, THE FINANCIAL IMPACT AND EMOTIONAL STRAIN CAUSED BY THE FLOODING. AT YESTERDAYS INFORMATION SESSIONS I MET MANY IMPACTED FAMILIES AND INDIVIDUALS AND IT WAS AN EMOTIONAL TIME FOR ALL OF THE RESIDENTS AT THESE TOWN HALL MEETINGS. I ALSO HEARD STORIES OF GREAT HOPE. COMMUNITIES COMING TOGETHER AND THE KINDNESS OF COMPLETE STRANGERS. PEOPLE PULL TOGETHER TO HELP ONE ANOTHER. AND DEMONSTRATED EXCEPTIONAL RESOLVE AND DETERMINATION IT

UNFORTUNATELY NOT ALWAYS WITH A SUCCESSFUL ENDING. THIS MORNING THERE IS A SHIMMER OF GOOD NEWS. THE SUN IS OUT AND I CAN CONFIRM THAT WATER LEVELS ARE IN FACT DROPPING. AS OF YESTERDAY, BY TWO CENTIMETRES IN CONSTANCE BAY, BUT FIVE CENTIMETRES IN BRITANNIA, AND BY 12 CENTIMETRES IN CUMBERLAND. >> (Voice of Translator): WE ARE ANCHORED BY THE RETURN OF THE SUN BUT FOR THE EFFECTED RESIDENTS, THE WORK HAS ONLY STARTED NOW. (End of Translation) >> A TOTAL OF 346 PROPERTIES IN THE OTTAWA AREA HAVE BEEN IMPACTED AND THAT ABOUT 155 FAMILIES HAVE HAD TO LEAVE THEIR HOMES IN WEST CARLETON, 323 PROPERTIES ARE IMPACTED, AND 137 FAMILIES HAD TO EVACUATE. IN CUMBERLAND, 21 PROPERTIES ARE IMPACTED AND 18 FAMILIES HAD TO LEAVE THEIR HOMES, AND BRITANNIA, TWO PROPERTIES WERE IMPACTED. AND WE ALSO KNOW THAT THERE WERE PROPERTIES IN COUNCILLOR MONETTE'S WARD AS A RESULT OF EROSION OF THE RAVINE. IT'S BEEN MY HONOUR AND PRIVILEGE TO SPEND SOMETIME WITH AFFECTED RESIDENTS OVER THE WEEKEND AND OVER THE LAST FEW DAYS, AND I'LL BE BACK IN CONSTANCE BAY WITH COUNCILLOR EL-CHANTIRY FOR OUR FOURTH TOWN HALL MEETING. OUR FOCUS TURNS FROM EMERGENCY RESPONSE TO RECOVERY CLEANUP EFFORTS IN THE EFFECTED COMMUNITIES. WHILE WE'RE STILL CONTINUING OUR EFFORTS TO STABILIZE AND RESPOND WE'RE ACTIVELY MOVING TO THE RECOVERY PHASE. AS WE MOVE TO THIS NEW PHASE OF OPERATIONS, I WANT TO OFFER SOME THOUGHTS ON HOW OUR CITY HAS RESPONDED TO DATE TO THIS EMERGENCY. IT'S BEEN VERY EMOTIONAL. AND I'VE FOUND MYSELF PERSONALLY VERY TOUCHED BY THE OUTPOURING OF COMMUNITY SUPPORT AND VOLUNTEERING IN THE EFFECTED AREAS, BUT ALSO THE PROFOUND SENSE OF LOSS FOR THE IMPACTED RESIDENTS. AS OF YESTERDAY, OVER 2,000 VOLUNTEERS HAD ALREADY SIGNED UP ON OTTAWA.CA TO CONTINUE SUPPORTING THEIR FRIENDS AND NEIGHBOURS WHOSE PROPERTIES HAVE BEEN DAMAGED OR LOST. I SALUTE AND THANK ALL OF THESE RESIDENTS WHO HAVE SURVIVED THIS ORDEAL AND THOSE WHO HAVE GIVEN OF THEIR TIME AND ENERGY TO HELP IN THE MOST SERIOUS FLOOD OF THE OTTAWA RIVER I'VE CERTAINLY WITNESSED IN MY TIME. I ALSO WANT TO THANK OUR MANY FIRST RESPONDERS, POLICE, FIRE AND PARAMEDICS, AND IN PARTICULAR, IN THE RURAL COMMUNITIES, THE VOLUNTEER TIRE FIGHTERS WHO HAVE REALLY GONE ABOVE AND BEYOND THE CALL OF DUTY TO HELP FELLOW NEIGHBOURS IN THEIR COMMUNITY, AS WELL AS CITY STAFF, COMMUNITY

PARTNERS WHO HAVE BEEN WORKING TIRELESSLY, I THINK OF THE CONSTANCE BAY LEGION, FOR INSTANCE, THAT'S BECOME A HUB FOR THE COMMUNITY, PROVIDING HOT MEALS AND COMFORT TO RESIDENTS IN DISTRESS. I THINK THE INFORMATION SESSIONS HELD YESTERDAY WERE A GOOD START AND WE'LL HOLD ANOTHER ONE AS I MENTIONED IN CONSTANCE BAY THIS EVENING BUT I CHALLENGE EACH AND EVERY ONE OF US INCLUDING OUR SOFT TO DO EVEN MORE. WE NEED TO CONTINUE TO BE THOUGHTFUL AND APPROACHABLE IN OUR RESPONSE, INSTEAD OF BUREAUCRATIC. UNDERSTANDABLY, MANY RESIDENTS ARE DEALING WITH THE ACUTE AFFECTS OF THIS TRAGEDY IN OTTAWA. I ASK ALL RESIDENTS TO BE MINDFUL OF THIS EMOTIONAL TIME AND TO DO WHAT THEY CAN TO REACH OUT TO THEIR RESPECTIVE CIRCLE, NEIGHBOUR, FRIENDS AND RELATIVES WHO MAY BENEFIT FROM CONTINUED SUPPORT. IF YOU'RE ABLE TO, I ASK THAT YOU SIGN UP TO VOLUNTEER TO HELP WITH THESE CLEANUP EFFORT. BECAUSE THE CLEANUP IS GOING TO BE MASSIVE. IF YOU GO INTO THOSE COMMUNITIES, YOU SEE FIRSTHAND LOGS, HOT WATER HEATERS, DEBRIS THAT IS WASHING UP ON PEOPLE'S PRIVATE PROPERTY IN THE DITCH SYSTEM AND ON OUR ROADS. I'VE ALSO ASKED COUNCILLOR BLAIS TO INTRODUCE A MOTION TODAY -- COUNCILLOR BLAIS TO INTRODUCE A MOTION FOR MID-JUNE FOR THESE RESIDENCES AFFECTED BY THE FLOOD, DELAY TO SEPTEMBER 2017. IT'S A MODEST MEASURE BUT I KNOW THAT EVERY LITTLE BIT HELPS. OVER THE COURSE OF THE NEXT COMING DAYS AND WEEKS AS WATERS RECEDE, WE'LL GET A BETTER IDEA OF WHAT SPECIFIC HELP WILL ASSIST IMPACTED COMMUNITIES. AS WE WORK TO UNDERSTAND THE ORDER OF MAGNITUDE OF THE RECOVERY EFFORT, WE'RE AWARE THAT THOSE MOST DIRECTLY AFFECTED BY THE FLOOD HAVE BEEN PUSHED PAST THE POINT OF EXHAUSTION. WE KNOW THAT MENTAL HEALTH SERVICES ARE A KEY SUPPORT. SOME PEOPLE WILL HAVE LOST LITERALLY EVERYTHING. OTHERS WILL HAVE A CLEANUP OPERATION THAT SEEMS INSURMOUNTABLE. IN ADDITION TO THE PHYSICAL SERVICE, WATER TEST, CULVERT REPAIR, DUMPSTERS AND ALL THE REST WILL BE LETTING PEOPLE KNOW THEY HAVE ACCESS TO COUNSELLING RESOURCES IN THE COMMUNITY. I KNOW THAT OUR CITY WILL CONTINUE TO SHOW SUPPORT ON THE GROUND BUT MORE THAN THAT, OTTAWA WILL PULL TOGETHER WITH COMPASSION AND GENEROSITY TO SUPPORT THESE RESIDENTS IMPACTED BY THE FLOODING AS THEY WORK TO REBUILD THEIR LIVES. I KNOW THAT OUR CITY AND OUR RESIDENTS ARE UP TO THAT CHALLENGE. AND WE WANT OUR RESIDENTS TO

KNOW THAT WE ARE COMMITTED TO RESPONDING TO RESIDENTS' NEEDS TO THE BEST OF OUR ABILITIES. SUPPORTING OUR RESIDENTS OBVIOUSLY IS PRIORITY NUMBER ONE. >> (Voice of Translator): OUR PRIORITY NUMBER ONE IS TO ASSIST OUR RESIDENTS? (End of Translation) >> MONETARY DONATIONS SHOULD BE MADE TO THE CANADIAN RED CROSS AND IN-KIND DONATIONS SUCH AS FURNITURE AND CLOTHING AND SO ON SHOULD BE GIVEN TO THE SALVATION FARM ARMY. >> (Voice of Translator): TO I WANT EVERYONE TO KNOW THAT DONATIONS IN MONEY SHOULD BE GIVEN TO THE CANADA RED CROSS AND OTHER DONATIONS TO THE SALVATION ARMY. >> I'D LIKE TO THANK OUR THREE COUNCIL COLLEAGUES WHO HAVE BEEN ON THE FRONT LINES OF THIS NATURAL DISASTER FROM DAY UP ON ONE, COUNCILLOR BLAIS, EL-CHANTIRY HAVE BEEN ABLE TO CONNECT WITH THEIR RESIDENTS IN A THOUGHTFUL AND COMPASSIONATE FASHION. I SAW THAT FIRST HAND OVER THE COURSE OF MY VISITS TO THE COMMUNITIES AND I THINK YOU CAN BE VERY PROUD OF YOUR COLLEAGUES FOR THE JOB THEY HAVE DONE. BECAUSE THEY HAVE BEEN ROCK SOLID IN GETTING CITY SERVICES TO THE AFFECTED AREAS, WORKING CORROBORATIVELY WITH OUR EMERGENCY MANAGEMENT TEAM AND I WANT TO THANK STEVE KANELLAKOS AND HIS TEAM, ANTHONY DIMONTE HAS BEEN AT THE MEETINGS, OUR OTHER GENERAL MANAGERS HAVE BEEN AT THE OTHER MEETINGS AS WELL AND IT'S BEEN A TEAM EFFORT BUT I KNOW WE HAVE MUCH MORE WORK TO DO. I'M GOING TO ASK MEMBERS OF COUNCIL, THE THREE COUNCILLORS TO SAY A FEW WORDS AND ASK CITY MANAGER STEVE KANELLAKOS AND TONY DIMONTE TO SAY A FEW WORDS AND I'LL ASK COUNCILLOR BLADE TO START THE MOTION WITH RESPECT TO TAX DEFERRAL. WE'LL BEGIN WITH COUNCILLOR TAYLOR, PLEASE. COUNCILLOR TAYLOR. >> THANK YOU VERY MUCH, MR. MAYOR, AND I WANT TO START JUST BY RECOGNIZING THAT IN MY COMMUNITIES OF BRITANNIA, BELL TOWN AND CRYSTAL BAY THAT HAVE BEEN AFFECTED. I COULD NOT BEGIN ANY SENTENCE WITHOUT FIRST SAYING HOW AMAZING THE VOLUNTEERS IN THIS COMMUNITY, IN THESE COMMUNITIES HAVE BEEN. FROM THE MOMENT THE WATER STARTED RISING AND THE RAIN STARTED FALLING, MEMBERS OF THE COMMUNITY, MANY OF WHOM WERE NOT FORMALLY CONNECTED TO THE COMMUNITY ASSOCIATION OR INVOLVED IN COMMUNITY ACTIVITIES SHOWED UP AT SAND DUMPS AND SHOWED UP AT EACH OTHER'S DOORS TO HELP OUT, TO SANDBAG NEIGHBOUR'S HOMES TO DO WHATEVER THEY COULD TO HELP PREVENT THE LOSS THAT WAS GOING TO BE EXPERIENCED, THAT WE EXPECTED WAS

GOING TO COME, AND EFFECT OUR NEIGHBOURS. TO THOSE VOLUNTEERS AND TO THOSE COMMUNITY MEMBERS, I WANT TO SAY YOU ARE THE TRUE HEROES OF THIS ENTIRE CRISIS. YOU'RE THE ONES WHO SPRANG INTO ACTION AND WORKED WITH PASSION ON BEHALF OF ALL OF YOUR NEIGHBOURS. I WANT TO ECHO THE MAYOR'S COMMENTS TO VIRTUALLY EVERY CITY DEPARTMENT, AS WE SEE THIS MORNING, EVEN THE REVENUE DEPARTMENT, THAT THE CITY HAS FOUND A WAY TO HELP TO ADDRESS OUR RESIDENTS ACROSS THE CITY AND SO THANK YOU VERY MUCH OFTEN TIMES WE GET CALLED UPON TO DEBATE POLICY AND GO THROUGH VERY DRY REPORTS. IT'S NOT OFTEN THAT WE GET TO SEE YOU IN ACTION DELIVERING MEANINGFUL SERVICES TO OUR RESIDENTS THAT ARE GOING TO CHANGE THEIR LIVES AND PROTECT THEM FROM LOSS IN THE WAY THAT WE DID IN THIS CASE. SO THANK YOU SO MUCH. THIS IS AN EXAMPLE OF PEOPLE PULLING TOGETHER. I THINK PROBABLY ONE OF THE MOST POIGNANT EXAMPLES WE'VE SEEN IN OTTAWA IN A WHILE OF PEOPLE PULLING TOGETHER. CERTAINLY WE SAW THAT IN THE SYRIAN REFUGEE CRISIS. THIS WAS A DIFFERENT TYPE OF CRISIS BUT ANOTHER EXAMPLE OF WHAT MAKES OTTAWA SUCH AN OUTSTANDING CITY. THE PROPERTY LOSS THE MAYOR SPOKE OF, OF COURSE, IS VERY REAL. THE MENTAL HEALTH IMPACTS HE SPOKE OF ARE ALSO VERY REAL. AND IT'S MY HOPE THAT RESIDENTS WHO ARE FEELING THAT LOSS MORE PROFOUNDLY THAN OTHER, PERHAPS SEEK THE COUNSEL -- WE'RE ENDEAVOURING TO MAKE THAT AVAILABLE, SEEK THAT MENTAL HEALTH COUNSEL WHEREVER YOU CAN TAKE IT. CERTAINLY THIS IS A TRAUMATIC EFFECT FOR ALL AND THEY MAY NOT REALIZE IT FOR SOMETIME. ONE BRIGHT SHINING MOMENT I WILL SAY, AT THE BRITANNIA YACHT CLUB WHICH WAS FLOODED OUT ON THE GROUND FLOOR, THERE WAS A WEDDING SCHEDULED TO TAKE PLACE LAST SUNDAY AND THE FIRE SERVICES WENT IN WITH PUBLIC WORK AND DID EVERYTHING THEY COULD TO ENSURE. ALTHOUGH THEY HAD TO RELOCATE UPSTAIRS. THE WEDDING TOOK PLACE. I WAS THERE AS THE RAIN WAS STOPPING AND THE BRIDE AND GROOM WERE LIVING. WE WERE IN THE BACKGROUND, NOT IN THE WEDDING PARTY, BUT IT WAS AN AMAZING POINT OF LIGHT TO SEE HOW SOMETHING SO SMALL ON THE GRAND SCALE OF THE EVENT WE WERE CONFRONTED WITH, BUT SO MEANINGFUL FOR THAT COUPLE THAT WERE GETTING MARRIED THAT DAY, WAS MADE POSSIBLE BY THE VOLUNTEER, THE STAFF AT THAT YACHT CLUB AND THE CITY STAFF WHO MADE SURE THAT THEY WERE ABLE TO MOVE FORWARD. THE SUN IS COMING OUT TODAY, THE WATER

LEVELS ARE RECEDING, WE'VE HEARD THAT AND THINGS ARE STARTING TO DRY OUT A BIT, BUT OUR TEAM CONTINUES TO WORK THROUGH THIS THE ONLY WAY THIS THEY CAN DO THINGS SUCCESSFULLY IN OTTAWA. TOGETHER, AND I WANT TO THANK EVERYBODY FROM VOLUNTEER. COMMUNITY MEMBERS, RESIDENT, CITY STAFF TO THE BUSINESSES THAT HAVE STEPPED UP FOR THE AMAZING RESPONSE ON BEHALF OF BAY WARD RESIDENTS AND CITY RESIDENTS. THANK YOU, MR. MAYOR. >> THANK YOU, COUNCILLOR BLAIS, PLEASE. >> THANK YOU VERY MUCH, MR. MAYOR, AND CERTAINLY THE OBSERVATIONS ABOUT YOU AND COUNCILLOR TAYLOR ALREADY MADE ARE PARALLELLED IN CUMBERLAND. THE COMMUNITY SPIRIT THAT HAS COME OUT OF THIS HAS BEEN TRULY AMAZING. IT'S DEMONSTRATED THE RESILIENCE OF THESE COMMUNITIES, MANY OF WHOM STUCK IT OUT THE ENTIRE TIME. I'M THINKING OF ERICA AND ALFRED. ERICA, EIGHT AND A HALF MONTHS PREGNANT WITH THEIR SECOND CHILD AND SHE AND AL STUCK IT OUT UNTIL FIRE SERVICES DEEMED IT FAR TOO DANGEROUS FOR THEM TO STAY. AND THINKING OF THE VOLUNTEERS THAT HELPED DELIVER THE SAND AND THE SANDBAGS AND PARTICULARLY FROM OUR CITY LOSE CREWS, THE RURAL SUPERVISOR, MAX AMER AND OUR AREA MANAGER, MATT CAVANAUGH WENT ABOVE AND BEYOND TO ORGANIZE THE DELIVERY OF SAND AND THE BAGS AND COORDINATE BETWEEN THE TWO NEIGHBOURHOODS, AND OF COURSE, AS YOU MENTIONED. THE VOLUNTEER FIREFIGHTERS OUT OF STATION 72 IN CUMBERLAND AND THE WATER RESCUE TEAM OUT OF STATION 53 IN ORLÉANS WERE AMAZING. GOING DOOR TO DOOR, CHECKING ON PEOPLE TO ENSURE THEY WERE SAFE, DEVELOPING PLANS TO GET THEM OUT, ESPECIALLY FOLKS SURROUNDED BY WATER AND IN POTENTIALLY DANGEROUS SITUATIONS. IT REALLY HAS BEEN TRULY SOMETHING TO SEE EVERYONE COME TOGETHER. WE CAN'T FORGET THE DONATIONS FROM LOCAL BUSINESSES, WHETHER IT WAS COFFEE FROM THE BLACK WALNUT BAKERY OR HEAVY EQUIPMENT DONATED BY ANY NUMBER OF CONTRACTORS AND THE LABOUR AND THE FUEL TO MAKE THAT WORK. IT'S TRULY BEEN AN AMAZING SIGHT TO SEE, AND THE COMMITMENT OF THE CITY TO HELP THESE FOLKS AS WE GO INTO THAT RECOVERY STAGE AND HELP THEM TO BEGIN THEIR LIVES IS TRULY APPRECIATED BY THOSE RESIDENTS AS WE SAW YESTERDAY AND I KNOW TOGETHER THEY'LL BE ABLE TO GET THROUGH THIS IT THANK YOU VERY MUCH. >> THANK YOU, MERCI. COUNCILLOR EL-CHANTIRY, PLEASE. >> THANK YOU, MR. MAYOR, AND I BELIEVE MY COLLEAGUE, I ECHO THEIR SENTIMENT ABOUT OUR STAFF AND

ABOUT THE VOLUNTEERS. THERE ARE MANY VOLUNTEERS CAME FROM ALL OVER THE CITY. ACTUALLY FROM ALL OVER THE OTTAWA VALLEY TO SHOW UP. SOME OF THEM DON'T EVEN KNOW WHERE CONSTANCE BAY WAS, AND SURE ENOUGH, THEY STEPPED TO THE PLATE. THEY HELP US. I BELIEVE IN WEST CARLETON WE FILLED AROUND 95,000 BAGS OF STAND, AND I CANNOT SAY ENOUGH THANK YOU TO EVERYONE IN THE CITY SERVICES. THE TRUCKS KEPT GOING. EVEN SOME OF OUR LOCAL BUSINESS OPEN HIS PIT TIE LOU THE CITY TO PICK UP SAND FROM HIM INSTEAD OF GOING A LONGER DISTANCE BECAUSE WE CAN NOT BRING ENOUGH SAND OVER FAST ENOUGH. SO NO MATTER HOW MANY TIME WE SAY THANK YOU. I DON'T THINK WE'LL SAY IT ENOUGH, MAINLY TO THE VOLUNTEERS, MAINLY TO CONSTANCE BAY COMMUNITY CENTRE. YOU KNOW IN THE RURAL AREA, COMMUNITY CENTRES RUN BY VOLUNTEERS. THE LEGION, RUN BY VOLUNTEERS. THE LEGION, OPEN 24/7 FOR OUR CITY SERVICES. FOR THE RED CROSS. FOR ACCOMMODATION AND ALSO TO PROVIDE MEALS AND FOOD TO EVERYONE BECAUSE YOU'VE GOT TO REMEMBER, IT'S NOT JUST THE VOLUNTEERS NEED TO EAT. THEY HAVE PEOPLE CANNOT USE THEIR FACILITY OR THEIR HOMES TO COOK THEIR OWN MEAL. BUT YET THEY DIDN'T WANT TO LEAVE HOME BECAUSE THEY HAVE TO MONITOR THE WATER LEVEL. AND I KNOW IT IS A GOOD NEWS, AND I JUST CHECKED THE WEBSITE YESTERDAY, WE'RE DOWN A FEW CENTIMETRES. BUT IF I PUT IT IN CONTEXT HOW MUCH WE WERE HIGHER, SO YOU'LL UNDERSTAND WHAT YOU'RE LOOKING AT, SO TODAY WE ARE A METRE AND A HALF HIGHER THAN NORMAL WATER LEVEL. WITH TODAY'S REDUCED WATER IN THE RIVER WILL BRING US BACK ONLY TOP 1979. AND THE WATER LEVEL WE SAW. ACCORDING TO MISSISSIPPI VALLEY CONSERVATION INFORMATION WAS FROM 1928. THAT WAS THE HIGHEST. SO WHEN WE TALK ABOUT REDUCE, I THINK RIGHT NOW WHAT'S IMPORTANT TO CONTINUE, THAT SUPPORT TO THE COMMUNITY. NOW WE DON'T NEED VOLUNTEERS TO FILL UP SANDBAG ANYMORE. AND YET WE'RE NOT IN A RECOVERY MODE YET. SO WE HAVE TO WAIT. AND YESTERDAY IN A MEETING WE LEARNED SOMETHING FROM DR. ISRAEL LEVY, THAT MEANS EVERYTHING TOUCH WATER, POSSIBILITY OF CONTAMINATION. WHETHER THE WOOD YOU SEE ON THE ROAD, WHETHER ANY MATERIAL, ANY FURNITURE, ANY WALL, ANY CARPET, POSSIBILITY OF CONTAMINATION BECAUSE THE RIVER IS CONTAMINATED. WE HAVE SOME, UNFORTUNATE SOME SEWER BUSTED FROM UP THE LINE DOWN TO THE RIVER AND THAT'S SOMETHING WE REALLY -- SO WHAT WE ARE ASKING YOU, MR. MAYOR, ASKING MY COLLEAGUES, LET'S NOT JUST TAKE

THE GLOVES OFF AND SAY OKAY, WELL NOW THE WATER'S -- SUNNY DAY AND NOW THE WATER'S DOWN. WE NEED TO KEEP SUPPORTING THAT COMMUNITY. WE NEED ONE POINT OF CONTACT. WHEN SOMEBODY HAVE A QUESTION, AND I DO APPRECIATE THE 3-1-1, THEY WERE OVERWHELMED WITH CALL. MY OFFICE WAS OPEN ON THE WEEKEND ALSO, FULLY STAFFED TO ANSWER SOME QUESTION, BUT WE NEED TO CONTINUE. SO DURING THE FLOODING, WE HAVE INSTANT COMMAND ON SITE. THEY DID A TERRIFIC JOB. VOLUNTEER, FIRE AND PARAMEDIC, EVERYONE DID A TREMENDOUS JOB BUT I SEEN THE OPERATION TODAY START DWINDLING DOWN, AND RIGHTLY SO, IF WE DON'T NEED IT, WE DON'T WANT IT THERE, BUT WE NEED TO KEEP IN MIND THE RECOVERY AND THE IMPACT ON THE PEOPLE WHEN THEY WALK INTO THEIR HOME. AND I KNOW, I WANT TO CLARIFY THIS, A LOT OF PEOPLE SAY YOU LOST YOUR HOME, ELI. NO, SO LET ME BE CLEAR. I LIVE IN CARP. MY WIFE AND I LIVE IN CARP. THAT'S NOT OUR PRIMARY RESIDENCE IN CONSTANCE BAY. THAT'S OUR HOUSE, WE OWN SINCE 1994, IT'S WINTERIZED AND WE HAVE A FAMILY FRIEND LIVE IN IT. SHE WAS RESCUED ON FRIDAY BY THE FIRE DEPARTMENT, THEY DIDN'T WANT HER TO STAY ALONE BECAUSE THE SITUATION, AND JUST FOR THE RECORD, I THINK COUNCILLOR MOFFAT WAS THERE AND HE SAID YOU'RE THE ONLY HOUSE THAT DOESN'T HAVE SANDBAG AROUND IT, AND ON PURPOSE. BECAUSE I WANT TO MAKE SURE THE COUNCILLOR AND ALL STAFF AND ALL THE EFFORT GOES EVERYBODY ELSE. SO AGAIN, I'M ASKING YOU, KEEP IN MIND WE NEED ALL THE HELP FROM HERE ON MORE THAN WE NEED IT BEFORE. BEFORE WE HAD A LOT OF PEOPLE STEP IN. EVEN WITHOUT BEING ASKED TO HELP. NOW WE NEED YOUR HELP. AND I NEED TO SEE LESS RED TAPE NOW THAN WE DID BEFORE. HOW COULD WE HELP? HOW COULD THE COMMUNITY HELP? IT'S EVERYTHING CONTAMINATED, WHAT CAN WE SAY? WE NEED THAT INFORMATION, AND I KNOW WE FEEL GOOD WHEN WE POST IS ON WEBSITE AND THINK EVERYBODY'S GOING TO READ OUR MESSAGES. IT DOESN'T. THAT'S NOT THE WAY IT WORKS, FOLKS. PEOPLE DON'T HAVE ELECTRICITY, PEOPLE DON'T HAVE INTERNET IN SOME PLACES, SO WE NEED SOMEHOW TO DELIVER THE MESSAGE TO THE COMMUNITY CENTRE, AND THE COMMUNITY CENTRE IS WILLING TO DELIVER IT BY HAND AND TO THE REGION AND KEEP THAT SUPPORT AND THE MOMENTUM GOING, AND SO ON BEHALF OF MY RESIDENT, A HEART FELT THANK YOU TO ETCH, ESPECIALLY TO THE PEOPLE WHO CAME FROM ALL OVER, TO HELP US, TO ALL THE CITY STAFF WITHOUT EXCEPTION, THEY WERE TREMENDOUS FOLKS. I THANK YOU, BECAUSE THEY

WEREN'T THERE TO SAY WELL YOU HAVE TO LEAVE YOUR HOME. THEY TRIED TO ACCOMMODATE, THEY TRIED TO MITIGATE, THEY TRIED TO KEEP THE PEOPLE IN THEIR OWN HOME AND BRING THEM FOOD AND WATER AND LOGISTICS. SO WE DID GREAT JOB, BUT I HOPE WE DON'T THINK WE WON THIS BATTLE. WE DIDN'T. THANK YOU. >> THANK YOU COUNCILLOR. I'LL ASK THE CITY MANAGER FOR AN UPDATE, FOLLOWED BY MR. DIMONTE. >> THANK YOU, MAYOR, IT'S AN APPROPRIATE SEGUE AFTER COUNCILLOR EL-CHANTIRY'S STATEMENT, BECAUSE I WANT TO ASSURE COUNCIL THAT THE EMERGENCY MANAGEMENT TEAM AND ALL CITY DEPARTMENTS ARE RAMPING UP MORE SIGNIFICANTLY THAN EVER IN TERMS OF THIS PHASE OF WHERE WE'RE AT WITH THE RECOVERY. WE UNDERSTAND THIS IS THE MOST IMPORTANT PIECE RIGHT NOW IN TERMS OF GETTING PEOPLE'S LIVES BACK TO NORMAL. SO TODAY WE'RE GIVING AN UPDATE THAT MARKS THE TRANSITION FROM CRISIS RESPONSE TO RECOVERY AND REMEDIATION. AND WE ARE DEEP INTO THE DETAILED PLANNING TO DEAL WITH MANY OF THE ISSUES WE ANTICIPATED COMING FORWARD. WHILE WE'RE RELIEVED TO SEE THE FLOODWATERS RECEDING WE KNOW THIS IS JUST THE BEGINNING OF THE NEXT PHASE OF OUR WORK. >> (Voice of Translator): THIS WILL BE THE BEGINNING OF THE NEXT PHASE OF OUR WORK? (End of Translation) >> THE NEXT PHASE AHEAD, WILL BE TO ASSESS THE DAMAGE TO HOMES AND THE COMMUNITY AND GET A SENSE OF THE MAGNITUDE OF WHAT IT WILL TAKE TO GET BACK TO NORMAL. ANTHONY DIMONTE, OUR GENERAL MANAGER OF EMERGENCY AND PROTECTIVE SERVICES WILL BE GIVING YOU AN OVERVIEW OF OUR RESPONSE BUT I WANT TO EMPHASIZE A FEW THINGS. AS I NOTED IN OUR MEDIA BRIEFING EARLIER THIS WEEK, PICTURES SIMPLY DON'T CAPTURE THE SCOPE AND SCALE AND OVERWHELMING POWER OF THE OTTAWA RIVER TAKING OVER HOMES AND STREETS, SOMETIMES IN REALTIME. THEY ALSO DON'T CAPTURE THE UNBELIEVABLE EFFORTS THE EFFECTED COMMUNITY MEMBERS AND THE MANY VOLUNTEER WHO CAME OUT TO DO WHAT THEY COULD DO. AGAIN, IT'S A TRUE FORCE OF NATURE. I WENT TO OVER SITE, AS DID THE MAYOR, AND THE COUNCILLORS WERE THERE, 24 HOURS A DAY, IT SEEMED, AND I WAS PROUD TO SEE OUR STAFF WERE ALSO THERE, WORKING ALONGSIDE COUNCILLORS AND THESE RESIDENTS AND VOLUNTEERS TO PROVIDE SUPPORT. AND AS I SAID AT THE MEDIA BRIEFING, I CAN'T THANK THE COUNCILLORS ENOUGH FOR THEIR GUIDANCE, THEIR SUPPORT. THEIR DIRECTION TO ENSURE THAT WE GOT THE RIGHT SERVICES TO THE RESIDENTS. THEY KNOW THEIR COMMUNITY SO WELL, AND THAT'S A

TESTAMENT TO EACH AND EVERY COUNCIL MEMBER HERE IN THIS COUNCIL CHAMBERS. AS COUNCIL IS AWARE, THE OFFICE OF EMERGENCY MANAGEMENT HAS BEEN LEADING THE COORDINATION OF ALL CITY SERVICES TO THE FLOOD SINCE EARLY APRIL. OUR SERVICES ON THE GROUND HAVE INCLUDED FIREFIGHTERS, PARAMEDICS, POLICE, PUBLIC HEALTH, ROADS, DRINKING WATER, STORM WATER, TRAFFIC, INFRASTRUCTURE, AND PARKS, JUST TO NAME A FEW, AND OUR 3-1-1 AND 9-1-1 OPERATORS HAVE BEEN THERE 24 HOURS A DAY TO RESPOND TO CALLS. WITH AN EVENT OF THIS MAGNITUDE WE'VE BEEN FORTUNATE COMMUNITY AND GOVERNMENT PARTNERS HAVE STEPPED IN TO HELP. THE PROVINCE OF ONTARIO, RED CROSS, SALVATION ARMY, OTTAWA VALLEY SEARCH AND RESCUE, LOCAL LEGIONS, HYDRO OTTAWA, HYDRO ONE, ENBRIDGE GAS AND MANY OTHERS ARE PROVIDING IMPORTANT CRISIS SERVICES AND I'D PERSONALLY LIKE TO THANK THEM. >> (Voice of Translator): THANK YOU TO ALL OUR PARTNERS WHO HELPED US OUT. (End of Translation) WE'RE DEVELOPING A FULL RECOVERY PLAN AND GETTING BRIEFED MIDDAY TODAY, THE SENIOR LEADERSHIP TIME OF THE SEE AND BE ABLE TO COMMUNITY INDICATE IMMEDIATELY AFTER THAT THE NEXT STEPS. WHAT WE CAN TELL YOU TODAY IS THE AFFECTED RESIDENTS WILL CONTINUE TO SEE CITY STAFF ON THEIR GROUND AND COMMUNITIES. >> (Voice of Translator): WE WILL HAVE A COMPLETE RECOVERY PLAN, AND PEOPLE WILL CONTINUE TO SEE THE CITY STAFF ON SITE. (End of Translation) >> OUR ON SITE SUPPORTS WILL REMAIN IN PLACE FOR AS LONG AS THEY'RE NEEDED. WE ARE NOT REMOVING THEM UNTIL WE GET PAST THIS CRISIS. AS OF TODAY, THE CITY IS SETTING UP INFORMATION AND FACILITATION CENTERS IN FOUR LOCATIONS TO ASSIST IMPACTED RESIDENTS. WE MADE THE DECISION EVEN THOUGH THE COMMAND CENTRES ARE THERE WE'RE GOING TO PUT PERMANENT STAFF THERE IN PLACE TO BE ABLE TO DEAL WITH ON THE GROUND REALITY VERSUS HAVING TO COME ALL THE WAY BACK TO CITY HALL AND BACK OUT INTO THE FIELD. AND I WANT TO READ OUT THE LOCATIONS. IN CUMBERLAND IT WILL BE AT THE COMMUNITY HALL AT THE R.J. KENNEDY ARENA, 1115 DUNNING ROAD. IN BRITANNIA, AT THE RON COLBIS LAKESIDE CENTRE, 102 GREEN VIEW AVENUE. IN WOODLAWN, IT WILL BE AT THE CONSTANCE BAY COMMUNITY CENTRE, 262 LEN PURCELL DRIVE, FITZROY HARBOUR, AT THE FIT ROY HARBOUR COMMUNITY CENTRE, 100 CLIFFORD CAMPBELL STREET. THESE CENTRES WILL BE OPEN TODAY FROM NOON TO 8:00 p.m. AND ON THURSDAY AND FRIDAY FROM 10:00 a.m. TO 8:00 p.m. THE WEEKEND AND THE

FOLLOWING WEEK'S SCHEDULE WILL BE PROVIDED IN THE COMING DAYS. CITY STAFF WILL BE PRESENT AT EACH CENTRE TO TRIAGE. ANSWER CITY RESOURCE QUESTIONS, FOLLOW UP ON RESIDENT INQUIRIES, ASSIGN THE PROPERTY DEPARTMENT AND GET THINGS DONE IN THE COMMUNITY. THE RED CROSS, THE SALVATION ARMY WILL ALSO BE IN ATTENDANCE. NOW I'D LIKE TO TURN IT OVER TO ANTHONY DIMONTE TO PROVIDE AN OVERVIEW OF OUR RESPONSE AND AN UPDATE ON THE CURRENT SITUATION. THANK YOU. MR. MAYOR. >> THANK YOU, STEVE. MAYOR, I WANT TO ECHO OUR CITY MANAGER'S COMMENTS AND SENTIMENTS. I'VE ALSO VISITED THE EFFECTED AREAS AND MY THOUGHTS ARE WITH THOSE THAT HAVE EXPERIENCED LOSS THROUGHOUT THIS FLOOD. >> (Voice of Translator): I'D LIKE TO THANK CITY STAFF, LOCAL COMMUNITIES, AS WELL AS VOLUNTEERS WHO WORKED TIRELESSLY IN ORDER TO BRING SUPPORT TO THOSE WHO ARE AFFECTED. (End of Translation) >> THE CITY WORKED CLOSELY WITH MANY PARTNERS INCLUDING THE OTTAWA RIVER REGULATORY PLANNING BOARD, THE CONSERVATION AUTHORITIES, ENVIRONMENT CANADA, THE MINISTER OF NATURAL RESOURCES AND FORESTRY, AMONGST OTHERS, AND WE SHARED KNOWLEDGE AND RESOURCES AND THAT INFORMATION WAS INVALUABLE AS THIS WAS AN UNPRECEDENTED FLOOD. WHEN WE SAW THE RAIN FORECAST LAST WEEK, STAFF MOVED QUICKLY. SANDBAGS AND SAND HAD BEEN IN CITY REGARDS SINCE EARLY APRIL AS WE NORMALLY HAVE FOR THIS TYPE OF SEASON. OTTAWA FIRE SERVICES WAS DEPLOYED ON SITE AND WENT DOOR-TO-DOOR TO PERFORM WELLNESS CHECK, ASSESS THE AREA FOR POTENTIAL HAZARDS AND OFFER ASSISTANCE TO RESIDENTS WHO WISH TO VOLUNTARILY EVACUATE. PARAMEDICS AND POLICE ALSO ASSESSED WITH THE WELLNESS CHECKS. >> ENHANCED DRAINAGE CONTROL SERVICES, SAND AND SANDBAGS SUPPLIED DIRECTLY TO THE HEAVILY AFFECTED AREAS. THREE EMERGENCY RECEPTION CENTRES AND LODGING CENTERS WERE IDENTIFIED TO PROVIDE RESIDENTS THE 24/7 SHELTER AND WELL WATER TESTING. INCIDENT COMMAND CENTRES WERE SET UP IN THE THREE MOST AFFECTED AREAS FOR SOME RESIDENTS WITHOUT ELECTRICITY. OTTAWA FIRE PROVIDED GENERATORS TO PROVIDE AUXILIARY POWER TO KEEP SUCH PUMPS WORKING. >> (Voice of Translator): THE HEALTH AND SAFETY OF RESIDENTS ARE THE MAIN CONCERN OF THE CITY, AND CONTINUE TO BE THE FOCUS OF OUR WORK. (End of Translation) KEEPING RESIDENTS INFORMED BY RELEASING PUBLIC SERVICE ANNOUNCEMENTS. SENDING OUT EMERGENCY NOTIFICATIONS ON OTTAWA.CA, UPDATING THE CITY'S SPECIAL

MAYOR. WE CAN TAKE THAT AS DIRECT TO LOOK AS HOW WE CAN LOOK AT THE REPORT TO INCLUDE OWNER'S NAMES AS WELL IN THE CASE OF A NUMBERED COMPANY. >> PERFECT, I'D LIKE THAT. THANK YOU SO MUCH AND I JUST WANTED TO REFLECT, WE RARELY GET AN OPPORTUNITY TO SPEAK ON AN ITEM LIKE PROCUREMENT, BUT PROCUREMENT IN A PUBLIC CORPORATION IS SO IMPORTANT ON THE WAY WE DO BUSINESS, ON THE WAY WE INNOVATE AND CERTAINLY ON THE ABILITY TO DELIVER THE WIDE RANGE OF SERVICES THAT AN ORGANIZATION LIKE THE CITY OF OTTAWA DOES, SO THANK YOU FOR THAT. >> ALL RIGHT. THANK YOU. ON THE REPORT, RECEIVED? NEXT ITEM HELD WAS VACANCY REBATE PROGRAMME. ITEM SIX. WAS THAT COUNCILLOR WILKINSON? GO AHEAD. >> THANK YOU MR. MAYOR. I'M SORRY I WASN'T ABLE TO BE AT THE MEETING WHEN YOU DISCUSSED THIS. THE CONCERN I HAVE ABOUT THIS ONE IS ON FUTURE ECONOMIC DEVELOPMENT. QUITE OFTEN WHEN PEOPLE ARE BUILDING BUSINESSES, THEY HAVE PART OF IT PRE-LEASED BEFORE THEY'LL START BUILDING BUT IT TAKES TIME TO LEASE OUT A WHOLE BUILDING. I'M CONCERNED THAT THEY, HAVING NO ABILITY TO DEAL WITH THAT. I'LL CALL IT A TEMPORARY VACANCY. IT'S AN INCREMENTAL VACANCY, MAY DISCOURAGE PEOPLE FROM DOING

NEW BUILDINGS. I'VE TALKED TO SOME OF THE PEOPLE WHO DO THE ECONOMIC DEVELOPMENT IN THE CITY ABOUT THIS. WHAT THEY SAY IS THE CITY'S COSTS NOW ARE SO HIGH THAT THEY ACTUALLY CAN'T AFFORD TO BUILD A NEW BUILDING, EVEN IF THERE IS A PURPOSE-BUILT BUILDING FOR A PARTICULAR INDUSTRY. THOSE ARE THE ONLY ONES I SEE GETTING BUILT IN MY BUILDING NOW AND WE HAVE A VERY LOW VACANCY RATE THERE. THEY CAN'T AFFORD TO BUILD ONE. IF THIS IS GOING TO APPLY TO THEM AS WELL, I DON'T SEE ANYTHING IN THE REPORT THAT TALKS ABOUT THE IMPACT ON FUTURE ECONOMIC DEVELOPMENT. THEY ONLY TALK ABOUT EXISTING BUILDINGS, PRETTY WELL, I REALLY WOULD LIKE MORE DIRECTION OF STAFF, I THINK TO LOOK AT IT, THAT WE SHOULD EVALUATE HOW THIS WILL IMPACT ON NEW DEVELOPMENT, PARTICULARLY FOR WHAT I'LL CALL THE JOB CREATION TYPE OF BUSINESSES. THE ONES THAT ARE NOT SERVICE INDUSTRIES. BUT THE BASIC JOBS THAT YOU GET FROM HIGH-TECH AND PLACES LIKE THAT. BECAUSE IF THEY'RE GOING TO -- IF WE CAN'T GET BUILDINGS FOR THEM TO BE IN, THEY'LL LEAVE THE CITY. WE NEED THAT KIND OF GROWTH IN THE BUSINESS COMMUNITY TO SERVICE US. SO I REALLY WOULD LIKE STAFF TO COMMENT ON THAT. AND THEN I WOULD ASK THEM TO TAKE A LOOK AT WHAT THAT IMPACT IS, AND SEE IF WE NEED TO MAKE SOME SORT OF MODIFICATION ON NEW CONSTRUCTION THAT REQUIRES, THAT WILL NOT BE 100% OCCUPIED BY THE PERSON WHO'S BUILDING THE BUILDING TO START WITH, SO THAT WE CAN MAKE SURE THAT WE DON'T HINDER OUR ECONOMIC DEVELOPMENT BY THIS POLICY. [PLEASE STAND BY] I THINK WE COULD HAVE A POLICY WITHIN THIS, SO WE DON'T GIVE REBATES FOR EXISTING BUILDINGS WHICH IS WHAT THIS IS ADDRESSING. AS LONG AS AT LEAST 50% OF THE **BUILDING IS** I REALLY WANT THIS LOOKED INTO BECAUSE I WORRY OCCUPIED. ABOUT THE FACT WE COULD STAGNATE OUR ECONOMIC DEVELOPMENT. IN PARTICULAR THE PARTS OF THE CORE. THAT APPLIES NOT JUST KANATA. TO ALL PARTS OF THE CITY. DON'T WANT TO SEE THAT HAPPEN. I THINK THE GROWTH OF BUSINESSES IS HEALTHY FOR THE CITY. SO I THINK WE SHOULD DO AN OF THIS. I'M NOT ASKING TO YOU DO THAT RIGHT NOW. BUT THIS IS BASED MOSTLY ON THE EXISTING BUILDINGS AND EXISTING

PROGRAM. THE MASTER PLAN IS WE WANT TO GROW THE EMPLOYMENT AND GROW THE. >>> JOBS, ET CETERA. AND THAT'S GOING TO REQUIRE A LOT OF PEOPLE PUTTING A LOT OF MONEY AT RISK AND BUILDING NEW BUILDINGS. I DON'T WANTS THEM DISCURRENT FROM DOING. THAT COULD YOU LOOK INTO THIS AND REPORT BACK ON WHAT THAT INPUT WOULD BE AND WHETHER OR NOT WE SHOULD BE DOING SOMETHING ABOUT. IT BECAUSE I DON'T KNOW THE ANSWER RIGHT NOW.

>> COUNCILLOR JUST FOR 2 CLARIFICATION. IF AN OWN BUILDS A PROPERTY LINE AND THEY WANT TO BUILD IT IN ANTICIPATION THEY WILL COMMAND INTO, IT THEY ARE NOT ENTITLED TO GET A VACANCY REBATE. I'M NOT TALKING ONE COMPANY. l'M TALKING A MULTIPLE USE 09:04:24:00 BUILDING. >> YES THE MULTIPLE USE BUT THE ASSESSMENT AT WACO THAT ASSESSMENT WAS THE VACANCY FACTOR. AND IF THAT FACTOR WAS TOO LOW, THEY COULD BUILD THAT AND GET THEIR PROPERTY TAXES REDUCED THROUGH THAT PROCESS. SO THEY STILL HAVE THAT MECHANISM THERE. IT'S JUST --THEY'RE NOT GOING TO BE COMING TO US AND TO IMPACT FOR A VACANCY REBATE. ONE OF THE STAKEHOLDERS SENT US A LETTER --OR SENT ME A LETTER YESTERDAY -- AND WE KNOW HOW THE COMMERCIAL --THERE'S A FAIRNESS ASPECT, THE WAY THEY BASED IT AT LEAST. AND ONE OF THEIR FIRST POINTS IN THE LETTER IS THAT THEY HIGHLIGHT THAT THE VRP WAS CREATED AS A FAIR MEANS TO ADDRESS VACANCIES WHEN THE BUSINESS OCCUPIES TAX WAS ABOLISHED IN 1999 IN FAVOUR OF INCREASING PROPERTY TAXES FOR COMMERCIAL BUILDINGS.

WE HAVE LOOKED AT IT FROM ALL ASPECTS AND IN TERMS OF THE BENEFITS THAT THE OWNERS RECEIVED -- AS DISCUSSED, WHEN YOU LOOK AT THE ASSESSMENTS OF THESE PROPERTIES VACANCY FACTOR BUILT INTO THIS ALREADY. SO THEY ARE BENEFITING IN ONE WHAT WE HEARD WHEN WE DID OUR ENGAGEMENT WAY. SESSIONS WITH THE BUSINESS OWNERS WAS THEY FELT THAT THEY WERE ENTITLED TO A 09:09:17:09 SECOND LEVEL OF BENEFITS. >> SO YOU DON'T SEE IT AS ANOTHER BURDEN ON THEM BY DOING THIS?
