AS WE STAND IN THIS MOMENT OF REFLECTION I WOULD ASK YOU TO THINK ABOUT THE THREE FEMALE VICTIMS WHO WERE KILLED WEST OF OTTAWA YESTERDAY.

ANASTASIA KUZYK, NATHALIE WARMERDAM AND CAROL CULLETON WERE SADLY TAKEN AWAY FROM THEIR FAMILIES.

IT WAS SUDDEN, TRAGIC AND SENSELESS.

AS WE WORK TO END VIOLENCE AGAINST WOMEN AND BUILD A MORE CARING SOCIETY, LET US HOLD THEM IN OUR HEARTS. LET US REMEMBER THEM.

IT IS WITH SHOCK WE RECENTLY LEARNED OF THE SUDDEN PASSING OF CAROL PARKER THE BELOVED WIFE, MOTHER, GRANDMOTHER, SISTER, AND TEACHER AND FRIEND TO MANY. MANY OF US KNEW HER AS A SCHOOL BOARD TRUSTEE WITH THE FORMER CARLETON BOARD OF EDUCATION FROM 1995 TO 1987 AND FROM OSGOODE TOWNSHIP COUNCIL 1997-2000.

CAROL WAS KNOWN AS A STRONG SUPPORTER OF THE ARTS CURRICULUM AND HER TIME WITH THE SCHOOL BOARD.

SHE BROUGHT THAT LIFE-LONG ENTHUSIASM FOR MUSIC AND THEATER TO HER COMMUNICATE AS ONE OF THE FOUNDERS OF THE GREELEY PLAYERS.

IN 1989 CAROL AND THE CHOIR MEMBERS OF THE ALL SAINTS CHURCH DECIDED TO MOUNT A MUSICAL THEATER PRODUCTION IN SUPPORT OF THE CHURCH'S 100TH ANNIVERSARY. THE GROUP DECIDED TO ESTABLISH A

PERMANENT MUSICAL THEATER TROOP AND THE GREELEY PLAYERS WERE BORN. EARLIER FOR THEIR 25TH ANNIVERSARY THE THEATER TROOP PLAYED TO FOUR SOLD-OUT SHOWS OF PETER PAN.

CAROL WAS PASSIONATE ABOUT EDUCATION OF ALL KINDS, INCLUDING SETTING UP A LIBRARY READING TIME FOR PRESCHOOLERS. TEACHING MUSIC THROUGH PIANO LESSONS AND MUSICAL THEATER.

WE SEND OUR THOUGHT AND PRAYERS TO CAROL'S HUSBAND AND FAMILY.

REMAIN STANDING FOR A MOMENT OF SILENCE IN CAROL'S HONOUR.

SHE ATTENDS SIXTH GRADE AND THE OLDEST OF THREE KIDS AND HAS A SISTER SADIE AND A BROTHER CRUZ AND CAN'T FORGET THE FAMILY DOG SUMMER. SHE IS AN APRIL FOOLS BABY BORN APRIL 1.

AND HAS SUNG AT THE CANADIAN LITTLE LEAGUE CHAMPIONSHIPS.

AND THE BOARD MEMBER FOR THE FORMER MAYOR MARY PIT IS HERE TODAY TO SUPPORT HER. SHE PLAYS HOST LEAGUE HOCKEY WITH THE ETIENNE WILDCATS AND HAS PLAYED IN MUSICALS SUCH AS ANNIE AND MARY POPPINS. WHEN ASKED RECENTLY BY HER BROTHER WHAT SHE WANTS TO BE WHEN SHE GROWS UP.

SHE THOUGHTFULLY RESPONDED "SUCCESSFUL ."

HAVING BEEN A RESIDENT SINCE 2011, THEY GREW ALONGSIDE THE YOUNG COMMUNITY.

THE ASSOCIATION PLANS TO HOST EVENTS SUCH AS BARBECUE AND PARK CLEANUP DAY AND FUN RUNS IN THE PAST SEVERAL YEARS. OMAR FOUND TIME TO COACH VARIOUS HOCKEY TEAMS FOR THE MINOR HOCKEY ASSOCIATION.

HIS MANY ROLES HE GOES BY MANY NAMES AND TITLES. OMAR HAS BECOME RECOGNIZABLE

ACROSS THE COMMUNITY. FOR YOUR CONTINUED LEADERSHIP AND DEDICATION TO YOUR COMMUNITY IT IS MY PLEASURE, ALONG WITH COUNCILLOR QADRI TO PRESENT YOU THE

MAYOR'S CITY BUILD AWARD FOR ALL YOU HAVE DONE TO MAKE LIFE EVEN GREATER.

FOR A SPECIAL PRESENTATION. WHETHER AS A VOLUNTEER, TEACHER OR REPRESENTATIVE COUNCILLOR OF OUR COMMUNITY, COUNCILLOR WILKINSON ALWAYS DEMONSTRATED AN EXCEPTIONAL COMMITMENT TO COMMUNITY SERVICE.

MARIANNE GRADUATED FROM TRINITY COLLEGE AND BEGAN A CAREER IN TEACHING. HER HUSBAND BOB IS HERE WITH US TODAY.

KANATA WAS STILL PART OF MARCH TOWNSHIP AT THE TIME. WITH THE SUPPORT OF HER HUSBAND AND FRIENDS, MARIANNE BECAME THE FIRST WOMAN TO RUN FOR ELECTED OFFICE IN THAT MUNICIPALITY.

COUNCILLOR WILKINSON AS MANY OF US KNOW HAS HELD A NUMBER OF OFFICES. MARIANNE SERVED AS COUNCILLOR KANATA NORTH IN OTTAWA IN 2006.

MARIANNE HAS CONTRIBUTED HOURS OF VOLUNTEER EXPERIENCE, IN HER COMMUNITY, AS WELL. THE FOUNDER OF THE CANADIAN RESOURCE CENTRE IN WEST CARLETON AND THE PRESIDENT OF THE COMMUNITY ASSOCIATION. THE FOUNDER AND PRESIDENT OF THE CANADIAN FEDERATION OF WOMEN KANATA. I REMEMBER HER COMING DOWN TO QUEEN'S PARK EVERY YEAR AS THE FOUNDER OF THE CANADA DAY COMMITTEE.

THESE ARE JUST A FEW OF THE ROLES SHE PLAYED IN KANATA AND THE CITY AS A WHOLE. AND HER WORK WHETHER ON COUNCIL, COMMITTEE MEETINGS, COUNCILLOR WILKINSON ALWAYS DEMONSTRATES THE UTMOST DEDICATION AND PASSION FOR PUBLIC SERVICE.

WITH HER FOCUS AND DEPTH OF EXPERIENCE THIS COUNCIL AND CITY AT LARGE ARE ABLE TO BENEFIT FROM HER MANY CONTRIBUTIONS.

SHE STILL HAS MANY GOALS FOR KANATA AND OUR CITY.

LET'S HEAR IT FOR BOB.

WELL IT IS SAID THAT BEHIND EVERY SUCCESSFUL WOMAN IS A SURPRISED MAN.

I USED TO SAY I HAVE BEEN THINKING. HE ALWAYS GOT EXTREMELY WORRIED.

I HAVE MY YOUNGEST SON ANDREW HERE. HE WAS 4 MONTHS OLD MY FIRST ELECTION.

LOOK AT THE SIZE OF HIM NOW. THAT WAS 46 YEARS AGO.

HIS WIFE BRENDA IS HERE WITH HIM.

MY HAPPENS TO ALWAYS VOLUNTEER THINGS. SHE'S ON TRAINING FOR HEALTH AND

SAFETY FOR HER SCHOOL, SO SHE COULDN'T BE HERE TODAY

AND HER OLDEST DAUGHTER IS NOW AT WATERLOO DOING NANO ENGINEERING, WHICH I DON'T EVEN

UNDERSTAND.

THE YOUNGER SISTER, JUST WON THE CAPPY AWARD FOR LEADING ACTRESS IN THE PLAY, SO THESE ARE VERY INVOLVED KIDS.

MY SON-IN-LAW WAS AT NORTEL AND NOW TEACHING PHYSICS. SO THEY WEREN'T ABLE TO BE HERE

TODAY AND MY OLDEST SON AND WIFE ARE IN BRAMPTON WITH 7-YEAR-OLD TWINS AND IT IS A LITTLE FAR TO COME.

THEY ARE A VERY SUPPORTIVE FAMILY.

THEY HAD TO PUT UP WITH AN AWFUL LOT, BECAUSE WHEN YOU'RE SMALL

CHILDREN AND YOUR MOTHER IS MAYOR. THEY GREW UP ANDREW ONCE TOLD ME

THAT SOMEONE ASKED WHAT IS IT LIKE TO HAVE YOUR MOM AS A

POLITICIAN. HE SAID I DON'T KNOW I NEVER KNEW ANYTHING DIFFERENT.

I FINISHED MY FIRST 25 YEARS.

AND I WANT TO TELL YOU A COUPLE OF THINGS. FIRST, THANK YOU TO MY HUSBAND, WHO DID SO

MUCH IN THE FAMILY. AND TODAY HE STILL COOKS DINNER FOR ME, BECAUSE HE'S RETIRED HE

SAYS HE CAN DO THAT, AND HAS ALWAYS BEEN BEHIND ME. NEVER WANTED TO BE IN THE FRONT.

HE DOESN'T LIKE TO DO DOOR KNOCKING, SO HE LOOKS AFTER SIGNS, WHICH ARE HELPFUL.

THERE ARE THINGS IN THE FAMILY YOU HAVE TO WORK AS A FAMILY. I SAY TO MY COLLEAGUES, YOU NEED THE SUPPORT OF YOUR FAMILIES. I THINK ALL OF YOU DO, BECAUSE WITHOUT THAT YOU CAN'T DO THE JOB.

MY BIGGEST THING AND AN ADVANTAGE I HAVE OVERALL OF YOU. I STARTED WITH THE SMALL

MUNICIPALITY. MY FIRST ELECTION YOU WOULD LIKE THIS, JIM. I HAD LANGERITIS.

I COULDN'T SAY A WORD.

[LAUGHTER]

BUT WE HAD. WE HAD SHARED SEAT ON REGIONAL COUNCIL.

WE SHARED WITH ANOTHER TOWNSHIP.

WE HAVE VOTES TO ALTERNATE YEAR AFTER YEAR.

SO I HAD TO BE THERE AND VOTE FOR THAT.

AND IT GOES BACK A LONG TIME WHEN THE REGION WAS IN THE FIRST YEARS OF THE REGION. BUT BECAUSE IT WAS SMALL, WE HAD NO STAFF.

WE HAD NO STAFF IN RECREATION AND WE HAD FOUR IN THE OFFICE AND WE HAD A CLERK AND HIS WIFE LOOK AFTER THE BUSINESS AND A COUPLE OF PEOPLE COLLECTED TAXES AND THEN A SMALL ROAD CREW.

THEY GAVE US ALL LIFTS OF WHAT WE AS COUNCIL WOULD DO.

I WAS GIVEN PLANNING I PUT TOGETHER A VOLUNTEER GROUP IN OUR COMMUNITY. WE WON TWO NATIONAL DESIGN AWARDS.

WHAT YOU DO IN YOUR COMMUNITIES IS MAKE SURE MAKES THE PEOPLE IN THE COMMUNITY CARE ABOUT IT AS MUCH AS YOU DO.

THAT'S WHEN YOU CREATE GREAT COMMUNITIES.

WE DID A LOT OF INTERESTING THINGS THAT WERE FIRST IN THOSE YEARS.

BUT WE LEARNED EXACTLY I LEARNED HOW TO BUILD A RURAL ROAD AND ALL SORTS OF THINGS, BECAUSE WE HAD TO LEARN THOSE IN A SMALL MUNICIPALITY.

I'VE BEEN A COUNCILLOR AND A MAYOR OF A SMALL CITY AND A COUNCILLOR IN A BIG CITY, I'VE NEVER MOVED.

IT JUST KEEPS CHANGING.

BUT THE KEY THING ALL ALONG IS YOU HAVE TO LIKE PEOPLE.

I'M A VERY GRASSROOTS PERSON.

TO ME THE COMMUNITY IS THE MOST IMPORTANT THING.

THE THINGS I GET MOST OUT OF IS NOT THE BIG ARENAS AND THE RECREATION COMPLEXES WE DO.

IT IS WHEN SOMEONE COMES TO ME AND SAID YOU HELPED ME-- ONE

PERSON SAID, "30 YEARS AGO I WAS IN REAL PROBLEMS AND YOU CAME TO MY HOUSE AND HELPED ME.

I CAN'T REMEMBER DOING IT BUT FOR THAT PERSON IT MADE A CHANGE IN HER LIFE.

YOU MAKE A CHANGE LIKE UNITED WAY AND THEY'RE HERE TODAY.

THAT MAKES A DIFFERENCE.

THE MORE YOU CAN DO FOR INDIVIDUALS, I THINK BETTER THE JOB IS.

SO THANK YOU FOR GIVING ME THIS. MY COLLEAGUES, WHEN YOU HAVE 25 YEARS OF SERVICE YOU GET TWO PLAQUES AND A PIN.

BUT THE JOB KEEPS GOING.

TOMORROW HERE AT CITY HALL LOCAL POLITICIANS MEDIA PERSONALITIES AND VOLUNTEERS WILL KICK OFF THE UNITED WAY OTTAWA COMMUNITY CAMPAIGN.

THE ANNUAL TRADITION WHERE THE PEOPLE OF THIS GREAT CITY RAISE FUNDS FOR PEOPLE IN, WHO NEED IT THE MOST.

SOME OF THE MOST GENEROUS DONORS ARE RIGHT HERE AT THE CITY OF OTTAWA.

SINCE IT WAS DESIGNATED THE CORPORATE CHARITY IN 2001, CITY EMPLOYEES HAVE RAISED MORE THAN \$7 MILLION FOR THE UNITED WAY AND HELP CHANGE THE LIVES OF 17,500 PEOPLE TO COINCIDE WITH THE LAUNCH OF THE GREATER COMMUNITY CAMPAIGN.

>> COUNCILLOR MOFFATT: THE BRIEF REPORT FOR 2014 AND THEN A QUICK MOTION

THAT CAME FROM OUR LAST MEETING OF THE BOARD, SO AS SOME OF YOU MAY KNOW OR MAY NOT

KNOW THE CITY ACQUIRED FIVE OR SIX PROPERTIES IN 2007 IN DICKINSON SQUARE.

FOUR OF THE PROPERTY WERE FROM THE CONSERVATION AUTHORITY AND THEN THEY DID ACQUIRE TWO, ADDITIONAL PROPERTIES, WHICH HAD SIGNIFICANT IMPACT ON DICKINSON SQUARE, SO THOSE WERE REQUIRED AS WELL.

WE STILL HAVE THREE PROPERTIES COMING INTO 2015. ONE HAS SINCE BEEN SOLD.

IT WAS LISTED IN 2014. SOLD IN 2014, BUT THAT FELL THROUGH.

THERE IS ANOTHER PROPERTY THAT WAS ACQUIRED BACK IN 2007, 1116 BRIDGE STREET.

IT IS KNOWN AS THE HALLWAY PROPERTY. BACK IN 2014, DECEMBER 2014 IT WAS VOTED THE COUNCIL VOTED TO RETAIN THAT PROPERTY. IT HAS NO ACTUALLY DEVELOPMENT POTENTIAL DUE TO THE SETBACK FROM THE RIVER.

TWO, PROVIDE MR. KIRKPATRICK WITH NOTICE FROM THE CITY AS SET OUT IN THE EMPLOYMENT CONTRACT OF THE INTENTION NOT TO RENEW THAT CONTRACT FOR ANOTHER YEAR, BASED UPON THE LETTER RECEIVED FROM MR. KIRKPATRICK DATED SEPTEMBER 22, 2015, COPY ATTACHED.

THREE, APPROVE THAT THE MAYOR(CHAIR) AND ALL MEMBERS OF FEDCO BE CONSTITUTED AS THE HIRING PANEL TO INTERVIEW CANDIDATES FOR THE POSITION OF CITY MANAGER AND THAT THE MAYOR ALSO SEEK INPUT FROM ALL MEMBERS OF COUNCIL ON THEIR EXPECTATIONS OF THE DESIRED QUALIFICATION FOR SAME.

FOUR, APPROVE THE IMMEDIATE ENGAGEMENT OF EXTERNAL SEARCH FIRM FROM THE STANDING OFFER LIST TO ASSIST THE HIRING PANEL IN UNDERTAKING THE EXECUTIVE SEARCH FOR A NEW CITY MANAGER TO THE UPSET LIMIT OF \$50,000.

FIVE, DIRECT THE CITY CLERK AND SOLICITOR OFFICE TO PROVIDE THE ADMINISTRATIVE SUPPORT TO THE HIRING PANEL.

I WANT TO THANK MR. KIRKPATRICK. AS YOU KNOW WE HAVE HAD DISCUSSIONS OVER THE LAST, SEVERAL WEEKS. I INDICATED VERY EARLY ON THAT MY DESIRE, AND I KNOW I SPEAK FOR ALL OF COUNCIL WAS THAT WE VERY MUCH WANTED TO HAVE MR. KIRKPATRICK STAY ON.

HE'S DONE A REMARKABLE JOB FOR US, BUT HE HAS TAKEN THE DECISION AND I FULLY SUPPORT AND

RESPECT THAT FIRST AND FOREMOST HIS HEALTH AND HIS OWN WELL-BEING MUST COME BEFORE ANYTHING ELSE.

AND THAT IS WHY WE'RE-- I'M BEFORE YOU TODAY WITH THIS MOTION.

AND AGAIN, WE WILL HAVE MANY OPPORTUNITIES TO CELEBRATE THE REMARKABLE CAREER OF MR. KIRKPATRICK.

AND I THANK HIM FOR THE SENSITIVITY IN WHICH HE HAS DEALT WITH THIS ISSUE OVER THE LAST, SEVERAL MONTHS AND MY PERSONAL RESPECT CONTINUES TO GROW FOR KENT EACH, AND EVERY DAY.

SO COUNCILLOR ELI EL-CHANTIRY, PLEASE.

>> ELI EL-CHANTIRY: .THANK YOU MR. MAYOR AND ITEM FOUR I HAVE A CONCERN OF THE LIMIT OF \$50,000, BECAUSE SINCE I'VE BEEN ON COUNCIL WE HAVE DONE MORE THAN ONCE-- FOR THE EXTERNAL SEARCH. ESPECIALLY TALKING ABOUT NATIONAL EXECUTIVE SEARCH.

THE 50,000 WILL BE A LIMITED NUMBER.

I WOULD LIKE TO SEE WITHOUT THE LIMIT. WE KNOW YOU'RE NOT GOING TO GO.

BUT I DON'T WANT TO FIRE OFF WITH CERTAIN NUMBERS. ESPECIALLY TALKING ABOUT A NATIONAL SEARCH AND PUT AD IN THE NATIONAL NEWSPAPERS AND OTHERS, AS I HAVE SEEN IN THE PAST YOU ALMOST EXCEED \$100,000 IN THAT AREA.

JUST CAUTION WHETHER WE SHOULD CHANGE IT NOW, OR YOU WILL HAVE TO BRING TO THE COMMITTEE, AS COMMITTEE MEMBER YOU BRING IT TO US FOR AN INCREASE.

IT IS UP TO YOU WHETHER YOU DO IT NOW OR LATER ON. NOTION \$50,000 ON THE NATIONAL SEARCH WILL DO IT JUSTICE.

>> Mayor Watson: COUNCILLOR I APPRECIATE YOUR PERSPECTIVE.

THE CITY CLERK IS THE ONE THAT GAVE US THE UPPER AMOUNT. OBVIOUSLY IF THERE'S A REQUIREMENT TO GO ABOVE AND BEYOND THAT WILL GOOD TO CITY COUNCIL.

I DON'T WANT TO SEND A SIGNAL TO THE SEARCH FIRMS IT IS A BLANK CHECK.

I THINK WE WILL HAVE TO PUT IN SOME PARAMETERS WE WILL SEARCH THROUGH THE STANDING LIST WHO IS AVAILABLE AND WISHES TO BID ON THIS.

MY HOPE IS BY PUTTING IN A LIMIT WE SEND THE SIGNAL THAT WE'RE NOT GOING TO LEAVE IT AS AN UNKNOWN NUMBER AND THEY COME IN WITH A BID THAT'S \$100,000.

I'LL ASK THE CITY CLERK IF HE'S COMFORTABLE WITH THE \$50,000 LIMIT?

AND SECONDLY TO FOLLOW UP ON COUNCIL EL-CHANTIRY'S POINT IF IT DOES IN FACT REQUIRE ADDITIONAL DOLLARS WE WOULD HAVE THE ABILITY TO BRING IT BACK TO UP THAT NUMBER AT THE TIME?

MR. O'CONNOR >> YES, MR. MAYOR WE WERE ABLE TO DO THE AUDITOR GENERAL EXECUTIVE SEARCH 18 MONTHS AGO FOR THE \$50,000 LIMIT THAT'S WHY WE WERE TARGETING IT AGAIN IN THAT RANGE, BECAUSE IT WAS A NATIONAL SEARCH AND YES, WE WOULD COME BACK TO COUNCIL, IF THE EXPENSES EXCEEDED THAT.

>> Mayor Watson: THANK YOU FOR THE POINT COUNCILLOR.

COUNCILLOR TIERNEY.

COUNCILLOR TIERNEY: . THANK YOU KENT FOR YOUR SERVICE. WE APPRECIATE THAT.

WHEN I GO THROUGH IT I SUPPORT EVERYTHING, EXCEPT FOR ITEM 3.

AS COUNCILORS WE ONLY HAVE ONE ROLE. WE CAN HIRE AND FIRE, NOT KENT.

I'M NOT SAYING THAT. TO HAVE THE FEDCO GROUP BE THE PRIMARY PANEL.

I WOULD LIKE TO KNOW HOW THAT WOULD WORK.

HOW DO WE ENVISION FEDCO BIDDING.

DO MULTIPLE PEOPLE GO TO FEDCO AND THEN IT COMES BACK TO COUNCIL?

OR IS IT ONE PERSON THAT COMES BACK TO FEDCO THAT WOULD MAKE THAT DECISION ON?

>> Mayor Watson: WE'RE FOLLOWING A SIMILIAR ROLE THAT HIRED MR. KIRKPATRICK SEVERAL COUNCILS AGO.

WE WOULD HAVE FEDCO CONDUCT THE INTERVIEWS.

THEN BRING FORWARD A RECOMMENDED CHOICE TO FULL COUNCIL, WHERE FULL COUNCIL WOULD HAVE THE OPPORTUNITY TO INTERVIEW THE INDIVIDUAL IN CAMERA.

AND ULTIMATELY FULL COUNCIL HAS TO VOTE ON IT.

>> COUNCILLOR TIERNEY: I'M CURIOUS. WHY WE DON'T WANT TO JUST BRING IT DIRECTLY TO COUNCIL, INSTEAD OF GOING THROUGH FEDCO FIRST?

>> Mayor Watson: I THINK HAVING A SELECTION COMMITTEE OF 23 CAN BE UNWIELDING.

JUST GETTING SCHEDULES ORGANIZED FOR 23, MOST STAFF AND I FELT IT MADE SENSE TO HAVE A SMALLER GROUP CONDUCT THE INTERVIEWS AND BRING FORWARD A RECOMMENDATION BEFORE COUNCIL. AND FULL COUNCIL WOULD HAVE EVERY OPPORTUNITY TO REJECT OR ACCEPT THE INDIVIDUAL AND QUESTION HIM OR HER INCAMERA.

EVERYONE IN COUNCIL WILL HAVE ULTIMATELY THE SAY, BECAUSE AS YOU KNOW IT IS THE ONE PERSON THAT WE HIRE.

>> COUNCILLOR TIERNEY: THANK YOU I WOULD LIKE IT BROKEN OUT. I DON'T SUPPORT ITEM 3. I FEEL PRETTY STRONGLY ALL OF COUNCIL SHOULD BE INVOLVED IN WHAT IS THE CITY'S MOST POWERFUL POSITION.

THANK YOU.

>> Mayor Watson: OKAY.

THANK YOU. COUNCILLOR QAQISH.

>>COUNCILLOR QAQISH: THANK YOU, MAYOR I WILL OBVIOUSLY THANK MR. KIRKPATRICK FOR ALL OF HIS WORK OVER THE YEARS AT CITY HALL.

I WILL TAKE A DIFFERENT PERSPECTIVE TO WHAT COUNCILLOR EL-CHANTIRY SAID.

PARTICULARLY WITH THE ECONOMIC TIMES I APPRECIATE IT IS A SIGNIFICANT POSITION FOR THE MUNICIPALITY AND WE GENERALLY GO TO AN OUTSIDE FIRM TO HELP US WITH THE SEARCH.

WHAT I SUGGEST BECAUSE OF THE ECONOMIC TIMES WE'RE FACING NOT MORE CONSULTING CONTRACTS BUT GET OUR H.R. DEPARTMENT TO COLLABORATE USING OUR BUDGETS THAT ARE EXISTENT TO PROMOTE THIS POSITION AND THEN THAT HIRING PANEL CAN WORK, BASED ON THAT SHORT LIST FROM OUR INTERNAL HR DEPARTMENT.

>> Mayor Watson: YOU'RE EXPRESSING AN OPINION, MR. CLERK, WHO WILL BE OUR ADMINISTRATIVE SUPPORT, CAN OFFER A COMMENT.

>> RICK O'CONNOR: MR. MAYOR, YES. I WOULD HAVE TO GO BACK AND LOOK AT THE JOB DESCRIPTION FROM COUNCIL PREVIOUS POLICY. FOR SENIOR STAFF, IT IS A NATIONAL SEARCH, AND THESE NATIONAL SEARCH AGENTS THAT WE HAVE ON OUR STANDING OFFER LIST ARE PREPARED AT A MOMENT'S NOTICE TO DO THIS SORT OF THING.

I DO NOT BELIEVE THAT WE ARE EQUIPPED INTERNALLY TO DO THAT TYPE OF THING AND WE COME UP WITH I THINK THE RANGE OF CANDIDATES THAT MIGHT NOT BE AVAILABLE THROUGH THE NATIONAL SEARCH AGENCY.

>> COUNCILLOR WILKINSON: INVOLVED WITH THE NATIONAL SEARCH FOR COMMUNITY HOUSING A YEAR AGO.

THEN IT WENT INTERNATIONALLY AND WE WERE WITHIN THE BUDGET SET THERE AND THE ADVERTISING ITSELF DIDN'T REALLY BRING MUCH IN THERE.

IT IS CONTACTS AND THINGS THAT THEY GET, WHICH IS IMPORTANT. BUT IT IS REALLY IMPORTANT WHO YOU GET TO DO THE PROGRAM. WE LOOK AT IT CAREFULLY. I'LL GIVE YOU THE NAME OF THE PERSON WE USED. IT WORKED OUT EXTREMELY WELL.

WE WERE VERY SATISFIED WITH THE RESULTS.

IT WAS A BIT OF A SURPRISING RESULT. BUT BECAUSE OF THE WORK THAT SHE DID, I THINK THAT'S WHAT WE NEED IN THIS CASE, AS WELL.

>> MAYRO WATSON: ANYTHING ELSE ON THE MOTION?

COUNCILLOR DEANS?

>> COUNCILLOR DEANS: THERE WERE FIVE MEMBERS OF COUNCIL, INCLUDING THE MAYOR ON

I KNOW WHEN WE CHOSE THE NEW FILM COMMISSIONER THAT'S THE PROCESS FOLLOWED THEY HAD A SMALL FOUR OR FIVE MEMBER COMMITTEE AND THEN THEY BROUGHT FORWARD THREE RECOMMENDATIONS AND THEY RANKED THEM FOR US.

WHEN THEY BROUGHT THEM FORWARD AND WE ENDED UP AGREEING WITH THE RANK.
