The Council of the City of Ottawa met at Andrew S. Haydon Hall, 110 Laurier Avenue West, Ottawa, on Wednesday, 28 November 2018 beginning at 10:00 a.m.

The Mayor, Jim Watson, presided and led Council in a moment of reflection.

ANNOUNCEMENTS/CEREMONIAL ACTIVITIES

RECOGNITION - MAYOR'S CITY BUILDER AWARD

Mayor Watson presented the Mayor's City Builder Award today to two organizations:

Proud To Be Me was recognized for empowering youth and for its anti-bullying efforts. Established in 2011 by Cindy Cutts and Jody McCombe, the organization raises funds for community supports, resources and programs that

help empower and educate youth in a way that promotes inclusion and antibullying. The organization recognizes the importance of providing an environment of empathy, acceptance, responsibility and opportunity. Proud To Be Me has provided grants to help build child- and youth-friendly communities, support healthy and active children and youth, create mental health and wellness programs, promote acceptance and prevent bullying.

The Billings Bridge Pacesetters Walking Club was recognized for its contributions to osteoarthritis research and for 25 years of community support. The Billings Bridge Pacesetters Walking Club is a social walking and knitting club that produces blankets, scarves, mittens and hats for seniors and children. The club started 25 years ago at the Billings Bridge Shopping Centre as a way to promote social interaction and reduce isolation among seniors. The group keeps active through walking and knitting, and donates much of its knitting to those in need. Wool blankets are made for the Children's Hospital of Eastern Ontario and local retirement residences. Members also knit hats, scarves and mittens for clients of the Snowsuit Fund. The club has supported the University of Ottawa on studies of the health benefits of walking and knitting for older individuals with osteoarthritis.

WHEREAS at their meeting of November 22 and 23, 2018, the Board of Directors of the National Capital Commission (NCC) approved an amendment to the Greenbelt Master Plan 2013 to permit a soundstage campus and creative hub at 1740 Woodroffe Avenue; and

WHEREAS the zoning amendment is in the critical path in the project plan; and

WHEREAS it is appropriate that direction be provided as soon as possible to Planning, Infrastructure and Economic Development staff to begin the City-led Zoning By-law amendment;

THEREFORE Be It Resolved that the Rules of Procedure be suspended to permit the introduction of the following motion:

WHEREAS the Ottawa Film Office has secured partnerships to invest 40 million dollars in Ottawa to develop a new soundstage campus and creative hub for the film, television and animation industry; and

WHEREAS Ottawa's film, television and animation industry provides hundreds of skilled jobs to Ottawa residents and contributes over 100 million dollars to the local economy annually; and

WHEREAS supporting creative and cultural industries forms part of the City's economic development strategy; and

WHEREAS the soundstage campus and creative hub will create approximately 500 jobs during construction and will generate approximately 40 million dollars in new economic activity within the first few years of operation, creating more than 500 new full-time jobs in Ottawa; and

WHEREAS the National Capital Commission (NCC) has undertaken a process of public engagement on locating a film studio and related uses on federal lands within the Greenbelt Research Farm, located on the southwest corner of West Hunt Club and Woodroffe Avenue; and

WHEREAS at their meeting of November 22 and 23, 2018, the Board of Directors of the NCC approved an amendment to the Greenbelt Master Plan 2013 to permit a soundstage campus and creative hub at 1740 Woodroffe Avenue; and

WHEREAS as part of the same proposal, the NCC Board approved an amendment to the Greenbelt Master Plan 2013 to designate the former Capital Golf Centre at 3798 Bank Street as a Natural Link Area, with the intention of renaturalizing this greenbelt parcel; and

WHEREAS there is a need for the City to bring its Zoning By-law into alignment with the federal land use decision;

BE IT RESOLVED that Council approve:

- 1. That the Planning, Infrastructure and Economic Development Department be directed to bring forward to Planning Committee, in accordance with the notice requirements of the *Planning Act*, a City-initiated Zoning By-law amendment to permit a soundstage campus and creative hub with related office and production uses at 1740 Woodroffe Avenue, subject to such performance standards as may be appropriate, to align with the Exception created within the Greenbelt Master Plan 2013; and
- 2. That the Planning, Infrastructure and Economic Development Department be directed to bring forward to Planning Committee, in accordance with the

notice requirements of the *Planning Act*, a City-initiated Zoning By-law amendment to rezone the lands at 3798 Bank Street to align with the Natural Link designation of the Greenbelt Master Plan 2013.

WHEREAS Marlene saw the need for more integrated social services in the area including community health services, organizing the first meeting of local service providers to start the process towards establishing a multi-service centre; and

WHEREAS As City Alderman Marlene worked with residents to plan the Michele Heights Recreation Centre in Michèle Park, a centre that still meets the needs of a community that has grown in diversity; and

WHEREAS, in support of the community surrounding the park, in addition to the community centre, Marlene and others launched restaurant and clothing store businesses that today we would define as 'social enterprises' for the good of the community and the employees; and

WHEREAS Marlene's ongoing efforts to support the Michele Heights and wider community today in engaging in civic participation, growing the representation of women in community leadership and strengthening community bonds are exemplary; and

WHEREAS members of the community and organizations of community support have come forward to request recognition of Marlene Catterall; and

WHEREAS the City's Commemorative Naming Policy, approved by Council on July 24, 2002, outlines the criteria and process for commemoratively naming municipal streets, parks and facilities (or parts thereof), and provides for Council to assign a commemorative name by resolution, in keeping with its powers set out in the *Municipal Act*, 2001; and

WHEREAS the name Marlene Catterall has been vetted through Emergency Services and does not pose any concerns with respect to name duplication;
