#### **RECOMMENDATION**

That the Ottawa Police Services Board receive this report for information.

## <u>BACKGROUND</u>

In 2001, the Provincial Government enacted Ontario Regulation 3/99 under the *Police Services Act of Ontario (PSA)*. The regulation, named *Adequacy and Effectiveness of Police Services*, is intended to ensure police services boards and police services implement the mechanisms required to provide effective delivery of policing services to the community.

#### **DISCUSSION**

The Ottawa Police Service (OPS) has developed service policies and procedures that establish a system of controls required to ensure the effective delivery of policing services. The compliance function is administered by the Planning, Performance, and Analytics Section (PPA). Their role is to oversee compliance and quality assurance activities such as Control Self Assessment, Risk Management, Policy Development, and Internal Audit. PPA is required to provide the framework for establishing and maintaining corporate policies and procedures; monitor compliance through risk assessments and internal audits; and, reporting annually on compliance matters to the Board.

## **COMPLIANCE WITH MINISTRY STANDARDS**

Internal audits, management reviews and risk assessments are used to provide assurance to the Board that the OPS is proactive in monitoring compliance with Ministry Standards. This includes providing assurance that internal controls are effective and operational procedures and practices align. Information presented herein summarizes compliance related activities for 2014.

# **External Audits**

There were no external audits undertaken by the OPS in 2014.

The consolidated year-end financial statements of the City of Ottawa are subject to external audit by Ernst and Young. As a consolidated entity, the OPS is also subject to an annual financial audit which is reported to Council, and subsequently provided to the OPSB. In 2013 there were no recommendations specific to the OPS.

#### Internal Audit

## LE-020 Collection, Preservation, and Control of Evidence and Property

Ministry Standards, Board Policy and OPS Procedure requires the police service to conduct an audit of all property and evidence in its custody.

A compliance audit will be completed on the property and evidence control function in April 2015. The objective of the engagement was to assess OPS compliance with Provincial Adequacy Standard LE-020 Collection, Preservation and Control of Evidence and Property, and the related Board policy. The audit also evaluated the effectiveness of controls in place to safeguard evidence and property items; the effectiveness of compliance monitoring activities including accuracy of reports; and, opportunities to improve process efficiency.

#### Control Self Assessment

Control Self-Assessment (CSA) is a risk management process that enables the organization to proactively assess compliance with Ministry Standards. CSA was formally launched in April 2014 with the mandate to review compliance with Ministry Standards. Last year 16 Standards were assessed, including a review of over 600 guidelines. The assessment has confirmed that OPS operations are compliant, with opportunities to improve efficiency of communication, training, supervision and documented procedures.

In response to the findings, Directorates have established management action plans (MAP) that have been incorporated into Directorate Operational Plans. Progress on the MAPs will be monitored through the Professional Accountability and Corporate Excellence Committee (PACE). The following is a list of the Standards that were assessed in 2014.

The CSA process is cyclical and will continue to assess the Standards to ensure compliance and find efficiencies that can be leveraged to enhance service delivery.

Pursuant to S. 3 (1) of Ontario Regulation 550/96 a report has been prepared and submitted to the Minister of Community Safety and Correctional Services setting out the number of major cases the Service investigated in 2014.

# Service Policies (Chief's Procedures)

Service Policy reviews incorporate legislative changes, current practice, training or a recognized opportunity to build on the services and response provided by the organization. During the past year, a total of 16 service policies were revised or created through the Policy Committee, endorsed by Senior Management Committee and approved by the Chief. Four new service policies were developed to meet operational requirements or address legislative amendments, including:

3.28 Asbestos Management
3.30 Mould Management
3.29 Reporting Critical Injuries & Fatalities
2.20 Wireless Devices.

The remaining 12 policies were revised in accordance with Provincial Adequacy Standards.

A policy management framework was implemented to improve the efficiency and effectiveness of the policy intake, assessment, review, and approval processes. The framework also addresses the retention, purging, and stabilization of the 179 existing OPS service policies.

## FINANCIAL STATEMENT

There is no financial impact from this report.

#### **CONCLUSION**

The Ottawa Police Service continues to fulfil its regulatory obligations and maintain compliance with Adequacy Standards through quality assurance, risk management, policy development, and internal audit functions.
