BACKGROUND

The Ottawa Community Lands Development Corporation (OCLDC), as approved by Council on October 10, 2007, is incorporated under the *Corporations Act* with the City as the sole shareholder. OCLDC provides an implementation vehicle, controlled by and available at the discretion of Council, to clearly separate the City's land ownership and real estate development from its planning authority role as the municipality under the *Municipal Act*, 2001 and the *Planning Act*.

At the establishment of the OCLDC, the Board of Directors included eight Members of Council. Officers of the Corporation are appointed from Executive and Senior Management teams by the City Manager.

On December 5, 2018, City Council approved the 2018-2022 Council Governance Review report which included the following recommendation:

That the Ottawa Community Lands Development Corporation Board of Directors be six members, consisting of four Members of Council and two citizen members, as outlined in this report.

As noted in the Governance Report, staff surveyed other Canadian cities with municipal development corporations to identify best practices for board membership. The five cities surveyed all include citizen members on their development board.

Further, the report outlined the benefits of including citizen members on the OCLDC board, such that it would increase technical and industry expertise.

On December 12, 2018, City Council appointed the following Councillors to the Board:

Mayor Jim Watson; Councillor Tobi Nussbaum (Chair); Councillor Laura Dudas; and Councillor Jan Harder.

The Appointment Policy for Citizen Members of City Advisory Committees, Boards and Task Forces, and External Boards, Commissions and Authorities, (the "Appointment Policy") was revised and approved by City Council on December 5, 2018. The Appointment Policy outlines the process and requirements for recruiting citizen members to the City's Advisory Committees, Boards and Task Forces, as well as to its External Boards, Commissions and Authorities, for which members are required.

Advertisements for membership on the City's Sub-committees, Advisory Committees, Boards, External Boards, Authorities and Commission were placed in the Ottawa Citizen and Le Droit beginning November 1, 2018. In addition, ads were posted on the City website, on social media, and were sent to a number of organizations and associations with a potential interest, including planning and architectural firms. The application deadline was Monday, January 14, 2019.

DISCUSSION

The Selection Panel for the Ottawa Community Lands Development Corporation Board of Directors was comprised of Councillors Rick Chiarelli and Laura Dudas, as well as Robyn Guest (on behalf of Mayor Jim Watson, *ex officio*). Their recommendations to Council for the appointment of two (2) voting members and two (2) reserve members to the OCLDC is listed in the Recommendations section of this report.

The Selection Panel is asking Council to waive Section 2.6 of the Appointment Policy in order to allow Ms. Willis to serve simultaneously on the Ottawa Community Development Land Corporation Board of Directors and the Committee of Adjustment.

Since Council enacted this change on December 8th, 2010, few privacy issues have arisen. However, should a Member of Council wish to address any issue arising from such reports, it is suggested that they contact the City Clerk and Solicitor in advance of

any meeting to discuss whether or not their concerns should be address in open or closed session.
