BACKGROUND

The Council-approved Appointment Policy for Citizen Members of City Advisory Committees, Boards and Task Forces, and External Boards, Commissions and Authorities, revised and approved by City Council on December 5, 2018, outlines the process and requirements for recruiting citizen members to the City's Advisory Committees, Boards and Task Forces, as well as to its External Boards, Commissions and Authorities, for which members are required.

Advertisements for membership on the City's Sub-committees, Advisory Committees, Boards, External Boards, Authorities and Commission were placed in the Ottawa Citizen and Le Droit beginning November 1, 2018. In addition, ads were posted on the City website, on social media, and were sent to a number of organizations and

associations with a potential interest. The application deadline was originally Thursday, December 13, 2018; however, the deadline was extended to Monday, January 14, 2019 due to changes in the *2018-2022 Governance Report*.

Specifically, Council approved the recommendation that the membership of the Sub-Committee be expanded to include five (5) councillors and four (4) public members. This includes one additional public member who resides within a Heritage Conservation District, and one additional councillor member. Ads were revised to reference the additional public member position and its specific eligibility requirements.

City Council considered the Nomination Committee report *Appointments To Standing Committees, Transit Commission And Sub-Committees – 2018-2022 Term Of Council* (ACS2018-CCS-GEN-0029) at its December 12, 2018 meeting. Council approved the following recommended appointments of councillor members to the Built Heritage Sub-Committee for the 2018-2022 Term of Council:

1. Councillor Glen Gower (Chair);
2. Councillor Rick Chiarelli;
3. Councillor Catherine McKenney;
4. Councillor Riley Brockington; and
5. Councillor Scott Moffatt.

DISCUSSION

The Selection Panel for the Built Heritage Sub-Committee was comprised of Councillors Scott Moffatt, Glen Gower, and Jan Harder (*ex officio*), as well as James Armbruster (on behalf of Mayor Jim Watson as *ex officio*). Their recommendation to Council for the appointment of four (4) voting public members to the Built Heritage Sub-Committee, including one resident of a Heritage Conservation District, is listed in the recommendation of this report.
