#### **BACKGROUND**

At its meeting of December 5, 2018, Ottawa City Council considered a report titled 2018-2022 Council Governance Review (ACS2018-CCS-GEN-0028). In approving this report, Council approved "That the revised Terms of Reference for Standing Committees, Sub-Committees and the Transit Commission be submitted in draft form to the respective Committees/Commission at their first meeting in 2019 for consideration and recommendation to Council for approval."

Accordingly, this report is presented to the Built Heritage Sub-Committee (BHSC) for its consideration and recommendation to Planning Committee and Council.

With respect to Terms of Reference changes specific to BHSC, the 2018-2022 Council Governance Review report recommended that the following positions be added to the membership of the BHSC:

- One additional citizen member, who resides in a Heritage Conservation District
- One additional Member of Council

The 2018-2022 Council Governance Review report further recommended that the BHSC be provided with the ability to make recommendations directly to Council regarding Ontario Heritage Act reports approved by the Sub-Committee that do not include an accompanying Zoning By-law or Official Plan amendment. This means that the BHSC now has the authority to recommend the following matters directly to Council:

- Approval of additions to the Heritage Register
- Approval for alteration, demolition, or new construction for buildings designated under Part IV or V of the *Ontario Heritage Act* where there are no associated Zoning By-law or Official Plan amendments

- Approval of a staff recommendation for Part IV designations where there are no associated *Planning Act* applications
- Approval of a staff recommendation for the creation of new Heritage Conservation Districts

#### DISCUSSION

The Terms of Reference have been revised by the Clerk's Office to incorporate the above changes approved by Council. The draft revised Terms of Reference for the BHSC are attached at **Document 1**, with proposed changes underlined for ease of reference.

#### **Built Heritage Sub-Committee**

#### **Terms of Reference**

#### **MANDATE**

The mandate of the Built Heritage Sub-Committee is to advise and assist Council on matters relating to Parts IV and V of the *Ontario Heritage Act*, and such other heritage matters as Council may specify by by-law or as specified in the City's Official Plan.

#### **RESPONSIBILITIES**

The Committee shall meet monthly to review applications under the *Ontario Heritage Act*. The Committee shall also have:

- The authority to recommend to Council, through the appropriate Standing Committee, opportunities to issue notice of intent to designate heritage properties;
- b) The ability to be consulted by staff and/or have matters referred to it by other Standing Committees relative to the built heritage portfolio; **and**,
- c) The ability to comment on *Zoning By-law* amendments and Official Plan amendments that involve designated heritage buildings.

#### **COMPOSITION**

The Built Heritage Sub-Committee shall be organized as follows:

- Five (5) Members of Council including at least:
  - o One (1) member of the Planning Committee;
  - o One (1) member of the Agriculture and Rural Affairs Committee; and,
  - One (1) member of Council whose ward encompasses a Heritage Conservation District; and,

• <u>Four (4)</u> citizen members, with appropriate experience, appointed by Council <u>with at least one of the citizen members that resides within a</u>

Heritage Conservation District

The Mayor is an *ex-officio* member of the Sub-Committee.

#### REPORTING RELATIONSHIP

The Built Heritage Sub-Committee has the authority to recommend the following matters directly to Council, without consideration by the Planning Committee or Agriculture and Rural Affairs Committee (ARAC):

- Approval of additions to the Heritage Register;
- Approval for alteration, demolition, or new construction for buildings
   designated under Part IV or V of the Ontario Heritage Act where there are
   no associated Zoning By-law or Official Plan amendments;
- Approval of a staff recommendation for Part IV designations where there are no associated *Planning Act* applications; and
- Approval of a staff recommendation for the creation of new Heritage Conservation Districts).

<u>For all other matters</u>, the Built Heritage Sub-Committee shall report through the Planning Committee <u>or ARAC</u> to City Council; however, it may also report to another Standing Committee where appropriate, depending on the issue.
