WHEREAS the Tornado/Wind Storm that struck the City of Ottawa on September 21, 2018 resulted in significant tree damage in the affected neighbourhoods; and

WHEREAS the City of Ottawa's top priority during the storm clean-up was to ensure public safety and assist residents' efforts to get back into their homes, and the first goal during recovery efforts was to remove debris, and

WHEREAS tree stumps on private property were not ground down or removed during the initial clean-up as they did not pose an immediate hazard to public safety; and

WHEREAS the Province of Ontario has a Disaster Recovery Assistance for Ontarians (DRAO) Program that provides financial assistance following natural disasters; and

WHEREAS staff are aware that not all expenses from windstorm and tornado damage are covered by the DRAO Program, by private insurance or under the purview of the City; and

WHEREAS the City of Ottawa requested and received funding from the Province of Ontario to support the recovery efforts; and

THEREFORE BE IT RESOLVED THAT staff provide a plan to the Standing Committee on Environmental Protection, Water and Waste Management in the Spring of 2019 to offer support to affected residents for stump grinding on private property through partnerships with NGO Alliance members and/or corporate partners; and

BE IT FURTHER RESOLVED THAT the City use any remaining funding provided by the Province to assist with the recovery efforts to support a program for stump grinding on private property.

DISCUSSION

Chair Moffatt explained that the Motion spoke to the grinding of tree stumps on private properties from trees felled in Ottawa as a result of tornado and windstorm damage in September of 2018. Councillor Egli added that the Motion would seek to provide a plan to offer support to affected residents through partnerships with NGO Alliance members
