#### REPORT RECOMMENDATION

That the Ottawa Public Library Board approve the 2018 regular meeting schedule as proposed in Document 1.

#### RECOMMANDATION DU RAPPORT

#### **BACKGROUND**

The Public Libraries Act, Section 16 (1) requires that "A board shall hold regular meetings once a month for at least 10 months each year and at such other times as it considers necessary."

In accordance with the Ottawa Public Library (OPL) Board Rules of Procedure By-law (Section 15) approved in January 2015, regular meetings shall be held once a month for

at least 10 months of the year, and shall be held at the place and time as designated by the Board.

## **DISCUSSION**

While the Board is required to hold a meeting each month for 10 months, there is no requirement with regard to the date or time of regular meetings. In 2017, OPL Board meetings were typically held on the second Tuesday of the month at 5:00 p.m.

Staff's recommendation is to maintain consistency and continue to hold meetings at 5:00 p.m. on the second Tuesday of each month, in the Champlain Room at City Hall, unless otherwise noted. The noted modifications to the schedule, if approved, are:

- The January meeting of the Board will occur on the third Tuesday of the month; and,
- The September meeting of the Board will occur on the first Tuesday of the month.

In addition, the meeting in March is during the March Break, and the meetings in September and October follow statutory holidays, and the November meeting is the day after Remembrance Day observance.

The Board meeting schedule was developed in consultation with Trustees. Staff confirmed that the proposed meeting schedule does not conflict with any of the City of Ottawa's Council meetings, standing committee meetings, and/or other meetings.

The proposed calendar (Document 1) includes regularly scheduled meetings for the months of July and August. In the event that meetings are not required, staff will ensure advance notice is provided that no meeting will be held.

## **CONSULTATION**

The Board Chair and Trustees were consulted in the development of the 2018 Board Meeting schedule.

The City of Ottawa's room booking agent was contacted to confirm the availability of the Champlain Room for all proposed dates.
