**SUBJECT: 2017 Board Meeting Schedule**

#### REPORT RECOMMENDATION

That the Ottawa Public Library Board approve the 2017 regular meeting schedule as proposed in Document 1.

#### RECOMMANDATION DU RAPPORT

#### **BACKGROUND**

The Public Libraries Act, Section 16 (1) requires that "A board shall hold regular meetings once a month for at least 10 months each year and at such other times as it considers necessary."

In accordance with the Ottawa Public Library (OPL) Board Rules of Procedure By-law (Section 15) approved in January 2015, regular meetings shall be held once a month for

at least 10 months of the year, and shall be held at the place and time as designated by the Board.

#### DISCUSSION

While the Board is required to hold a meeting each month for 10 months, there is no requirement with regard to the date or time of regular meetings. In 2016, OPL Board meetings were typically held on the second Tuesday of the month at 5:00 p.m.

Staff recommendation is to maintain consistency and continue to hold meetings at 5:00 p.m. on the second Tuesday of each month, in the Champlain Room at City Hall, unless otherwise noted. The noted modifications to the schedule, if approved, are: the January meeting of the Board will occur on the last Tuesday of the month; and the March, September and December meetings of the Board will occur on the first Tuesday of the respective months. In addition, the meetings in September, October, and November follow statutory holidays.

The Board meeting schedule was developed in consultation with Trustees. Staff confirmed that the proposed meeting schedule does not conflict with any of the City of Ottawa's Council meetings, standing committee meetings, and/or other meetings.

Based on actual meeting schedules from the previous two years, the proposed calendar includes regularly scheduled meetings for the months of July and August. In the event that meetings are not required, staff will ensure advance notice is provided that no meeting will be held.

#### CONSULTATION

The Board Chair and Trustees were consulted in the development of the 2017 Board Meeting schedule.

The City of Ottawa's room booking agent was contacted to confirm the availability of the Champlain Room for all proposed dates.

# **LEGAL IMPLICATIONS**

The proposed 2017 Board meeting schedule complies with sub-section 16 (1) of the *Public Libraries Act* regarding a regular monthly meeting schedule (for at least 10 months of the year). The schedule also complies with Section 15 of the OPL Board Rules of Procedure By-law.
