WHEREAS the COVID-19 pandemic, has highlighted issues within the Long Term Care home system; and

WHEREAS these issues are not new and existed long before COVID-19 began. Now more than ever, there is a pressing need to change the system so that residents in LTC homes are safe, comfortable, and live with dignity and quality of life; and

WHEREAS the COVID19 pandemic has further highlighted the importance of quality Long Term Care facilities and with the City of Ottawa operating 4 long term care homes; and

WHEREAS the Community and Protective Services committee recognizes that due to the COVID-19 pandemic, the City-operated homes have needed to shift their priorities to focus on outbreak prevention, containment of the virus and implementation of changing directives, which has resulted in significant resource pressures during the emergency response;

THEREFORE BE IT RESOLVED that the following revised recommendation be approved:

That the Community and Protective Services Committee direct staff to present to Committee and Council a Dementia Care Strategy Framework

for the City's Long-Term Care homes which focuses on innovative dementia care models by Q4 2021.
