BACKGROUND

Over the last 10 years as an elected official, Councillor Fleury visits Long Term Care homes on a quarterly basis to share updates about the Ward and to speak with residents, staff and families.

During these visits, Councillor Fleury often received inquiries from family members and care givers about maintenance to be completed and lack of clarity regarding planned upgrades. Given the importance of ensuring the quality of City operated Long Term Care homes, it is important to have a publicly available 1 year outlook on planned maintenance, for each facility, to ensure proper notice is given and that proper resources are secured.

As a result, the Community and Protective Services Committee, at its meeting of November 19, 2020, received the following Notice of Motion to be considered at a subsequent meeting:

WHEREAS the COVID19 pandemic has further highlighted the importance of quality Long Term Care facilities and with the City of Ottawa operating 4 long term care homes;
