SUBJECT: Adoption of OPL 2016 Draft Budget

OBJET: Adoption du budget provisoire 2016 de la BPO

REPORT RECOMMENDATIONS

- 1. That the Ottawa Public Library (OPL) Board approve the 2016 OPL Draft Operating and Capital Budget, and forward to City Council for consideration and final approval; and,
- 2. That the Board approve the draft funding request for \$3.9M to further the work required for the Central Library Development Project; and that in addition to OPL funds of \$1M for the project, the OPL request that Ottawa City Council fund the balance of \$2.9M from City reserves.

poursuivre les travaux nécessaires dans le cadre du projet d'aménagement de la Bibliothèque centrale et que, outre les fonds d'un million de dollars consacrés par la BPO à ce projet, la BPO demande au Conseil municipal d'Ottawa de financer le solde, soit 2,9 millions de dollars, à partir des réserves de la ville.

BACKGROUND

At its meeting of November 10, 2015, the Ottawa Public Library Board (the Board) received 2016 draft budget estimates that are in keeping with the guidelines approved by City Council. The 2016 draft budget estimates were subsequently tabled with City Council on November 12 2015.

DISCUSSION

OPL has been allocated \$1.041M in its draft 2016 budget to address operating and/or capital pressures. As a result, OPL has a budget envelope of \$46.297M and a net operating budget of \$45.362M. The draft operating budget is summarized in Table A. The majority of the allocation will be used to maintain existing services.

In order to further the planning for the Central Library Development Project, capital funding of \$3.9M is required in 2016. OPL has worked with the City's Finance Department to develop a funding solution. Through a cost-shared approach, OPL proposes to self-fund \$1M of the 2016 requirement with the balance of \$2.9M funded by the City through the use of City reserves. Table C summarizes the proposed Central Library Development Project funding.

In summary, the proposed is a straight-forward budget, which maintains services with the existing staff complement while advancing key OPL Board and Ottawa City Council strategic initiatives.

CONSULTATION

OPL budget information was available online at www.biblioottawalibrary.ca and members of the public were invited to provide feedback on the draft budget via BudgetOPLBPO@biblioottawalibrary.ca and other feedback channels. Members of the public were offered the opportunity to share their views at public consultation sessions led by the Mayor and Ottawa City Councillors throughout the summer and into the fall. The OPL Board will receive public delegations at its meeting on December 1, 2015.

LEGAL IMPLICATIONS

The draft budget is in keeping with the *Public Libraries Act*, *R.S. O. 1990, c. P. 44*, (PLA) which states: A public library board, county library board or county library cooperative board shall submit to the appointing council, annually on or before the date and in the form specified by the council, estimates of all sums required during the year for the purposes of the board. *R.S.O. 1990, c. P.44*, s. 24(1).
