Many of the delegations spoke on the following items and concerns:

- Demand is far outpacing funding.
- Many new and worthwhile organizations and "on ramp" funding is required to assist them.
- The increase in minimum wage will hit many organizations hard.
- The need for more healthy, safe and affordable housing.
- Programs for seniors especially those in isolation.
- Programs and assistance for the homeless especially homeless teens.
- Education and outreach on many issues such as homophobia, transphobia, abused women, etc...
- Recreation programs to encourage health such as trails for X-country skiing.
- Property standard issues and health bedbugs being one.
- Many social organizations to be seen as an investment where the return is greater than the money invested.
- Fundraising is much harder and absorbs a lot of energy and time best used elsewhere.
- The value in having firefighter paramedics.
- Quality of life issues such as accessible washrooms in parks and public areas.
- Arts, culture and festivals a great value for residents and visitors and return on investment is high.

- Access to healthy and affordable food.
- An offer by the Social Planning Council of \$100,000 if City could match or better for on ramp funding.

Following the delegations, staff responded to member's questions regarding the concerns raised by those delegations and as well as other concerns listed below:

- 100 portable washrooms are rented for summer use in parks and sports fields. City is looking at possibility of 10 more in areas where seniors recreate more.
- Further review of by-laws regarding marijuana. However, this is still a moving target.
- Paramedics are a shared financial responsibility with the province 50/50 but only on a provincial fiscal year (April to March)
- There is a wait for Loong Term care beds of about 2 years. This is managed by the LHIN.
- The need to ensure that the Paramedics issues don't fall behind again now that that 50 FTE's to hired this term of Council and new ambulances. Will it be enough? Staff said that this should be good for 2018.
- A review of cameras in public areas is taking place with a report in Spring 2018.
- In 2015 there was financial pressure and \$4 million was transferred from capital to operations.
- There were 146 housing units built in 2017, 255 in development, 130 to be announced soon and approximately 300 for 2018.
- Questions were raised on the new Hotel Tax but and its destination and use but still too early to have concise information.
- Discussion ensued on the Social Planning Council offer of \$100,000 and directions to staff given to be ready for Council on December 13.
- The City's share of social housing costs now is 58%, 33% province and 9% federal.

Two directions to staff were given.

Before introducing the roadmap motion Chair Deans wrapped up with final comments and concerns.

The budget roadmap motion was then put before the Committee and carried as presented.
