WHEREAS the City of Ottawa also partners with the Velocity Media Company (1823374 Ontario Inc.) for the supply, installation, and maintenance of bicycle racks with advertising faces in various locations across the city, at no cost to the City;

THEREFORE BE IT RESOLVED THAT Transportation Committee recommend that City Council waive the requirements of the City's Municipal Parking Management Strategy to install bike racks only in paid parking areas, and establish a pilot project for 2018 to install bike racks at up to 50 OC Transpo bus stops both within and outside paid parking areas, as described in this motion, to be funded from within the existing Parking Operations budget, on the understanding that any additional funds required will be transferred from the Parking Reserve Fund, to an upset limit of \$30,000; and

Ken Holmes* spoke on the matter of under-funded road maintenance and provided recommendations for improvement.

Alex Cullen, Council on Aging (COA), Ottawa Seniors Transportation Committee*, stressed the importance of winter sidewalk maintenance and its impacts for seniors and requested that additional funds be allocated.

Alex Cullen and Roland Dorsay, Federation of Citizens Associations (FCA)*, spoke to the Transportation Master Plan (TMP) and recommendations to better achieve the TMP's goals regarding active transportation.

Dianne Bretton, Council on Aging (COA), Pedestrian Safety Committee*, emphasized the importance of snow and ice clearing and its impacts for seniors.

Eric McCabe, Gotta Go Campaign*, spoke to the necessity of signage directing people to the nearest public toilet in and around LRT.

Hélène Nadeau, Accessibility Advisory Committee (AAC)*, although generally pleased with the budget, spoke to the need to improve accessibility of UBER and taxis in Ottawa, as well as the need to ensure the availability of adequate accessible permit parking spots.

Trevor Haché, Healthy Transportation Committee*, provided recommendations touching on funding to improve cycling and pedestrian infrastructure, road user fees and snow and ice clearing.

Robb Barnes, Ecology Ottawa, touched on the Complete Streets implementation plan, the implementation of Cycling and Pedestrian Plans and cautioned the disproportionate amount of investment in road widening in relation to pedestrian and cycling.
