BACKGROUND

The Diefenbunker, Canada's Cold War Museum, is a community-operated museum located at 3929 Carp Road and funded in part by the City of Ottawa since 2002. Its mandate is to "increase throughout Canada and the world, an interest in, and an understanding of, the Cold War by preserving the Diefenbunker as a National Historic Site and operating as a Cold War Museum." It was incorporated as a not-for-profit organization in November 1998.

In October 1998, the Township of West Carleton entered into an Agreement with the Diefenbunker to convey to the museum the “Bunker Lands” and the “Guardhouse Lands” for the sum of \$1 and to lease certain adjoining lands. The agreement between the Museum and the Township included the adoption of a by-law declaring the Cold War Museum to be a Municipal Capital Facility (By-Law 34 1998). Since this time, Canada’s Cold War Museum has operated a cold war museum. Through its Cultural Funding program, the City contributes to the cost of operating the museum (\$270,690 in 2017).

The current Municipal Capital Facilities (MCF) designation expires on May 1, 2018. To ensure that the Cold War Museum can continue to operate as a community museum, open to the public as a cultural, recreational and tourist facility, it is necessary to extend the term of the municipal Capital Facilities Agreement.

On April 11, 2018, City Council directed staff to report back to the Finance and Economic Development Committee (“FEDCO”) and Council with a report to further extend the existing Municipal Capital Facilities Agreement (MCFA) beyond the May 31, 2018 extension.

DISCUSSION

The Museum operates as a not-for-profit museum with limited financial resources. The exemption from property taxes through an MCF designation remains a critical component to maintaining its financial viability.

Regulation 603/06 of the Ontario Municipal act requires that the municipality own, agree to purchase or own on reversion the facility and the land being exempted from taxes under an MCFA. The Township of West Carleton entered into a MCFA with the Museum following the Purchase and Sale agreement in 1998, which included an option to purchase the land on the completion of the agreement.

To allow the museum for continue to plan for medium and long term facility and program development, the Department is recommending the approval of a 20 year extension to the initial 20 year Municipal Capital Facilities Agreement, with an option to purchase at that time. This long-term commitment to the museum is essential to enable it to remain eligible for capital improvement and operational grants, and is consistent with the terms of similar MCFA approved by City Council. Recent examples include a 30 year MCFA

for the Richcraft Sensplex East and a 25 year MCFA for the inflatable sports dome at Ben Franklin Park.
