THEY HAVE A PROBLEM GAMBLING PROGRAM SPECIFICALLY FOR OLDER ADULTS.WE KNOW THAT SENIORS ARE HARDER HIT BY PROGRAM GAMBLING AT GAMBLING TABLES AND ELECTRONIC GAMBLING TABLES.AND THEY HAVE ASSERTED WITH ME ANY WAY AND I CAN READ IT OUT LOUD OR I CAN CERTAINLY FORWARD IT TO ANYONE WHO WOULD LIKE TO SEE IT THAT THEY WILL NEED ADDITIONAL RESOURCES TO, YOU KNOW, ADDRESS THE INCREASE IN PROBLEM GAMBLING IN THE CATCHMENT AREA. SO IT'S GIVING PEOPLE THE CHOICE TO WAIT TO HEAR WHAT HAPPENS WITH THE PROVINCE BEFORE VOTING FINALLY, WHETHER THEY WOULD BE IN FAVOUR OF ALLOCATING 2% OF THE 5, UP TO \$12 MILLION WE'LL BE GETTING OVER THE COMING YEARS FOR PUBLIC HEALTH PURPOSES WITH, FOR PREVENTION AND TREATMENT, I'LL STOP THERE. >> COUNCILLOR MCKENNEY HAS A MOTION. DO YOU HAVE A

MOTION, COUNCILLOR?>> YEAH. >> OKAY. THE FLOOR IS YOURS. >> THANK YOU. MR. MAYOR. I HAVE A MOTION THAT ESSENTIALLY WOULD LIMIT THE NUMBER OF SLOT MACHINES. I THINK THAT THAT IS THE -- THAT HAS BEEN THE CRUX OF A LOT OF OUR DISCUSSION, AND I WANT TO CALL IT DISCUSSION AROUND WHAT OUR PAST MOTIONS MEANT, WHAT 82-12 MEANT AND WHAT THE INTENTION OF HARD ROCK IN TERMS OF THE CAPS ON THE SLOT MACHINES. MY MOTION ESSENTIALLY IS WHEREAS AS THE ONTARIO LOTTERY AND GAMING COMMISSION CAPS SLOT MACHINES IN ANY GIVEN FACILITY TO 2,000 MACHINES, AND WHEREAS THE CURRENT PROPOSED ZONING RECOMMENDATION FOR THE HARD ROCK CASINO DOES NOT SPECIFY A CAP TO THE NUMBER OF SLOT MACHINES AT THE HARD ROCK CASINO, THEREFORE BE IT RESOLVED THAT UNDER THE DETAILS OF THE RECOMMENDED ZONING, AMEND EXCEPTION 528R WITHIN SECTION 239, COLUMN 3-2. CASINO LIMITED 2.000 SLOT MACHINES AND 55 GAMING TABLES AND BE IT FURTHER RESOLVED THERE BE NO FURTHER NOTICE PURSUANT TO THE PLANNING ACT. ESSENTIALLY WHAT THAT DOES IS IT -- YOU KNOW, IN ADDITION TO HAVING HARD ROCK COME BACK ON THE GAMING TABLES TO COMMITTEE AND COUNCIL, ALTHOUGH THERE IS ALREADY A CAP ON SLOT MACHINES WITH O.L.G., IT MEANS THAT IF HARD ROCK WANTED TO EXPAND THAT, THEY WOULD HAVE TO COME BACK TO COMMITTEE AND COUNCIL AND AS WELL. >> THANK YOU. COUNCIL LEIPER ON THE REPORT AND THE MOTIONS BEFORE US. >> THANK YOU, CHAIR. I JUST HAVE A COUPLE OF QUICK QUESTIONS OF STAFF. THE DEFINITION FOR CASINO PROPOSED IN THE REPORT SPEAKS TO ANCILLARY FINANCIAL SERVICES USES. WHAT ARE THOSE ANTICIPATED TO BE?>> WE DON'T HAVE DETAILS ON THAT BUT REALLY WHAT WE'RE DOING WITH THE NEW DEFINITION OF THE CASINO IS CAPTURING THE TYPES OF THINGS THAT TYPICALLY WOULD BE ASSOCIATED WITH A CASINO. RIGHT NOW A LOT OF THESE THINGS, IN FACT, ARE PERMITTED UNDER THE CURRENT ZONING. EITHER AS ACCESSORY OR ANCILLARY CATEGORY BECAUSE WE DIDN'T HAVE A SPECIFIC DEFINITION RATHER THAN CONTINUING WITH THAT FRAGMENTED APPROACH HOW WE'RE DEALING WITH ISSUES, ROLLING IT ALL INTO ONE. THE ANCILLARY FINANCIAL POTENTIALLY COULD BE SOME FINANCIAL SERVICES, IT COULD BE FINANCIAL COUNSELLING, IT COULD BE SOMETHING ALONG THESE LINES. BUT, AGAIN, I THINK THAT'S PART OF WHAT THEY WILL DEAL WITH, CONTINUED DISCUSSIONS WITH THE HARD ROCK PROPRIETORS IN TERMS OF WHAT THEY WILL BE PROVIDING. >> DO WE HAVE A DEFINITION IN OUR ZONING BYLAW

WHAT FINANCIAL SERVICES ARE?>> UM, WITHOUT TAKING A LOOK AT IT, I'M SURE THAT WE DO. IT'S PROBABLY CAPTURED UNDER A BANK DEFINITION AND THAT'S FAIR ENCOMPASSING IN TERMS OF THE TYPES OF OPERATIONS THAT WOULD BE ASSOCIATED WITH IN A. I DON'T HAVE THAT IN FRONT OF ME. I CAN DEFINITELY GET THAT BACK TO YOU, COUNCILLOR. >> CASINO WOULD, UNDER THIS DEFINITION, BE ALLOWED TO INCLUDE A BANK?>> THAT WOULD BE THE POTENTIAL FOR THAT, YES. BUT I'D HAVE TO CONFIRM. IF YOU CAN GIVE ME A COUPLE OF MINUTES. I'LL LOOK AT THE ZONING AND SEE WHAT WE HAVE IN TERMS OF THE DEFINITION. >> OKAY. I'LL LET YOU LOOK AT THAT. THANK YOU. I SHARE COUNCILLOR NUSSBAUM'S DISCOMFORT WITH HOW THIS HAS ROLLED OUT IN TERMS OF OUR OPPORTUNITY AS A COUNCIL TO SAY THAT WE CONTINUE TO BELIEVE THE 2013 CAP APPLIES. IT SOUNDS LIKE THE 81-12 REGULATION WAS AN IMPORTANT OPPORTUNITY THAT CAME BY. WE WERE TOLD IT WAS A TECHNICALITY AND WE VOTED FOR THAT. I NOTE THAT IN THEIR RECENT APPROVAL FOR THE GAMBLING IN TORONTO, THAT CITY COUNCIL IN TORONTO HAS VOTED TO REQUEST THE PROVINCE OF ONTARIO TO AMEND ONTARIO REGULATION 81-12 AS NECESSARY TO PROVIDE A CLEAR REQUIREMENT FOR MUNICIPAL APPROVAL PRIOR TO ANY DECISION TO SUBSTANTIALLY EXPAND OR RENEW GAMING SITES AND RELATED CONTRACTS WITH OPERATORS WITHIN THE MUNICIPALITY. GIVEN THE -- GIVEN THE WAY THAT THIS PROCESS HAS UNROLLED, I'M WONDERING FROM THE SOLICITOR WHETHER HE FEELS THAT THAT WOULD BE A HELPFUL THING TO ASK THE PROVINCE AS WELL. >> MR. MAYOR, SEEKING GREATER CLARITY, I CONCEDE WOULD BE AN EXCELLENT IDEA. >> OKAY. I'LL LEAVE IT THERE. THANK YOU VERY MUCH. >> COUNCILLOR EGLI, PLEASE. >> THANK YOU VERY MUCH, MR. MAYOR. I WANT TO START OFF BY THANKING AND RECOGNIZING THE WORK THAT THE CHAIR HAS DONE ON THIS FILE. IT'S BEEN A VERY CHALLENGING FILE GOING FORWARD AND CERTAINLY I THINK THE DOCTOR IS THINKING THIS IS CERTAINLY A CHALLENGING FILE TO BE TAKING ON ON HER FIRST INITIAL DAY. BUT I KNOW THE HARD WORK THAT THEY'VE PUT ON THIS FILE IN MOVING IT FORWARD AND ADDRESSING THE CONCERNS THAT HAVE COME UP. SO I JUST WANT TO ACKNOWLEDGE THAT TO START. I'M MORE COMFORTABLE WITH COUNCILLOR NUSSBAUM'S MOTION THAN I WAS THEERS HAVE I SAW LAST NIGHT. AND I THINK IT'S A BACK-UP PLAN, IF YOU WILL, IF WHAT THE BOARD OF HEALTH CAME FORWARD WITH, AND I WANT TO THANK COUNCILLOR TAYLOR FOR ASSISTING ME ON THE BOARD HEALTH TO BRING FORWARD A MOTION WHICH CHANGED THE RECOMMENDATIONS SO

THAT THE MONEY BEING ASKED FOR WASN'T A HARD CAP BUT RATHER A MINIMUM ASK. SO IT DOES GIVE THE BOARD FLEXIBILITY. BUT IF THOSE THINGS DON'T WORK OUT, THEN COUNCILLOR NUSSBAUM'S MOTION THAT RECOMMENDS THAT WE CONSIDER THAT AS PART OF THE 2019 BUDGET IS CERTAINLY A BACK-UP PLAN. IT STILL CONCERNS ME A LITTLE BIT BECAUSE I'M NOT SURE WE SHOULD BE TAKING ON THE OBLIGATION OF FIXING A PROBLEM, WHICH EMANATES FROM THE PROVINCE. WE DON'T REALLY HAVE A LOT OF CONTROL OVER WHETHER THERE'S GAMBLING IN ONTARIO OR NOT. THAT'S ALL PROVINCIALLY DRIVEN. THAT PART STILL MAKES ME A LITTLE BIT NERVOUS. BUT SINCE IT'S TONED DOWN SOMEWHAT IN MOVING IT FORWARD AS CONSIDERATION AS OPPOSED TO PUTTING THAT DISCUSSION IN FRONT OF US TODAY, THAT'S A MOTION THAT I WILL BE SUPPORTING. AS FOR COUNCILLOR MCKENNEY'S MOTION, I'LL BE SUPPORTING THAT AS WELL. I HAVE TO BE FRANK. MY NAME WAS BATTED AROUND A LITTLE BIT AS THE COUNCILLOR THAT ASKED THE QUESTION. I DON'T THINK THE QUESTION I ASKED COULD HAVE BEEN CLEARER. IT WAS VERY DIRECT AS TO WHETHER IT WOULD BE A REAFFIRMATION OR NOT, THE ANALOGY USED DURING THE DISCUSSION WAS -- YOU KNOW, IS THIS THE SAME THING AS SOMEBODY BUYING A HOUSE AND US SIMPLY TURNING THE KEYS OVER TO THE HOUSE AND YOU GET THE HOUSE WITH NO RENOVATIONS, NO CHANGES WHATSOEVER. YOU JUST GET THE HOUSE. IN EFFECT. WHAT WE WERE TOLD WAS WE WERE APPROVING A NEW OWNER AND THAT WAS IT. WE'RE APPROVING A NEW CONSTRUCTION. IT WASN'T LIKE THE UGANDAN EMBASSY TO BE KNOCKED DOWN AND REBUILT. WE WERE TRANSFERRING THE HOUSE. AS IT WAS, WITHOUT ANY ADDITIONS, ANY NEW CONSTRUCTION, ANY RENOVATIONS, ANY CHANGES. SO IN THAT REGARD, I THINK THAT THE MOTION BROUGHT FORWARD BY COUNCILLOR MCKENNEY IS A PRUDENT ONE TO GET IT DOWN IN WRITING, TO MAKE IT VERY CLEAR WHAT WE'RE SAYING HERE TODAY. I'M HEARDENED BY LEGAL'S POSITION THAT THIS WOULD LIKELY BE SUCCESSFUL ON APPEAL IF THE APPLICANT DECIDED THAT THEY WANTED TO CHALLENGE IT. SO I THINK IT MAKES IT CLEAR SOMETHING THAT WAS NOT CLEAR LAST TIME AROUND, UNFORTUNATELY, BUT THIS IS VERY CLEAR, VERY DIRECT. I THANK HER FOR BRINGING IT AND I'LL CERTAINLY BE SUPPORTING THAT MOTION AS WELL. >> ALL RIGHT. THANK YOU. >> THANK YOU VERY MUCH, MR. MAYOR. I DO HAVE A COUPLE OF QUESTIONS OF DR. ETCHES FIRST BEFORE I MAKE SOME COMMENTS ON WHAT THE DISCUSSION THAT'S HAPPENING THIS MORNING. TO DR. ETCHES, DOCTOR,

WHEN YOU DID THE REPORT -- WHEN OTTAWA PUBLIC HEALTH PROVIDED THE REPORT. WHAT KIND OF WORK WENT INTO PRODUCING THAT REPORT?DID YOU GO OUT AND CONSULTANT WITH THE COMMUNITY?DID YOU CONSULT WITH THE PARENTS IN THE COMMUNITY ALONG WITH SOME OF THE, YOU KNOW, OTHER ITEMS THAT YOU WOULD HAVE TO LOOK AT IN ORDER TO PUT THIS KIND OF REPORT TOGETHER?>> MR. MAYOR, WE CONSULTED WITH COMMUNITY MEMBERS PROVIDING TREATMENT. WE CONSULTED WITH OTHER PROVINCIAL ORGANIZATIONS THAT LEAD RESEARCH INTO GAMBLING AND THE EFFECTS OF GAMBLING ON HEALTH AND WE DID LOOK AT THE LITERATURE. >> IN THAT CONSULTATION WITH THE PARTNERS. THE HEALTH CENTRES WERE PART OF THAT CONSULTATION, AM I CORRECT?>> YES. >> THANK YOU. IN TERMS OF THE RECOMMENDATIONS THAT YOU PUT ON THE REPORT, THE FOUR RECOMMENDATIONS IN FRONT OF COUNCIL THIS MORNING, WHERE DID THOSE RECOMMENDATIONS COME FROM?DID YOU CONSULT WITH, LIKE, THE HARD ROCK CASINO, OR WAS THAT BASED ON EVIDENCE THAT YOU'RE AWARE OF IN TERMS OF THE MEDICAL FIELD AND OTHER PARTNERS IN THE COMMUNITY?>> WE PUT FORWARD THE PLAN BASED ON THE LITERATURE AND CONVERSATIONS WITH PARTNERS. WE SHARED SOME OF THE IDEAS AROUND THE NETWORK WANTING COMMITMENT FROM O.L.G. AND HARD ROCK OTTAWA TO PARTICIPATE IN THE NETWORK. AND WE DID GET CONFIRMATION THIS IS SOMETHING THEY WOULD SUPPORT. >> THANK YOU VERY MUCH. YOU KNOW, JUST THE CONVERSATION AROUND THE TABLE THIS MORNING, I MEAN, I KNOW WHAT HAPPENED BACK IN 2013 WITH THE CASINO DEBATE THEN, AT THAT POINT. THE COUNCIL OF THE DAY CHOSE TO PUT SOME RESTRICTIONS ON THE CASINO THAT WAS OPERATING, OR THE RIDEAU CARLETON RACEWAY THAT WAS OPERATING. THOSE RESTRICTIONS, AND THE OPINION WAS THAT YOU WERE RESTRICTING THE HANDS OF A BUSINESS THAT YOU FIRST AUTHORIZED TO GO AHEAD OPERATE AND THEN RESTRICT THEIR CAPABILITIES OF OPERATING THAT BUSINESS. THIS MORNING WE'RE HERE TO LOOK AT A NEW PROPOSAL -- OR AN EXTENSION OF THE PAST PROPOSAL. IF YOU WANT TO CALL IT THAT. I THINK THE RECOMMENDATION -- OR THE SUGGESTION THAT WAS MADE TO OTTAWA PUBLIC HEALTH IS TO GO OUT AND DO DUE DILIGENCE. AND WE DID THAT, AS YOU JUST HEARD FROM DR. ETCHES. COULD THERE BE MORE WORK DONE? I DON'T THINK SO. I THINK THE WORK WAS COMPLETED. THE RECOMMENDATIONS CAME FORWARD IN THE REPORT, AND, AS I SAID TO SOMEBODY JUST A FEW MINUTES AGO,

HERE'S A DEPARTMENT THAT WE SPEND MONEY IN TO ASK FOR THEIR PROFESSIONAL HELP. TO ASK FOR THEIR KNOWLEDGE-BASED HELP. AND THAT'S WHAT THE OTTAWA PUBLIC HEALTH DOES AND DOES PROVIDE ON AN ONGOING BASIS. THE ITEM THAT WE'RE DISCUSSING THIS MORNING AND IS PART OF THAT RECOMMENDATION FROM THE PUBLIC HEALTH, I MEAN, YOU KNOW, YOU PAY PROFESSIONALS ALMOST A QUARTER OF A MILLION DOLLARS, YET EVERY TIME THEY COME OUT WITH A RECOMMENDATION, WE SORT OF SAY WELL, YOU KNOW, I DON'T KNOW WHETHER WE SHOULD FOLLOW THOSE RECOMMENDATIONS. I THINK IT'S ABOUT TIME WE DID FOLLOW THOSE RECOMMENDATIONS. IN THIS PARTICULAR CASE. THESE RECOMMENDATIONS ARE GOOD AND SOUND RECOMMENDATIONS. COULD WE USE MORE MONEY?ALWAYS. EVERYBODY CAN USE MORE MONEY. BUT MONEY IS NOT THE SOLUTION. YOU CAN'T JUST THROW MONEY AT A PROBLEM AND SAY IT'S GOING TO BE SOLVED. PEOPLE TALK AROUND THIS TABLE ABOUT GAMBLING. GAMBLING IS JUST NOT A CASINO ISSUE. GAMBLING, WHETHER WE LIKE IT OR NOT, IT'S IN OUR BASEMENTS, WHETHER YOU ARE DOING COMPUTER GAMBLING, O.L.G., YOU KNOW, BUYING LOTTERY TICKETS, THAT'S ALL GAMBLING. I JUST WANT TO CAUTION IN THE MOTION THAT COUNCILLOR NUSSBAUM PUT FORWARD ABOUT THE MONEY. I DON'T WANT TO TAKE ON AS A MUNICIPALITY A RESPONSIBILITY THAT BELONGS IN THE PROVINCE'S BASKET. LEAVE IT THERE. TODAY WE'RE TALKING ABOUT CASINOS. TOMORROW WE COULD BE TALKING ABOUT CANNABIS-RELATED ISSUES. HOW MUCH OF THOSE ISSUES DO WE WANT TO OWN? I THINK THE PLAN THAT'S HERE TODAY, BASED ON SOUND AND REASONING PLAN, I THINK WE SHOULD SAY, LET'S MOVE FORWARD. WHAT HAPPENS IN THE FUTURE IN TERMS OF MONEY, SO ON AND SO FORTH, WE CAN LOOK AT THAT IN THE FUTURE. RIGHT NOW THERE'S RECOMMENDATION TO ASK FOR ONE-TIME FUNDING OF \$150,000 AND ONGOING FUNDING OF \$200,000 RECOMMENDED BY THE OTTAWA PUBLIC HEALTH. THEY'VE CONSULTED WITH THE PARTNERS. THAT FUNDING FOR NOW, I THINK IS SUFFICIENT. LET'S MOVE FORWARD WITH THAT, AND THEN, IF IN THE FUTURE WE NEED THAT MONEY OR WE NEED EXTRA MONEY, WE CAN LOOK FOR THAT AT THAT TIME. BUT OUR MANDATE WITH THE PUBLIC HEALTH IS TO WORK WITH THE MINISTRY OF HEALTH CHAMPLAIN LHIN AND SEE HOW WE CAN GET THIS PROGRAMME ON RAIL AND HOW TO WORK TOWARDS MAKING IT A SUCCESS. THANK YOU VERY MUCH, MR. MAYOR. >> OKAY. THANK YOU. COUNCILLOR QAQISH. PLEASE. >> THANK YOU, MAYOR. I'LL START OFF WITH A COUPLE OF QUESTIONS TO DR. ETCHES.

WE DID HAVE AN EXTENSIVE DEBATE AT BOARD OF HEALTH, WHICH I SIT ON AND SO I'M VERY COMFORTABLE WITH THE REPORT AND THE RECOMMENDATIONS THAT WE CAME UP WITH THERE. IN TERMS OF THE LETTER THAT WE -- THE REQUEST FOR FUNDING, HAS THAT SHORT-TERM FORECASTED TO THE PROVINCE YET?HAVE THERE BEEN PRELIMINARY DISCUSSIONS BETWEEN STAFF AND THE PROVINCE ABOUT THEIR INTENTIONS ABOUT FUNDING?>> THE LETTER HAS BEEN SENT TO THE PROVINCE. WE'VE NOT HAD ANY DISCUSSIONS YET. >> OKAY. GENERALLY SPEAKING, HISTORICALLY ARE GAMBLING PROGRAMMES FULLY FUNDED BY PROVINCIAL FUNDING?I KNOW THE BOARD OF HEALTH FUNDING IS 75/25. I THINK. GENERALLY SPEAKING, WHEN IT COMES TO GAMBLING PROGRAMMES, ARE THOSE SOLELY FUNDED THROUGH THE PROVINCE OR IS THERE A CITY SHARE THAT GOES TOWARDS THAT?>> GAMBLING ISN'T MENTIONED SPECIFICALLY AS A PUBLIC HEALTH MANDATE IN THE COST-SHARED REQUIREMENTS FOR PUBLIC HEALTH. THAT'S WHY WE'RE SEEKING ADDITIONAL BASE FUNDING FROM THE PROVINCE. AND WE -- SO THE OTHER SECTOR THAT'S BEEN MENTIONED TODAY HERE IN TERMS OF TREATMENT IS FUNDED FROM THE PROVINCE. >> SORRY. CAN YOU REPEAT THAT AGAIN. >> SO TREATMENT FOR PROBLEM GAMBLING IS FUNDED BY THE PROVINCE. >> OKAY. OKAY. I CERTAINLY THINK, YOU KNOW, ON THE HEALTH FRONT THERE'S OBVIOUSLY SEVERAL ELEMENTS AS THE CHAIR POINTED OUT OUTSIDE OF SLOT MACHINES AND LIVE GAMBLING TABLES, WHERE THERE ARE, PERHAPS, BIGGER PROBLEMS EVEN WITH ONLINE GAMBLING AND OTHER VERSIONS OF IT AS WELL. AS I SAID, DO I SUPPORT THE RECOMMENDATIONS THAT WE DISCUSSED AT LENGTH AT THE BOARD OF HEALTH. ON A SEPARATE NOTE, I WANT TO SHIFT TO INFRASTRUCTURE AND THAT'S BEEN A BIG PRIORITY FOR ME AS I REPRESENT THE AREA JUST NORTH OF THE CASINO. AND I'VE BEEN WORKING ON IMPROVEMENTS FOR LEITRIM AND FINLEY CREEK IN THE LAST COUPLE OF YEARS AND THE LANDOWNERS IN THAT AREA HAVE BEEN VERY HELPFUL. WHEN THE CASINO CAME FORWARD, I JUST WANT TO GIVE THEM FULL CREDIT, I SEE JACK'S HERE. I KNOW WE'VE BEEN GIVING HIM A HARD TIME ABOUT SOME OF THE ISSUES OVER THE PAST FEW WEEKS, BUT THEY'VE BEEN RECEPTIVE, HELPFUL, SUPPORTIVE AND AT THE TABLE EVEN THOUGH THAT WE KNOW THE TRAFFIC IMPLICATIONS ARE MINIMAL. THEY'VE BEEN VERY RECEPTIVE AND WORKING TO -- WORKING WITH US AND STAFF TO HELP ADVANCE THE INFRASTRUCTURE PROJECTS WE'VE BEEN WORKING ON FOR BANK STREET

OR ARMSTRONG AND THE OTHER ONES. I KNOW THEY'VE SENT A LETTER OF COMMITMENT, AS WELL, TO REFLECT THAT. I JUST WANT TO SAY THANK YOU TO THEM FOR BEING AT THE TABLE AND BEING GOOD CORPORATE CITIZENS. THANK YOU, MAYOR. >> OKAY. COUNCILLOR TAYLOR, PLEASE. >> THANK YOU VERY MUCH, MR. MAYOR. I WANT TO START BY SAYING I'M A PROUD MEMBER OF THE BOARD OF HEALTH. AND AT THE BOARD, I SPOKE ABOUT THE IMPORTANCE OF SUPPORTING THE HEALTH UNIT'S PLAN TO PROBLEM GAMBLING AND INCREASING THE FOOTPRINT OF COMMUNITY EDUCATION. ACTING ON COUNCILLOR EGLI'S PRESENTATION, I WAS PLEASED TO MOVE A MOTION THAT EXPANDED THE OPPORTUNITY FOR OPH TO PURSUE FURTHER FUNDING FROM THE PROVINCE TO ADDRESS GAMBLING. WHILE I UNDERSTAND WHERE COUNCILLOR NUSSBAUM'S MOTION IS COMING FROM, I DON'T SUT IT AND THE COUNCILLOR TRANSMITTERED WHY. COUNCIL CAN DECIDE TO ALLOCATE FUNDING FOR ANY PROGRAMME WE WANT. WE DON'T NEED A MOTION TODAY TO SIGNAL TO A FUTURE COUNCIL THAT WE CAN DO THAT. WHAT A MOTION TODAY, IF APPROVED, WOULD SIGNAL IS IT WOULD SIGNAL TO THE PROVINCE THAT WE'RE WILLING TO STEP UP AND FUND, WHICH MEANS THAT THEY, IN TURN, CAN RESPOND TO OUR LETTER AND SAY, IF YOU'RE WILLING TO STEP UP AND FUND IT, WHY WOULD WE?THAT'S A CLEAR SIGNAL TO THE PROVINCE THAT THEY'RE OFF THE HOOK. SO WHY WOULD WE SEND THAT SIGNAL? AS THE COUNCILLOR ARTICULATED, THIS IS THE THIN EDGE OF THE WEDGE WHY WE LET THE PROVINCE OFF THE HOOK FOR FUNDING. YOU KNOW, WHILE I'M NOT A FAN OF GAMBLING, THE DISCUSSION AT THE BOARD OF HEALTH WAS QUITE INTERESTING AND BECAME VERY CLEAR THAT THE REAL EXPANSION IN GAMBLING WAS TAKING PLACE ONLINE, NOT ON THE GROUND AND THE LARGEST SHARE OF IT WAS A GREY MARKET AND TRYING TO CAP OR CONSTRAIN TODAY WHAT HAPPENS AT THIS SITE IS IN MANY RESPECTS A SMALL PART OF THE PUZZLE. SEEING THE GAMBLING OR NOT SEEING THE GAMBLING IS NOT A MEASURE OF WHETHER THE GAMBLING IS TAKING PLACE. THAT MEASUREMENT IS ONE THAT WE'RE GOING TO HAVE TO RELY ON OPH FOR, USING EVIDENCE, AND ONE THAT THE BOARD OF HEALTH -- WE HEARD AT THE BOARD OF HEALTH THAT THE O.L.G. IS COMMITTED TO HELPING INFORM OUR HEALTH UNIT WITH DATA THAT THEY COLLECT. SO IN SOME, YOU KNOW, AS BOARD OF HEALTH MEMBER, THERE ARE A LOT OF THINGS THAT I BELIEVE OUR COMMUNITY WOULD BE BETTER OFF IF NOBODY PAR TOOK OF. THAT INCLUDES SMOKING. IT INCLUDES DRINKING AND GAMBLING AND SUBSTANCE MISUSE. BUT OPH

HAS BROUGHT FORWARD, I BELIEVE, A RESPONSIBLE STRATEGY TO SAY, RECOGNIZING THAT PEOPLE WILL ENGAGE IN SOME OF THESE BEHAVIOURS, WE'RE GOING TO WORK TO TRY TO CONSTRAIN THE HARM, PROMOTE EDUCATION AND I BELIEVE THAT'S A SOUND RECOMMENDATION AND A SOUND PATH FORWARD. I THINK TO SOME EXTENT WHILE NOT BEING DISMISSIVE OF THE IMPORTANT DEBATE AROUND THE AMOUNT OF GAMING THAT WOULD TAKE PLACE AT THIS FACILITY, I THINK IT IS IS A LOSS LEADER IF WE WANT TO HAVE A FURTHER CONVERSATION ABOUT GAMBLING AND THE PROGRESS WE'RE MAKING ON PROBLEM GAMBLING IN OUR COMMUNITY, I'D SUGGEST THAT WE CONTINUE TO ENGAGE THE HEALTH UNIT OVER THE YEARS TO COME AND WORK WITH THEM TO TRY TO ENSURE THAT WHILE THIS DOES TAKE PLACE IN OUR COMMUNITY, IT'S NEGATIVELY AFFECTING AS FEW PEOPLE AS POSSIBLE. THANK YOU, MR. MAYOR. >> THANK YOU. THANK YOU, COUNCILLOR, COUNCILLOR BROCKINGTON, PLEASE, >> THANK YOU. YOUR WORSHIP. GOOD MORNING. FIRST THE MATTER BEFORE US, JUST ON THE PLANNING RATIONALE, THIS IS A PLANNING DECISION WE'RE TRYING TO HAVE A CONVERSATION ON TODAY. I THOUGHT I'D START OFF ON THE PLANNING POINT. I DO BELIEVE THIS IS AN APPROPRIATE PLANNING USE FOR THE SITE AND FOR WHAT'S BEING PROPOSED. WHEN YOU LOOK AT, YOU KNOW, FURTHER DEFINING A CASINO, ADDING A HOTEL, 55 GAMING TABLES, NOT MENTIONED IN PART 1 BUT ALSO THE ENTERTAINMENT VENUE, A THEATRE, I THINK IF YOU'RE GOING TO EXPAND THE OPTIONS WITH A SORT OF HIGH-QUALITY PROVIDER AND THIS IS SORT OF THE BUNDLED PACKAGE THAT THEY WOULD LIKE TO OFFER HERE WITHIN THE CITY, THAT THIS IS SOMETHING I CAN SUPPORT. CERTAINLY WITH EXPANDED CASINO OPTIONS, A GREATER SUSTAINABILITY FOR HORSE RACING INDUSTRY, BETTER ENTERTAINMENT VALUE -- VENUE AND VALUE, THE HOTEL AND FOR PEOPLE WHO WISH TO GAMBLING AND ARE LEAVING OUR PROVINCE NOW, THEY'RE GOING ACROSS THE RIVER. THEY MIGHT EVEN BE GOING TO VEGAS OR ATLANTIC CITY. IF YOU OFFER A HIGH-QUALITY PRODUCT, WE CAN KEEP MONEY IN OUR OWN PROVINCE AND IN OUR OWN CITY. THERE'S SOME BENEFIT TO THAT. I CERTAINLY RECOGNIZE THAT THERE ARE PROBLEM GAMBLERS AND THERE IS A PLAN TO ADDRESS THAT. BUT, YOU KNOW, GAMBLING IS NOT THE ONLY AREA WHERE PEOPLE HAVE PROBLEMS. WE HAVE LCBOS THAT OPEN UP IN THIS CITY AND WE DON'T HAVE A DEBATE ON THE FLOOR SIZE OF AN LCBO OR HOW MANY BOTTLES CAN THEY SELL AND CAPPING THE NUMBER OF OPTIONS THEY THAT CAN PROVIDE THEIR

CUSTOMERS. SO WE HAVE PROBLEM DRINKERS, GAMBLERS AND OTHER COMPONENTS IN THE CITY, AND, YOU KNOW, I THINK IT'S A FAIR CONVERSATION TO HAVE ABOUT GAMBLING AND HOW HEALTH AND THE PROVINCE HAVE RESPONSIBILITIES TO ADDRESS THAT. BUT, AGAIN, ON THE PLANNING ARGUMENTS, I'M FAIRLY SUPPORTIVE OF THIS TODAY. GAMBLING HAS BEEN AROUND SINCE FIRE. IT'S ALWAYS A PART OF OUR SOCIETY. WHETHER THERE'S A CASINO OR NOT, PUBLIC HEALTH WILL ALWAYS HAVE A RESPONSIBILITY TO ADDRESS SOME OF THE CONCERNS THAT EXIST. MR. MAYOR, THROUGH YOU TO STAFF, I HAVE SOME QUESTIONS ABOUT THE ACTUAL MOTION THAT'S BEFORE US. PART 3 TALKS ABOUT BASICALLY A PARTNERSHIP BETWEEN ALL PARTIES, PARTICULARLY LOOKING AT SOME TRANSPORTATION OPTIONS, PRIVATE DRIVEWAY FROM BANK, FRONT-ENING A PORTION OF ARMSTRONG TO BANK STREET, WORKING WITH THE DEVELOPERS WITH RESPECT TO LEITRIM. CAN I JUST HAVE SOME MORE INFORMATION HOW -- THESE ARE SOME PRETTY SIGNIFICANT OPTIONS THAT ARE BEING CONSIDERED TO PLAYOFF TRAFFIC FLOW. HOW EXACTLY ARE THESE CONVERSATIONS GOING TO EVOLVE? WHERE DID THE RESULTS OF THOSE CONVERSATIONS GET REPORTED OUT OF?WHAT ARE THE TYPES OF TIMELINES WE'RE WORKING WITH?>> MR. MAYOR, A LOT OF THESE ISSUES OUTLINED IN ITEM NUMBER 3 RELATE TO MATTERS OF SITE DESIGN WHICH WILL BE A SUBSEQUENT STEP ONCE THE ZONING IS IN PLACE. WE WILL BE ENTERING BOO AN AGREEMENT FOR THE APPLICATION AND MANY OF THESE MATTERS COULD BE ADDRESSED THERE. WE'D BE IN A POSITION AT THAT POINT TO PROVIDE FURTHER INFORMATION ON HOW THESE MATTERS WERE RESOLVED. THERE ARE ALSO MATTERS RELATED TO FRONT-END AGREEMENTS THAT WOULD COME BACK BEFORE PLANNING COMMITTEE AS WELL. >> SITE PLANS USUALLY ROLL OR EVOLVE FAIRLY QUICKLY AFTER ZONING'S BEEN APPROVED. AGAIN, THIS IS DEVELOPMENT THAT WILL BE MORE THAN ONE PHASE. I NOTICED THAT THE NEXT PART OF THE MOTION TALKS ABOUT ANOTHER STUDY FOR ALBION STARTING NEXT YEAR. THAT COULD BE YEAR LONG. IS THAT ALL CONGRUENT WITH ONE ANOTHER. WHAT ARE THE EXPECTED TIMELINES FOR THE SITE PLAN?>> MR. MAYOR, I CAN ANSWER, MR. SMITH MIGHT HAVE MORE PRECISE INFORMATION, THIS IS GOING TO BE VERY MUCH OVER THE NEXT A COUPLE OF MONTHS, INTO THE NEXT YEAR, TO ADDRESS MANY OF THESE MATTERS. THE AREA TRANSPORTATION STUDY CAN INITIATE ON ITS OWN. IT'S NOT TIED QUITE THE SAME TO THE OTHER MATTERS. BUT THE OTHER MATTERS WOULD BE

ADDRESSED AS WE EVOLVE THROUGH THE SITE PLAN PROCESS. >> ALBION ROAD. CERTAINLY NO STRANGER TO THIS COUNCIL. A ROAD THAT'S BEEN STUDIED AND SOME COLOURFUL CONVERSATIONS BETWEEN COUNCIL COLLEAGUES, PAST AND PRESENT, IN THIS EXACT AREA. WHAT ARE WE EXPECTING THIS STUDY TO STUDY?THAT HASN'T ALREADY BEEN STUDIED?WHAT IS THE EXPECTED OUTCOME?>> MR. MAYOR, I THINK IT'S PREMATURE BECAUSE WE HAVEN'T COMMISSIONED THE WORK YET. WE'RE LOOKING AT FURTHER IMPROVEMENTS TO MANAGE TRAFFIC SAFETY AT THAT INTERSECTION. WE'LL BE LOOKING AT INTERMISSION CONFIGURATION MATTERS PRIMARILY THROUGH THIS WORK. I THINK AT THIS STAGE. THAT'S IS IT EXTENT -->> AM I READING THE SUBSEQUENT PARTS OF THE THIS MOTION CORRECT, THAT WE'RE GOING TO ALLOCATE \$150,000 FOR THIS STUDY. WE'RE TALKING ABOUT THE STUDY, NOT MODIFICATIONS TO THE INTERSECTION. SO WHAT IS THE OBJECTIVE OF THE STUDY IN ARE WE CONCERNED THERE'S GOING TO BE AN OVERFLOW OF TRAFFIC ON ALBION AND WE WANT THE STUDY TO TALK ABOUT OPTIONS TO HELP MITIGATE THAT?OR IS THERE SOME OTHER ISSUES I'M NOT AWARE OF?>> MR. MAYOR. IN THE PREVIOUS TERM OF COUNCIL, COUNCIL HAD DIRECTED THAT THERE BE AN AREA TRAFFIC MANAGEMENT PLAN FOR THIS AREA WITH THE EXPIRY OF THE TERM OF COUNCIL AND THE PROJECT NOT BEING COMPLETED, THE MONEY LAPSED. WHAT THIS MOTION IS DOES IS REINSTATE THE MONEY PREVIOUSLY DECIDED BY COUNCIL TO EXAMINE THE BROADER TRAFFIC ISSUES A THIS INTERSECTION, WHICH ARE NOT DIRECTLY RELATED TO THIS APPLICATION BUT OF INTEREST IN CONSIDERATION OF THIS APPLICATION AND THE ADDITIONAL MONEY REFLECTS THE FACT THAT THE COST OF THESE STUDIES HAVE GONE UP IN THE LAST FIVE, SIX YEARS. SO WE DO NEED ADDITIONAL FUNDS IN ORDER TO COMPLETE IT. >> WILL THAT STUDY LOOK AT ANY OTHER STREET OTHER THAN ALBION ROAD?OR IS IT JUST SPECIFIC TO ALBION?>> MR. MAYOR. THAT'S CORRECT. WE LOOK AT GENERALLY IN THE AREA OF ALL THE STREETS COMING INTO INTO THE IMMEDIATE STUDY AREA. >> GOOD. THANK YOU VERY MUCH. >> GREAT. THANK YOU. THANK YOU FOR TALKING ABOUT THE ZONING APPLICATION. I APPRECIATE THAT. OUR NEXT SPEAKER IS COUNCILLOR EL-CHANTIRY. >> THANK YOU, MR. MAYOR. I DON'T HAVE A QUESTION, PER SE. I JUST HAVE A COMMENT, MR. MAYOR. I FIND IT [ INAUDIBLE ISOME OF MY COLLEAGUE TRY TO DEBATE THE MOTIONS AS LONG AS THEY CAN AND WHEN IT'S TIME TO VOTE AGAINST ITEM ITSELF. MAYBE WE NEED TO LOOK AT SOME OF THESE PRACTICES AND SEE IF THERE'S A

BETTER WAY TO DO THIS. FOR SOME OF PEOPLE LISTENING TO US, I HEAR TIME AND TIME AGAIN, I DON'T GAMBLE, I DON'T GO THERE. WELL, I GO TO THE CASINO. I SUPPORT THEM. I SUPPORT THE HORSE RACING IN MY COMMUNITY BECAUSE A LOT OF THOSE PEOPLE ARE FROM MY COMMUNITY. I LOVE THEIR FOOD. I LOVE THEIR HOSPITALITY. I THINK EVERYONE SHOULD TRY THAT EXPERIENCE. LET'S STOP BEING A NANNY STATE, PLEASE. THANK YOU, MR. MAYOR. >> COUNCILLOR MOFFATT. >> THANK YOU. FIRST, I WANT TO START BY THANKING EVERYONE AROUND THE TABLE. PREVIOUS TERM, THIS TERM, WE'VE COME A LONG WAY ON THIS. THE REALITY IS WE SAT HERE ALMOST SIX YEARS AGO AT THIS TABLE AND LISTENED TO THE O.L.G. SELL US WHAT WAS AT THAT TIME A BILL OF GOODS ON WHAT THIS PLAN WAS AND WHAT THIS MEANT FOR THE CITY. THERE WAS A LOT OF CONCERN. I FOUND MYSELF ON THE WRONG END OF A VOTE AT CITY COUNCIL AT THAT TIME AND I WAS PLEASED TO BE ABLE TO FOLLOW THAT AND WORK WITH THOSE AROUND THIS TABLE, WORK WITH THE CITY, WORK REQUEST THE O.L.G.THE O.L.G. HAS EVOLVED OVER THE LAST SIX YEARS WITH NEW LEADERSHIP. THE PREVIOUS LEADERSHIP IS FOR SOME REASON RUNNING FOR PROVINCIAL PARLIAMENT, ANYWAYS, I WON'T GO THERE, I THINK THE POINT HERE IS THAT THE O.L.G. HAS SEEN THE IMPORTANCE OF THESE FACILITIES ACROSS ONTARIO, YOU KNOW, PUTTING --[ INAUDIBLE ]IN PLACE, SENIOR VICE-PRESIDENT OF HORSE RACING. THEY SEE THE VALUE OF THESE FACILITIES IN RURAL ONTARIO. THE COUNCIL'S DECISION IN 2013 TO RECOGNIZE THE RIDEAU CARLETON RACEWAY AS THE PREFERRED SITE WAS THE RIGHT DECISION TO MOVE FORWARD. NOW SEEING HARD ROCK BE A PASSPORT IS A POSITIVE STEP FOR THE CITY. LOOKING AT CERTAIN THINGS. WE'RE TALKING ABOUT CAPS. THE O.L.G. SET OUT CAPS IN THEIR GAMING ZONES THROUGH THE MODERNIZATION PLAN BACK IN 2012 THROUGH THEIR REQUEST FOR PREQUALIFICATIONS. THAT REPORT SPECIFICALLY SPOKE UP TO 2.000 SLOTS. 600 GAMING POSITIONS. WE AREN'T LOOKING AT ZONING FOR 600 GAMING POSITIONS. WE'RE LOOKING AT ZONING FOR 55 TABLES BECAUSE THAT'S THE APPLICATION BEFORE US. IT'S A PLANNING APPLICATION THAT SEEKS 55 TABLES. IF WE'RE GOING TO CONSIDER LOOKING AT ZONING TO ALIGN OURSELVES WITH PROVINCIAL REQUIREMENTS FROM THE O.L.G., THEN WE SHOULD LOOK ACROSS THE BOARD. IT SHOULD BE 2600. THEN THE APPLICANT DOESN'T HAVE TO COME FORWARD TO INCREASE TABLES. THEY DON'T HAVE TO COME FORWARD. WE'VE ALREADY ADOPTED THE PROVINCIAL REQUIREMENTS. I DON'T THINK WE SHOULD DO THAT. I THINK WE SHOULD

LEAVE IT UP TO THE O.L.G. TO SET THOSE LIMITS. IN 2011, WE STARTED THE PROCESS BY ZONING FOR TABLES. YOU KNOW, IN HIND SERGEANT, I DON'T THINK THAT WAS THE RIGHT CHOICE. I THINK WE SHOULD LEAVE THE MINIMUM REQUIREMENTS TO THE O.L.G.WE DIDN'T DO THAT ON TABLES. I DON'T THINK WE SHOULD DO THAT, THOUGH, ON -- I DON'T THINK WE SHOULD BE ZONING FOR SLOTS. A SLOT CAP IS THERE IN THE RFPQ. I BELIEVE IT WAS WAS ALSO IN THE RFP. THEY COMMITTED TO THAT 2,000 SLOT CAP. I THINK THERE'S A LOT OF POSITIVES HERE IN WHAT WE'RE DOING GOING FORWARD. I THINK THE SITE PLAN -- THE COOPERATION BETWEEN THE COUNCILLORS IN WORKING IN THE NEIGHBOURHOOD ON WHAT THE IMPACTS OF THIS. WE ALL KNOW THERE ARE OTHER IMPACTS IN THE COMMUNITY. THOSE ROADS -- THE CASINO ISN'T GOING TO INCREASE SUBSTANTIAL TRAFFIC ON THOSE ROADS. THE PROBLEM EXISTS TODAY. HAVING THOSE COUNCILLORS WORK TOGETHER IS A POSITIVE STEP. THANK YOU TO COUNCILLOR DAROUZE FOR BEING A PART OF THAT. I APPRECIATE YOUR PRESENCE AND YOUR COMMENTS ON THIS APPLICATION. I WANT TO THANK EVERYONE INVOLVED. THE O.L.G., RCR, HARD ROCK, THE COMMUNITY, YOU KNOW, HE WAS HERE LAST WEEK AT COMMITTEE REPRESENTING THE HORSE PEOPLE, AS HE CALLS THEM. THE POSITION THEY WERE IN BACK IN 2012 AND 2013, THE POSITION OF UNCERTAINTY THAT HURT THEIR BUSINESS, THIS PROVIDED THEM SOME CERTAINTY AND I THINK IT'S IMPORTANT THAT WE SUPPORT THOSE GROUPS IN OUR CITY AND WE SUPPORT LOCAL BUSINESS. THE IMPACT OF THIS PROPERTY ON RURAL OTTAWA IN TERMS OF JOBS AND CERTAINTY IN OUR AREA IS SUCH AN IMPORTANT STEP THAT WE FELT SO FAR AWAY FROM SIX YEARS AGO. I REALLY WANT TO THANK YOU AND HAPPY TO SUPPORT THIS. I DON'T SUPPORT THE MOTIONS BROUGHT FORWARD TO COUNCILLOR QADRI'S POINT. THE CITY CAN WORK WITH THE PROVINCE, OPH CAN WORK THE PROVINCE ON HOW THAT CAN BE ADMINISTERED. MORE DOWNLOADING IS NOT NECESSARY. THANK YOU. >> RIGHT. THANK YOU. COUNCILLORS. YOU KNOW, COUNCILLOR MOFFATT REPRESENTS ME AT THE MINISTER'S CAUCUS -- O.L.G. MAYOR'S CAUCUS. I APPRECIATE ALL THOSE EXTRA MEETINGS. COUNCILLOR DAROUZE, PLEASE. >> THANK YOU, MAYOR. THANKS FOR MY COLLEAGUE AT CITY COUNCIL. I WANT -- I DON'T HAVE QUESTIONS BECAUSE I'VE BEEN ASKING LOTS OF QUESTIONS OVER THE LAST SIX MONTHS. I WOULD LIKE TO WRAP UP AND SAY A FEW WORD AND THANK SO MANY PEOPLE. I LOOK AROUND THE TABLE AND COUNCILLOR ALWAYS RESPONSIBLE TO BRINGING PROJECT AND TO BRINGING JOBS CREATION.

NOT ONLY IN RURAL OTTAWA, IN THE CITY. THIS FILE HAS BEEN ON THE TABLE SINCE 2013. I KNOW THE COUNCILLORS, SOME OF THEM, WORKED VERY HARD WITH O.L.G.BUT TWO YEARS AGO, THINGS CHANGED. O.L.G. AND HARD ROCK, THEY DECIDED ARE RIDEAU CARLETON TO CREATE A PARTNERSHIP AND THE VENUE CHANGED. WE STILL SITTING HERE AS A COUNCIL TALKING ABOUT GAMBLING AND WE'RE TALKING ABOUT PUBLIC HEALTH, WE'RE TALKING ABOUT ZONING, BUT, REALLY, ALL THESE ISSUES. THEY'RE GOOD AND THEY WORK TOGETHER BUT PEOPLE NEED TO LOOK AT THIS AS A CITY PROJECT. WE WORK ON LANSDOWNE, WE WORKED ON --[ INAUDIBLE |THERE WAS LOTS OF PEOPLE AGREED AND DISAGREED. NOW WE ENJOY THEM. I WANT TO TALK ABOUT RIDEAU CARLETON AS A DESTINATION. AND JOB CREATION. WE NEED TO TALK ABOUT THE -- THAT WILL CREATE 2500 SEATS AT THAT VENUE. WE'RE GOING TO HAVE SOME ARTISTS COMING AND ENTERTAIN THE CITY OF OTTAWA AND THE RESIDENTS IT'S BECOME TOURISM. WE KEEP TALKING ABOUT GAMBLING. COUNCILLOR BROCKINGTON MADE A GREAT POINT. RIGHT NOW THE CITY LOSE \$70 MILLION EVERY YEAR ACROSS THE BORDER. AND, YET, THE CITY OF OTTAWA AND THE PUBLIC HEALTH THAT EXISTS IN THE CITY OF OTTAWA, WE ARE HANDLING ALL THE GAMBLING ISSUE THAT WE HAVE RIGHT NOW. GAMBLING IS IN PEOPLE'S BEDROOM, PEOPLE'S BASEMENT, ON YOUR DEVICES, IN THE GAS STATION, EVERYWHERE YOU TURN AROUND. WE NEED TO TALK ABOUT THIS PROJECT AND LOOK AT THE SERIOUSNESS ABOUT IT AS JOB CREATION, WHAT'S GOING TO DO TO THE SOUTH END AND RESIDENTS AND HORSE RACING. I WANT TO THANK YOU, MR. MAYOR, FOR YOUR LEADERSHIP AND ALLOWING THE CONVERSATION GOING AND UNDERSTANDING THIS AS JOB CREATION ECONOMY FOR NOT ONLY THE OSGOODE WARD, IT'S FOR THE CITY. BECAUSE IT'S GOING TO HAVE 2,000 JOB. LOOK AROUND THIS TABLES AND MOST OF PEOPLE IN YOUR WARD GOING TO BE WORKING IN YOUR CASINO, NOT ONLY PEOPLE FROM OSGOODE WARD. WE HAD AN ISSUE AND WE HAD SOME -- WE GONNA TALK ABOUT, LITTLE BIT, THE TRAFFIC ISSUE AND SOME CHALLENGING HAVING WITH US. AROUND THE TABLE, COUNCILLOR QAQISH AND MYSELF AND COUNCILLOR DEANS TALKING ABOUT WHAT'S THE IMPACT IN THE COMMUNITY, ALSO, MY COMMUNITY, OSGOODE WARD ASSOCIATION, THE FINLEY CREEK RIVERSIDE SOUTH, ALL OF THEM CAME IN SUPPORT OF THIS. THEY UNDERSTAND THAT, YES, WE DO HAVE A CHALLENGE AND WE GONNA HAVE SOME TRAFFIC ISSUE. BUT WE WILL DEAL WITH THIS. THE STAFF WORKED VERY HARD WITH COUNCILLOR HARDER AND COUNCILLOR

MOFFATT ON ADDRESSING ALL OF THE ISSUE. TO ME, TODAY IS A HISTORICAL WIN. NOT ONLY FOR OSGOODE WARD BUT THE CITY OF OTTAWA. BECAUSE THIS IS A PROJECT THAT IT'S GOING TO BRING JOB, IT'S GOING TO BRING ECONOMY, IT'S GOING TO BRING A DESTINATION. I ENCOURAGE YOU TO SUPPORT THIS GOOD VENUE AND WELCOME THE GREAT PARTNERSHIP THAT WE'RE GOING TO HAVE WITH RIDEAU CARLETON AND HARD ROCK. RIDEAU CARLETON HAVE BEEN CONTRIBUTING TO OUR COMMUNITY SINCE 1962. THE WARREN FAMILY, AND I SEE ANDREW, THE GRANDSON -- THE SON OF LAW IN THE ROOM HERE. THEY'VE BEEN CONTRIBUTING TO EVERYTHING. THEY ALREADY ADDRESS THIS ISSUE. I THINK WE KNOW THAT -- I WANT TO THANK THEM FOR THEIR COLLABORATION AND WORKING WITH US. I WANT TO THANK ALL MY COLLEAGUE THAT THEY WORK VERY HARD ON THAT AND ESPECIALLY COUNCILLOR JAN HARDER FOR HER LEADERSHIP. MAYOR, WITHOUT YOUR LEADERSHIP. WE WOULDN'T BE HERE TODAY. THANK YOU VERY MUCH. >> DOES ANYONE ELSE WISH TO SPEAK TO THIS ITEM?NO. FIRST OF ALL, ON THE THREE MOTIONS, MOTION 1 BY COUNCILLORS HARDER AND MOFFATT, EECHO COUNCILLOR DAROUZE'S COMMENTS. THANK YOU FOR THE GOOD WORK. I'M GOING TO SUPPORT THAT FIRST MOTION. SECOND MOTION BY COUNCILLOR NUSSBAUM AND MCKENNEY, I'D URGE COUNCILLORS NOT TO SUPPORT THIS. WE JUST RECEIVED FROM THE HEALTH DEPARTMENT A RECOMMENDATION THAT INCREASED FUNDING COME FROM THE PROVINCE OF ONTARIO. THE INK ISN'T EVEN DRY ON THAT DOCUMENT THEN WE'RE UNDERMINING OUR POSITION SAYING, DON'T WORRY, WE'LL FUND IT. HE HIT THE NAIL ON THE HEAD. THIS IS A CLASSIC EXAMPLE, IF WE GO DOWN THIS PATH OF PROVINCIAL DOWNLOADING, GAMBLING AND O.L.G. IS 100% RESPONSIBILITY OF THE PROVINCE OF ONTARIO. THE PROVINCE HAS 100% RESPONSIBILITY OF THE PROBLEM GAMBLING STRATEGY AND FUNDING. I'M SOMEWHAT FAMILIAR WITH THIS BECAUSE I USED TO BE THE MINISTER IN CHARGE OF THAT FUNDING. SO THE REALITY IS THAT WE SHOULD NOT BE IN ESSENCE SUBSIDIZING THE PROVINCE OF ONTARIO. THEY GET THE BIGGEST CUT FROM THE CASINOS, AND, YET, WE'RE BEING NOW ASKED BY THIS MOTION TO TAKE A PORTION OF OUR FUNDING AND PUT INTO IT A PROVINCIAL PROGRAMME. YOU KNOW, IT'S THE SAME AS, YOU KNOW, WHY NOT SUPPORT THE OPERATING BUDGETS OF THE HOSPITALS OR TAKE OVER THE HIGHWAY SYSTEM?WE'D NEVER DO THAT IN A MILLION YEARS BECAUSE IT'S NOT OUR RESPONSIBILITY, YOU KNOW, REMEMBER WHAT HAPPENED WHEN THERE WAS DOWNLOADING OF A HIGHWAY, 174 AND WE'RE STILL SUFFERING THE

GREAT ISSUES WITH THAT PARTICULAR DOWNLOAD. SO I'D URGE YOU NOT TO VOTE FOR THE MOTION THAT BASICALLY IS SENDING IT OFF TO THE NEXT BUDGET. THAT'S THE EASY THING TO DO. PUSH IT OFF AND FEEL GOOD IF THE MOTION PASSES. SO I'D URGE YOU NOT TO SUPPORT THAT. AND SAME WITH COUNCILLOR MCKENNEY AND LEIPER'S MOTION WITH RESPECT TO THE CAPS. I THINK COUNCILLOR BROCKINGTON SAID IT RIGHT. YOU KNOW, WE CAN'T MICROMANAGE EVERY SINGLE PROJECT THAT COMES BEFORE US, NUMBER ONE. SECONDLY, AT THE END OF THE DAY, WE DON'T HAVE THAT RESPONSIBILITY. WE CAN BRING FORWARD ALL THE MOTIONS WE WANT AND A NUMBER OF MOTIONS I THINK WERE REALLY INTENDED TO TRY TO KILL THE PROJECT, YOU KNOW, HOURS OF OPERATION AND A.T.M. MACHINES, THIS, THAT, AND THE OTHER THING. IF YOU DON'T WANT A CASINO, DON'T KILL A DEATH OF A THOUSAND. THE EVIDENCE IS THIS IS GOING TO BE IN A SIGNIFICANT JOB CREATOR IN RURAL SOUTH OTTAWA. WE'VE TAKEN. AS A RESULT OF REPRESENTATIONS FROM MEMBERS OF THE PUBLIC AND MEMBERS OF THE COUNCIL, CONSIDERATION INTO DEALING WITH TRAFFIC ISSUES THAT ARE GOING TO BE A CHALLENGE, IF THE SITE IS SUCCESSFUL. THIS IS ABOUT THE ZONING TO ALLOW A HOTEL, BY THE WAY, DIDN'T EVEN HEAR THE WORD HOTEL IN THIS WHOLE DEBATE. IT'S GOING TO CREATE 3,000 CONSTRUCTION JOBS AND ALMOST 900 PERMANENT ONES IN RURAL SOUTH OTTAWA, UP FROM THE CURRENT 400 JOBS. AND WE KNOW THE IMPACT THAT THE SLOTS PROGRAMME THAT WAS BROUGHT IN ORIGINALLY, QUITE FRANKLY, TO HELP STABILIZE THE HORSE RACING INDUSTRY. AND WE ALL KNOW THAT WE HAVE A LARGE AGRICULTURAL COMMUNITY IN THE CITY OF OTTAWA. 82% OF OUR LANDMASS IS AGRICULTURE, RURAL, AND FOREST. SO I WOULD HOPE THAT MEMBERS OF COUNCIL RECOGNIZE THAT WE HAVE GAMBLING ALL AROUND US. WE'VE GOT -- YOU GO TO SENATORS' GAME, THERE'S A 50/50 DRAW. YOU GO TO CATHOLIC CHURCH ON WELLSTON STREET, THERE'S A SIGN UP THERE FOR BINGOS ONCE A WEEK, WE GOT INTERNET GAMBLING. YOU CAN ARGUE WHETHER YOU LIKE GAMBLING OR NOT. BUT THE REALITY IS IS THAT GAMING AND GAMBLING ARE BEFORE US. SO I WOULD URGE MEMBERS OF COUNCIL TO SUPPORT THE HARDER-MOFFATT MOTION, TO REJECT THE NUSSBAUM-MCKENNEY AND MCKENNEY-LEIPER MOTION AND VOTE FOR THE REPORT AS AMENDED. SINCE PARTICIPATING IN THE DEBATE AND AT TRANSPORTATION COMMITTEE, I'M VOTING IN FAVOUR OF THIS YEA AND THE REPORT. IT CAME TO MY ATTENTION, AND MANY OTHERS THROUGH SOME MEDIA REPORTS AND SOME INDIVIDUAL CONSTITUENTS WRITING, THAT THERE ARE WETLAND ISSUES AFFECTED BY THIS RECOMMENDED ROUTE. THAT DID NOT COME UP AT THE MEETING. IF I HAD BEEN AWARE I WOULD HAVE ASKED QUESTIONS THERE. I WOULD LIKE A BETTER UNDERSTANDING

OF WHAT WETLANDS ARE GOING TO BE AFFECTED BY THIS RECOMMENDED. ROUTE AND THE APPROACH THAT'S CURRENTLY BEING CONSIDERED FOR DEALING WITH BOTH ENVIRONMENTAL IMPACT AND ALSO COST AND INFRASTRUCTURE IMPACT OF BEING IN WETLAND. >>. >> YES, MR. MAYOR, I SAW THOSE REPORTS, AND I CAN TELL COUNCIL THAT THEY'RE NOT ACCURATE. WE'RE NOT PROPOSING TO BUILD THROUGH THE WETLANDS. I'LL ASK HER TO GIVE YOU A QUICK OVERVIEW OF THE SPECIFICS. BUT I CAN ASSURE YOU THAT WE ARE NOT. NOR WOULD WE OBVIOUSLY BUILD THROUGH WETLANDS. CAN YOU ELABORATE ON THE SPECIFICS. >> MR. MAYOR, THAT'S CORRECT. IT'S THE SEED MILL CREEK WATERSHED IN THE AREA. AND OUR FACILITY IS NOT IN THE FLOODPLAIN AT ALL. WE WOULD NEVER BUILD IN THE FLOODPLAIN. THERE IS A STUDY AROUND THIS AREA --THE WATERSHED STUDY AND IT WILL COME TO COMMITTEE NEXT YEAR. AND IT IS TAKING INTO ACCOUNT THE DEVELOPMENT IN THE AREA. AS WELL AS OUR LIGHT RAIL CORRIDOR. AND WE DID OUR WORK WITH THE TEAM THAT'S WORKING ON THAT WATERSHED STUDY, AS WELL AS THE NBCA. >> UM, WHAT, THEN, EXPLAINS I GUESS THE REPORTS OR THE MISUNDERSTANDING, IF THAT'S HOW YOU CHARACTERIZE IT THAT HAS BEEN BROUGHT TO OUR ATTENTION?>> YES, OUR REPORT SPEAKS TO THE ENVIRONMENTAL IMPLICATIONS, AND IN OUR PRESENTATION WE SAID THERE'S VERY MINOR ISSUES AND IF WE -- WE -- THROUGH THE DETAIL DESIGN IF THERE'S ANY IMPLICATION ON THE REMEDIAL AREA, WHICH IS OUTSIDE THE FLOODPLAIN, THAT WOULD BE ADDRESSED THROUGH THE DETAIL DESIGN AND, AGAIN, WE WOULD WORK THE CONSERVATION AUTHORITY ON THESE ISSUES.>> OKAY. SO TO BE CLEAR, YOU HAVE NOT RECEIVED ANY NOTICE OF CONCERN FROM ANY OF THE CONSERVATION AUTHORITIES, NOR DO YOU BELIEVE THERE'S ANY SIGNIFICANT RISK TO THE INFRASTRUCTURE FROM A MAJOR SAY 100-YEAR FLOOD?>> THAT'S CORRECT. THE REPORT OF THE STUDY, AND WE DEALT WITH THE ISSUE WITH THEM. THERE WERE NO CONCERNS RAISED. >> THANK YOU VERY MUCH. >> GREAT. THANK YOU. COUNCILLOR QADRI. PLEASE. >> THANK YOU VERY MUCH, MR. MAYOR. JUST A COUPLE OF QUESTIONS. FIRST OF ALL, IN TERMS OF THE -- YOU PROVIDED A MEMO TO US REGARDING THE RIDERSHIP ON THE LRT. COULD YOU JUST GIVE US A LITTLE BIT OF AN EXPLANATION FROM BEHIND THE SCENES AS TO WHAT THOSE NUMBERS ARE BASED ON. ARE THEY BASED ON CURRENT POPULATION?ARE THEY INCLUDING FUTURE POPULATIONS AS WELL AS THE RIDERSHIP?>> I'LL ASK HER TO GIVE YOU THE SPECIFICS. I'LL ASK HER TO BROADEN. ALSO THE

NUMBERS ON ALL-DAY RIDERSHIP. IN HINDSIGHT, THOSE ARE THE NUMBER WE SHOULD HAVE PROVIDED AND WILL INCLUDE IF YOU LIKE. >> OUR NUMBERS IN THE MEMO WERE BASED ON THE 2031 FORECAST FOR GROWTH IN KANATA AND STITTSVILLE. WE LOOKED AT THE PEAK PERIOD WHICH IS THE IMPORTANT FACTOR IN DETERMINING THE CAPACITY REQUIREMENTS. AND WE WERE ASKED TO LOOK AT THE UPLIFT BECAUSE OF THE LRT PROJECT VERSUS WHAT WE WOULD HAVE NORMALLY HAVE HAD IN THAT IN THE NEAR TERM. THAT'S THE NUMBER YOU RECEIVED WITH THE UPLIFT DURING THE PEAK PERIOD. NOW, WE ALSO TALKED ABOUT THE OVERALL 10,800 FORECASTED RIDERSHIP CROSSING THE GREEN BELT FOR THE PEAK PERIOD. BUT IF WE MULTIPLY THAT BY FOUR TO GET THE ALL-DAY RIDERSHIP. THAT WOULD COME OUT TO ABOUT 43,000.TODAY'S CURRENT RIDERSHIP IS CROSSING THE GREEN BUILT ALL DAY-RIDERSHI IS -- RIDERSHIP IS 23,000. >> THE NUMBER YOU JUST PRESENTED. THE 23.000, WHAT IS THAT MADE UP OF IN TERMS OF RIDERSHIPS COMING OUT OF WHAT AREAS OF THE CITY IN TERMS OF THE THE WEST END?>> THAT IS TO AND FROM KANATA, CROSSING THE GREEN BELT. SO IN BOTH DIRECTIONS, ALL-DAY TRIPS. >> OKAY. SO ACCORDING TO THE MEMO, THAT RIDERSHIP WILL GO UP BY ROUGHLY ABOUT, WHAT IS IT, 22, 2500 RIDERS, IF WE GO TO LRT OUT IN THE WEST?>> NO. THE 2200 IS JUST THE UPLIFT, THE DIFFERENTIAL BETWEEN THE TWO TYPES OF TECHNOLOGIES. WE WERE PLANNING TO BUILD THE BRT IN THE NEAR TERM AND LIGHT RAIL WAS IN THE ULTIMATE PLAN. THE CHANGE IN TECHNOLOGY WOULD PROVIDE 2200 IN THE MORNING PEAK PERIOD. IF WE WERE TO COMPARE THAT TO THE ALL-DAY, AGAIN YOU MULTIPLY THAT BY FOUR TO GET THE ALL-DAY. THAT'S THE INCREMENTAL DIFFERENCE PURELY BASED ON TECHNOLOGY. NOW, BY PROVIDING FAST AND RELIABLE TRANSIT YOU'RE GOING TO SEE FROM 23,000 TODAY TO 43,000 BY 2031 BECAUSE THAT'S OUR MODEL IN THAT TIME FRAME. >> THANK YOU, MR. MAYOR. >> THANK YOU. COUNCILLOR WILKINSON. PLEASE. >> JUST ON THAT. THAT MEANS YOU EXPECT A GOOD ALMOST DOUBLE THE TRANSIT RIDERSHIP WITH LIGHT RAIL FROM WHAT WE HAVE TODAY? IS THAT WHAT I'M HEARING THIS FROM YOU?IT SOUNDED LIKE THAT?>> BY PROVIDING A BETTER, RELIABLE SERVICE, YES, WE'RE FORECASTING THAT IT WOULD BE ALMOST DOUBLE. >> MR. MAYOR, THIS IS SOMETHING I'VE BEEN LEADING ABOUT, I GUESS, FOR QUITE A WHILE SEASON THAT THE ABILITY TO INCREASE RIDERSHIP IN TRANSIT IS THE GREATEST IN THIS AREA. FIRST BECAUSE WE DON'T HAVE A GOOD SYSTEM AT ALL RIGHT NOW. WHICH MEANS PEOPLE AREN'T USING IT.

THE FEW THAT HAVE TO DO IT BUT ONLY DO IT BECAUSE THEY ABSOLUTELY HAVE TO. THE RESULT OF THAT, OF COURSE, IS TRAFFIC IS INCREASING AND THE TRAFFIC OUT NOW, EVEN IN THE LAST YEAR HAS BECOME ALMOST IMPOSSIBLE. TALKING TO SOME OF THE BUSINESSES, THE TRAFFIC IS ACTUALLY IN THE MORNING RUSH HOUR IN KANATA BACKING UP ON THE QUEENSWAY ON MARSH ROAD BECAUSE THEY CAN'T GET THROUGH TO GET CARLING AVENUE IS SOLID BACK TO MOODIE AND TERRY FOX IS -- I DROVE BY IT THE OTHER DAY AT 9:15 IN THE MORNING WHEN YOU THINK MOST OF THE RUSH HOUR IS OVER, IT WENT BACK THREE KILOMETRES. GETTING THIS OUT HERE IS EXTREMELY IMPORTANT. I KNOW WE CAN'T BUILD LIGHT RAIL UNTIL YOU GET IT TO MOODIE. WE KNOW THE ROUGH ESTIMATE COST. TO GET TO KANATA AND PROCEED QUICKLY IS GETTING TO BE VERY, VERY ESSENTIAL. I THINK WE'VE RAISED THIS EARLIER ABOUT GETTING A COMMITTEE OF THE WEST END COUNCILLORS AND YOURSELF AND YOU WANTED TO WAIT UNTIL THE EA WAS FINISHED. I'M HOPING THIS IS DONE AND WE CAN START THOSE MEETINGS. THE BYLAW IS BEING REVIEWED NEXT YEAR AND A TRANSPORTATION MASTER PLAN AFTER THAT, WE KNOW IF THINGS AREN'T IN THOSE DOCUMENTS, THEY DON'T GET DONE. THE LIGHT RAIL PHASE TWO IS STARTING IMMEDIATELY ON THE COMPLETION OF PHASE ONE. I THINK WE HAVE TO LOOK FOR HOW WE CAN FIND AT LEAST OUR PORTION OF THE MONIES AND GO AFTER THE FEDERAL AND PROVINCIAL TO JOIN WITH US SO WE CAN DO THE SAME THING. SO IN 2023 WHEN LIGHT RAIL IS AT MOODIE WE CAN, THE NEXT YEAR, START ON THE NEXT PHASE WHICH -- HOW FAR WE CAN GET IT WITH THE MONEY WE CAN RAISE AT THAT POINT. ONE OF THE ADVANTAGES THROUGH KANATA ITSELF IS IT'S GRADE SEPARATED. PEDESTRIAN BRIDGE IS ALREADY GRADE SEPARATED. THERE AS MANY STRUCTURES THERE. THE RIDERSHIP WOULD HIT THE FIRST PART OF KANATA. THE FIRST PART IS ALMOST WHERE THE THREE DIFFERENT WARDS COME TOGETHER. SO WE CAN HAVE BUSES GOING OUT FROM THAT LOCATION. THAT WOULD SERVE A LARGE PART OF THE POPULATION. [ PLEASE STAND BY JBYLAW'S ONLY DONE EVERY FIVEYEARS.THAT WOULD BE -- THE NEXT TIMETHEY DID IT WOULD BE 2024, AYEAR AFTER MOODY'S.WE NEED TO BE THINKING FURTHERAHEAD THAN THAT.>> Mayor Jim Watson: OK.THANK YOU.COUNCILLOR LIEBER, PLEASE.>> THANK YOU, MAYOR.FAIRLY QUICKLY AS WE PUSH THETRAIN OUT FURTHER AND FURTHERWEST, I'M ENCOURAGED BY THE RIDERSHIP UPLIFT THAT YOU'VEDESCRIBED.IT IS CRITICAL WE GET MORE OFOUR SUBURBAN RIDERS ON MASSTRANSIT.ARE

THERE IMPLICATIONS FORSYSTEM CAPACITY OVERALL? I KNOW RESIDENTS MAY BECONCERNED ABOUT TRAINS THATARE FULL BY THE TIME THEY GETINSIDE THE GREENBELT.DO WE HAVE THE CAPACITY TOMANAGE A LOT MORE RIDERSCOMING FROM FURTHER ANDFURTHER AFIELD?>> MR.
