WHEREAS City staff have been monitoring the regulation of bike sharing internationally to gain a better understanding of both the business model and how other cities are adapting to an evolving industry; and

WHEREAS a holistic review of bike sharing and bike parking, and new regulatory tools, will be proposed in 2019 as part of the review of the City of Ottawa's Municipal Parking Management Strategy and Encroachment By-law; and

WHEREAS Cyclehop Canada has approached the City of Ottawa for a pilot program using their VeloGO bikes for the 2018 season ending November 15, 2018; and

WHEREAS VeloGO bikes have been operating on National Capital Commission (NCC) land and City of Gatineau lands since 2015; and

WHEREAS CycleHop will be responsible for installing/maintaining and removing bikes and stations; and

WHEREAS the potential locations of the sites shall be reviewed by Rightof-Way staff and circulated to relevant City departments for operational and technical approvals as well as the Ward Councillor;

THEREFORE BE IT RESOLVED that the Transportation Committee
recommend that Council waive the requirements of the Encroachment Bylaw (2003-446) to permit the Manager of Right of Way, Heritage and Urban
Design to enter into a pilot agreement(s) for 2018 to locate bike sharing
stations on City Rights-of-Ways and City property sites to ensure
compliance with the maintenance and liability provisions of the
Encroachment By-Law and subject to concurrence with Legal Services;
and
