BACKGROUND

[Protecting Our Community's Health: Ottawa Public Health's 2019-2022 Strategy](#) was approved by the Board of Health for the City of Ottawa in June of 2019. In December of 2019, the Board of Health received an [update](#) on progress made since the approval of the Strategy. At that meeting, the Board of Health made a request to receive quarterly updates on progress made towards the Strategic Plan. As such, the Board of Health will now receive quarterly updates as follows:

DISCUSSION

Ottawa Public Health continues to make progress with the implementation of the 2019-2022 Strategic Plan. In Q1 of 2020, OPH met three of its five strategic goals. Document 1 provides an overview of progress made as well as some key highlights and challenges for each of the five goals.

COVID-19 update

As a result of COVID-19 and the extensive response implemented by OPH to protect Ottawa's population, progress towards OPH's strategic goals and initiatives has been significantly impacted. It is important to note that strong advancements are being made consistent with our strategy and in other important areas of our core work such as case management, communications and surveillance.
