REPORT RECOMMENDATION

That the Community and Protective Services Committee recommend that Council receive this report for information and direct Community and Social Services Staff to work with Aboriginal partners to review the Truth and Reconciliation Commission's (TRC) Calls to Action, as outlined in this report, and report back to the Community and Protective Services Committee in Q1 2017 on options for action respecting any activities that may fall within the purview of the City of Ottawa.

Dr. Aaron Burry, General Manager Community and Social Services in his opening remarks spoke briefly on the work being done by City staff and the Aboriginal Working Committee since 2007. He then introduced those who would be assisting him in the PowerPoint presentation: Clara Freire, Manager, Client Service Strategies, Marc Maracle, Co-Chair of the Aboriginal Working Committee and Chair, Ottawa Aboriginal Coalition and Mary Daoust, Executive

Director of Minwaashin Lodge.

A copy of the presentation is held on file with the City Clerk's office.

It was noted by Marc Maracle that although the stated numbers of Aboriginal people in Ottawa is 18,000 the actual number is probably closer to 40,000. Mary Daoust commented that since 2007 strong relationships have developed with providers, the City and Aboriginal peoples and groups. The City of Ottawa is used as a benchmark.

Following the presentation, Committee members had a few questions dealing with:

- The amount of funds received from the Federal government and the hope that this would increase with the new government.
- The importance of housing and shelters and to ensure that this is high on the priority list.
- There were 94 recommendations made by the Truth and Reconciliation Commission, 14 dealing with government of which 5 deal with municipal issues. Aaron stated that the work has begun on these with Ottawa on the forefront but more needs to be done.

Chair Deans thanked staff and the presenters for the great work being done on this important issue.

The report recommendations were then put to Committee and CARRIED as presented.
