BACKGROUND

Every year, Ottawa Public Health (OPH) publishes an Annual Report to communicate about its work of promoting and protecting the community's health, thank community partners for their commitment to collaborating for improved health of Ottawa residents and visitors, and meet requirements under the *Ontario Public Health Organizational Standards* (OPHS). In addition to its duties and responsibilities under the *Health Protection and Promotion Act* (HPPA), the Board shall, at the request of the City, make an annual report to the City on the Board's operations, pursuant to the *City of Ottawa Act, 1999*, section 12(7). Further, in November 2016, City Council approved a recommendation requiring that annual reports from its local boards must be in writing and include the following: mandate, strategic directions, annual highlights and a financial statement.

OPH's 2020 Annual Report, attached as Document 1 (English version) and Document 2 (French version), fulfils the above-referenced requirements.

DISCUSSION

The Annual Report highlights some of OPH's key achievements of 2020 in protecting the health of Ottawa's community. The report includes:

- Examples of the work carried out according to OPH's mandate;
- An overview of OPH's strategic priorities;
- Financial data on OPH's sources of revenue and allocation of spending; and
- Recognition of the Board of Health's and the City of Ottawa's leadership, the contribution of partners, and the expertise of a diverse cross-section of OPH employees who work to support and protect the health of Ottawa's population.

The work highlighted in this report represents only a sampling of OPH's efforts to protect the health and well-being of Ottawa's population through prevention, promotion and protection.

OPH's work could not be possible without the efforts of its dedicated employees, volunteers, learners and the continued support of the Board of Health, partners, and the many individuals and organizations that contribute to the goal of a healthier, more equitable city for all.
