REMAIN STANDING. I'LL ASK COUNCILOR LIEPER TO INTRODUCE OUR VERY SPECIAL GUESTS HERE TO PERFORM OUR NATIONAL ANTHEM. >> THANK YOU MR. MAYOR AND COLLEAGUES. THIS MORNING IT IS MY DISTINCT PLEASURE TO INTRODUCE THE STUDENTS OF NOTRE DAME HIGH SCHOOL, WHICH IS ON BROADVIEW AVENUE IN KICHESIPPI. KICHESIPPI IS MUSIC'S HOME IN OTTAWA. WE ASKED FOR A CHOIR THIS MORNING AND THE SCHOOL OVERDELIVERED BY PROVIDING A NUMBER OF SMALL ENSEMBLES. I CAN'T WAIT TO HEAR THEM UNDER THE DIRECTION OF MR. BARRON AND MR. PETTY. IT'S NOW MY HONOUR TO INVITE KAY DUBE AND LIZ TUCKER FOR THIS COUNCIL'S CITY AWARD PRESENTATION. IF THEY WOULD LIKE TO COME FORWARD AND I'LL ASK COUNCILORS WILKINSON AND HUBLEY TO COME FORWARD. THEY'RE REPRESENTATIVES. [VOICE OF TRANSLATOR] I WOULD LIKE TO INVITE KAY DUBE AND LIZ TUCKER WITH THE COUNCILORS WILKINSON AND HUBLEY. >> FRIENDS OF KAY AND LIZ WHO ARE HERE TODAY, SOME FROM TRAVELLED FROM HOUSTON, TEXAS, AND OTHERS A LITTLE CLOSER AT HAND. OUR HONOURED GUESTS HAVE WORKED TIRELESSLY FOR THE KANATA SENIORS' COUNCIL AND HAVE BEEN INSTRUMENTAL IN MAINTAINING A HIGH QUALITY OF SERVICES AVAILABLE TO SENIORS IN THE COMMUNITY. KAY AND LIZ, I THINK SOMEONE SAID YOU'RE LIKE THELMA AND LOUISE OF KANATA. THAT WAS ME. I KNEW IT SOUNDED

FAMILIAR. KAY AND LIZ HAVE BEEN DEDICATED VOLUNTEERS ADVOCATING FOR SENIORS' NEEDS AND HELPING TO PROVIDE SERVICES AND PROGRAMS THAT GREATLY BENEFIT THE COMMUNITY. IT'S MY HONOUR TO ACKNOWLEDGE THEIR WORK AND CONTRIBUTION WITH THIS MEETING'S CITY BUILDER AWARD. THIS AWARD RECOGNIZES PEOPLE WHO HAVE DEMONSTRATED AN EXTRAORDINARY COMMITMENT TO MAKING OUR CITY A BETTER PLACE TODAY AND FOR THE FUTURE THROUGH OUTSTANDING VOLUNTEERISM OR EXEMPLARY ACTION. KAY BEGAN HER VOLUNTEER WORK AT THE KANATA'S SENIORS' CENTRE AS A VOLUNTEER KNITTER IN THE CRAFT ROOM BUT SOON BECAME CHAIR OF THE GROUP. SHE COORDINATES THE OPERATION OF THE GROUP WHICH INCLUDES SPONSORSHIP OF SENIOR SERVICES IN THE COMMUNITY, NOTABLY DONATING 10,000 DOLLARS TO THE LOCAL HOSPICE CARE OTTAWA FACILITY. KAY BECAME PRESIDENT OF THE KANATA SENIORS' COUNCIL LEADING THE BOARD THROUGH ITS OPERATIONS, COUNCIL CAFE, INSTRUCTIONAL COMPUTER TRAINING PROGRAM, TRAVEL TIPS AND OTHER SERVICES FOR SENIORS. SHE'S NOW PAST PRESIDENT OF THE BOARD AND CONTINUES TO BE A SHINING EXAMPLE OF SENIORS HELPING SENIORS. LIZ TUCKER BEGAN HER WORK AT THE KANATA SENIORS' CENTRE AS A FRIENDLY AND HELPFUL FRONT DESK RECEPTIONIST. SHE QUICKLY EXPANDED HER VOLUNTEER ROLE TO JOIN THE CENTRE'S SPECIAL EVENTS TEAM, WHERE SHE HELPED TO COORDINATE AND IMPLEMENT SPECIAL EVENTS FOR MEMBERS OF THE CENTRE. LIZ BECAME TREASURER OF THE KANATA SENIORS' COUNCIL IN 2010 AND ALSO STEPPED FORWARD TO IMPLEMENT THE ANNUAL SENIORS' GAMES PROGRAM WHICH WE'VE ALL HAD AN OPPORTUNITY TO PARTICIPATE IN. THE FAR WEST FUND FEST BEGAN IN MAY 2011 WITH 200 SENIORS PARTICIPATING IN MORE THAN 20 ACTIVITIES IN A TWO-WEEK PERIOD AND THE PROGRAM IS STILL GOING STRONG. YOU CAN WELL IMAGINE THE COORDINATION OF ALL OF THOSE SENIORS WITH THOSE PROGRAMS AND DIFFERENT LOCATIONS. OUTSIDE OF LIZ' INVOLVEMENT WITH SENIORS SHE'S STILL AN ACTIVE VOLUNTEER WITH THE FRIENDS OF THE LIBRARY BEAVERBROOK BRANCH, ASSISTING WITH FUND RAISING TO AUGMENT THE SERVICES AVAILABLE TO THE COMMUNITY. I WOULD LIKE TO TAKE THIS OPPORTUNITY TO SINCERELY THANK KAY AND LIZ FOR THEIR MANY, MANY YEARS OF CONTRIBUTION TO THE COMMUNITY, NOT JUST KANATA BUT THROUGHOUT THE CITY. [VOICE OF TRANSLATOR] I WOULD LIKE TO TAKE THIS OPPORTUNITY TO SINCERELY THANK KAY AND LIZ FOR THEIR MANY CONTRIBUTIONS TO THE COMMUNITY AND THE ENTIRE CITY. >>

WE ALSO FEEL THAT IT'S AN HONOUR TO THE KANATA CITY COUNCIL AS WELL. WE WORK IN TANDEM WITH THEM. WE HAVE BEEN AN INTEGRAL PART OF THE KANATA SENIOR COUNCIL FOR MANY YEARS. THE BEAVERBROOK LIBRARY LENDS SUPPORT. THE RETIREMENT RESIDENCES IN OUR AREA LEND SUPPORT. AND WE ALSO HAVE A HUGE GROUP OF VOLUNTEERS WHO ALSO MAKE THE WORK FOR US BECAUSE WE CERTAINLY COULDN'T DO IT WITHOUT THEM. WE HOPE TO KEEP DOING THIS FOR MANY YEARS. WE FEEL THAT IT IS A VALUABLE GIFT TO OUR SENIORS AND IT FULFILLS OUR MOTTO OF OUR KANATA COUNCIL WHICH IS SENIORS HELPING SENIORS. THANK YOU. [Applause]>> Mayor Watson: THANK YOU. COUNCILOR FLUERY, IF YOU WOULD LIKE TO INTRODUCE IT, PLEASE. >> THE MOTION IN FRONT OF US REALLY RELATES BACK TO SOME OF THE WORK OF COMMITTEE RELATING TO THOSE DIGITAL SIGNS. THERE'S BEEN, IN MY MIND, SOME CHALLENGES IN RESPECT TO THE APPLICABILITY OF THE BYLAW. SO WE'RE ASKING STAFF TO DO A BIT OF A REVIEW ON IT SO I'LL THEREFORE BE IT RESOLVED THAT STAFF BE DIRECTED TO REVIEW BYLAW 2016-326 AND REPORT BACK ON HOW THIS BYLAW REGULATES ILLUMINATED WINDOW SIGNS ALONG WITH THE RECOMMENDATIONS OF HOW BYLAW 2016-326 COULD BE AMENDED TO AUGMENT REGULATORY FRAMEWORK FOR THIS TYPE OF SIGNAGE BE. BE IT FURTHER RESOLVED THAT STAFF REPORT BACK TO PLANNING COMMITTEE ON DECEMBER 12th, 2017, WITH THE REVIEW AND RECOMMENDATION. MR. MAYOR, JUST TO CLARIFY, THIS IS THE SIGNS THAT WE WANT TO PROMOTE DIGITALIZATION OF SIGNS. WE'VE HAD ISSUES IN RELATION TO FLASHING OF THESE SIGNS AND ALSO THE AMOUNT OF ILLUMINATION THAT THEY'RE PUSHING ONTO THE SIDEWALK AND STREET.

AT COMMITTEE WHEN THIS HAS COME TO COMMITTEE THE PAST THREE TIMES WE'VE DISCUSSED THE LOT SIZE REQUIREMENT FOR IT AND WE HAD A MOTION FROM COUNCILOR EL CHANTIRY THAT WAS APPROVED AT COMMITTEE AND WE JUST NEED TO ALTER THE WORDING FOR THE REPORT TO REFLECT THAT MOTION. SO WHERE STAFF RECOMMENDS A REDUCTION IN THE MINIMUM REQUIREMENT OF LOT SIZE FROM .8 HECTARES TO .65 HECTARES WHEREAS OCTOBER 5TH, 2017, THE AGRICULTURE AFFAIRS COMMITTEE RECOMMENDED THE LOT SIZE FROM .65 HECTARES TO 0.4 HECTARES WHEREAS FURTHER AMENDMENTS TO CAPTURE WITHIN THE AMENDMENTS TO THE OFFICIAL PLANNING BYLAW. IN ADDITION TO THAT, I ALSO JUST WANTED TO -- ITEM 6. JUST TO AMEND ITEM 6 IN THE MOTION TO CHANGE THE REVIEW ON THE POLICY FROM FIVE YEARS TO THREE YEARS. SO I WOULD MOVE THAT SECONDED BY COUNCILOR HARDER, THE FIVE-YEAR REVIEW -- SINCE STAFF DIDN'T SUPPORT THE .4 HECTARE CHANGE, WE PUT IN THE MOTION THAT WE WOULD REVIEW IT AND SEE REVIEW THE IMPACTS OF THAT. FIVE YEARS WAS VERY ARBITRARY. THREE YEARS GETS US IN BEFORE THE NEXT OFFICIAL PLAN REVIEW SO THAT PROVIDES TIME FOR STAFF TO SEE THE IMPACTS OF THAT CHANGE. SO I JUST WOULD MOVE THAT AS WELL. WELL, I HAVE TO SAY BETWEEN COMMITTEE AND COUNCIL, I HAVE RECEIVED LOTS OF MESSAGES FROM THE PUBLIC WHO ARE REALLY KEEN ON MOVING FORWARD WITH THIS BECAUSE THAT HIGH PITCHED BACKUP BEEP IS DISTURB TO GO A LOT OF RESIDENTS, ESPECIALLY IN THE OVERNIGHT. BUT ONE OF MY CONSTITUENTS DID WRITE -- I THOUGHT MADE A REALLY GOOD POINT, WHICH WAS THIS WILL BE PRESUMABLY MOVED AHEAD WITH THIS AFTER THE PILOT -- THIS WILL BE A SIGNIFICANT CHANGE IN TONE FROM WHAT WE CURRENTLY HAVE, AND IT MAY BE THAT THE PUBLIC IS NOT AWARE OF THE URGENCY ASSOCIATED

WITH IT BECAUSE OF THE CHANGE OF TONE. SO I GUESS MY QUESTION TO STAFF IS: CAN STAFF CONFIRM THAT THEY'LL BE WORKING TO LAUNCH A CAMPAIGN TO INFORM RESIDENTS AND EMPLOYEES ABOUT THE CHANGES AND CAN STAFF CONFIRM THAT THIS CAMPAIGN WILL INCLUDE AUDIO SUCH AS TV OR RADIO COMMERCIALS SO THAT WE DON'T INADVERTENTLY CREATE AN UNSAFE SITUATION BY MAKING THIS CHANGE?>> THROUGH YOU, MR. MAYOR, YES, WE CAN CONFIRM WE'LL BE WORKING WITH COMMUNICATIONS WITH THE STRATEGY AROUND INFORMING THE PUBLIC AND OUR WORKERS AS WELL BECAUSE THEY'RE THE ONES IN THE YARDS WHERE THE BACKUP ALARMS ARE BASICALLY INTENDED TO PROTECT THEIR LIVES. >> THANK YOU. >> Mayor Watson: ANYONE ELSE ON THIS?ON THE ITEM. COUNCILOR QAQISH, PLEASE, SECONDED BY COUNCILOR TAYLOR. >> THAT ITEM 5 OF PLANNING COMMITTEE REPORT 50A AGRICULTURE AND RURAL AFFAIRS COMMITTEE REPORT 28, FINANCE AND ECONOMIC COMMITTEE REPORT 28, PLANNING COMMITTEE REPORT 51A AND 52, TRANSPORTATION COMMITTEE REPORT 27 AND THE REPORT FROM THE CITY CLERK AND SOLICITOR'S OFFICE ENTITLED "SUMMARY OF ORAL AND WRITTEN PUBLIC SUBMISSIONS FOR ITEMS SUBJECT TO BILL 73, EXPLANATION REQUIREMENTS AT CITY COUNCIL MEETING OF SEPTEMBER 27, 2017," BE RECEIVED AND ADOPTED AS AMENDED. >> Mayor Watson: ON THE MOTION?CARRIED. MOTION REQUIRING SUSPENSION OF THE RULES OF PROCEDURE. COUNCILOR EL CHANTIRY SECONDED BY COUNCILOR TAYLOR FOR A DEEP ROOTS FOOD HUB ROOTS CELLAR PROPOSAL. A TIMELINESS MATTER ON THIS. ON SUSPENSION?CARRIED. COUNCILOR EL CHANTIRY, PLEASE. >> THANK YOU, YOUR WORSHIP. MR. MAYOR, THERE'S QUITE A BIT OF HISTORY BEHIND THIS MOTION. WE ARRIVE TODAY AND JOKINGLY I WAS SPEAKING TO DEPUTY MAYOR TAYLOR AND I SAID, IRONICALLY WE CANNOT FIND A SUITABLE PLACE FOR THIS TO HAPPEN WITH THE TIME FRAME. SO WE END UP HAVING IT IN PART OF THE URBAN AREA, WHICH IS GREAT TO SHOW OUR CITY IS ALL ONE NOW, HELPING THE RURAL FARMER TO STORE THE ROOT VEGETABLES AND ALSO TO BE ABLE TO HELP PEOPLE WITH COST SAVINGS AND WE HAVE A FEW FOLKS WE WORK WITH THAT I WANT TO

ACKNOWLEDGE THERE'S A COUPLE OF VOLUNTEERS IN THE AUDIENCE SITTING HERE TODAY COME OUT OF THEIR WORK TO BE WITH US TO WITNESS THIS HISTORICAL DAY FOR THEM OBVIOUSLY. THEY'VE BEEN WAITING LONG ENOUGH. SO MR. MAYOR, WITHOUT GOING THROUGH ALL THE -- I WANT TO SAY THE OTTAWA COMMUNITY FOUNDATION GIVES A GRANT, \$123,000, ALSO FOR \$48,500 CAME FROM THE GREENBELT. ADDITIONALLY WE NEED 25,000 TO COMPLETE THIS PROJECT. THIS PROJECT HAS HAD THE SUPPORT OF THE OTTAWA COMMUNITY FOUNDATION, CENTRE TOWN COMMUNITY HEALTH CENTRE, THE GOOD FOOD BOX, OTTAWA PUBLIC HEALTH, TWO RIVERS FOOD HUB, CARTRIDGE ECO WELLNESS CENTRE, BOX COOPERATIVE FARMS LIMITED AND FAMILY HEALTH TEAM. AND IT HAS HOSTED ELEVEN FOOD-RELATED WORKSHOPS TO OVER 250 ATTENDANTS SO FAR HAS RECEIVED CONTRIBUTION VALUE AT MORE THAN \$33,000 AND WHEREAS RURAL AFFAIRS OFFICE AIM TO SUPPORT LOCAL INITIATIVE THAT DEMONSTRATED BENEFITS TO RURAL RESIDENTS IN OTTAWA FARMING COMMUNITY AND WHEREAS THE PROPOSED 38 SQUARE METRES CELLAR, WHICH WILL STORE UP TO 40,000 POUNDS OF FOOD, WILL SERVE AS AN IMPORTANT PILOT OPPORTUNITY TO VALIDATE THE NEW TECHNOLOGY THAT ENHANCED LOCAL FOOD ACCESS AND SECURITY IN OTTAWA. THEREFORE, BE IT RESOLVED THAT COUNCIL APPROVE A ONE-TIME CONTRIBUTION OF \$25,000 IN SUPPORT OF THE ROOT CELLAR PROJECT TO BE FUNDED FROM WITHIN THE RURAL AFFAIRS BUDGET. MR. MAYOR, THIS IS GOOD NEWS FOR ALL OF US AROUND AND I HOPE MY COLLEAGUES WILL SUPPORT THIS INITIATIVE. IT'S A SMALL CONTRIBUTION FROM US THAT, AS YOU CAN SEE, OTHER MAJOR FUNDING THIS PROJECT. IT'S RUN BY VOLUNTEERS AND WOULD GREATLY APPRECIATE THEIR EFFORT AND NOT GIVING UP BECAUSE IT TOOK SOME TIME TRYING TO FIND THE SUITABLE LOCATION BUT NOW WE FOUND IT IN COUNCILOR TAYLOR'S AREA AND WE'RE GRATEFUL COUNCILOR TAYLOR SUPPORTED THIS PROJECT AS WELL. THANK YOU, MR. MAYOR. >> Mayor Watson: GREAT, THANK YOU. APPARENTLY THE NOTIFICATION SYSTEM IS NOT WORKING, SO IF YOU'D LIKE TO SPEAK TO THIS ITEM, JUST WAVE. I BELIEVE COUNCILOR CHERNASHENKO, COUNCILOR BROCKINGTON. >> SEE IF THE MIC'S WORKING. I KNOW WE'RE AT RISK OF GOING OVERTIME TODAY SO I APOLOGIZE FOR DELAYING THIS MEETING. BUT I JUST WANT TO SPEAK BRIEFLY IN SUPPORT OF THIS. I THINK IT'S A GREAT INITIATIVE. I WAS AT THE COMMUNITY FOUNDATION EVENT WHERE THIS PROJECT WAS SELECTED AS ONE TO RECEIVE FUNDING AND I KNOW THEY'VE HAD DIFFICULTY IN FINDING

THE LOCATION NOT FOR LACK OF GOOD WILL OF EVERYONE AND COUNCILOR EL CHANTIRY IN PARTICULAR WORKING ON THIS, I THINK IT'S A GREAT EXAMPLE OF A FOOD SECURITY INITIATIVE THAT INVOLVES A LOT OF LOCAL GROUPS SO I'M SUPPORTING THIS. >> Mayor Watson: ANYONE ELSE WISH TO SPEAK? ON COUNCILOR EL CHANTIRY SECOND BY COUNCILOR TAYLOR'S MOTION, CARRIED. NEXT IS NOTICE OF THE MOTION FOR CONSIDERATION OF SUBSEQUENT MEETINGS. COUNCILOR EGLI. >> I'M WILLING TO BRIEFLY INTRODUCE THE NEW POLICY REGARDING PARKING IN PARTICULAR WHERE THEY BEGUN CHARGING FOR THE USE OF VISITOR PARKING SPOT. THIS CHANGE HAS LED TO A NUMBER OF COMPLAINTS IN MY OFFICE AS WELL AS OTHERS, I AM SURE. CITY STAFF HAS THUS FAR INDICATED THE CITY HAS NO SAY IN

REGULATING THIS SORT OF CHANGE. HOWEVER, IT'S RECENTLY COME TO MY ATTENTION THAT OTHER CITIES SUCH AS TORONTO HAVE PASSED A BYLAW TO DEAL WITH THIS SORT OF SITUATION. I WOULD LIKE STAFF TO REVIEW THE TORONTO EXPERIENCE AND ANY OTHER RELEVANT EXAMPLES THEY CAN FIND IN ONTARIO AND REPORT BACK TO COUNCIL AS TO WHAT THE OPTIONS -- WHAT POSITIONS THERE MAY BE GOING FORWARD TO ADDRESS THE SITUATION. IN PARTICULAR, I WOULD LIKE TO UNDERSTAND THE RATIONALE BEHIND WHY TORONTO BELIEVES IT HAS THE AUTHORITY TO BE INVOLVED IN THE REGULATION OF THIS TYPE OF PARKING CHANGE. >> Mayor Watson: ADJOURNMENT.
