Public comments touched upon, but were not limited to: excessive costs for a project with unproven benefits; inadequate water flow to justify such a project or, alternately, the potential for mosquito proliferation; safety concerns for children and others due to accumulated toxins and intrusion into an existing community; the potential destruction of an existing ecosystem and Federally-protected green space, confusion and a lack of clarity as to the reasons for which the project had been undertaken; a lack of consideration of alternative options, and; inadequate community notification, consultation and communication overall.

Staff explained the project's relationship to the Ottawa River Action Plan (ORAP) and Stage 2 Light Rail Transit (LRT) and the Committee also heard from Messrs. John Manconi, General Manager, Transportation Services Department (TSD) and Chris Swail, Director, O-Train Planning, TSD. Mr. Swail further explained that effective stormwater management was a key condition for National Capital Commission (NCC) approval for the LRT Stage 2 project to be allowed to proceed, as there is a need to remediate existing stormwater issues to improve stormwater management in the Pinecrest Creek Corridor and Pinecrest Creek.

Following Committee discussions, which touched upon points addressed by the delegations and in the staff presentation, the report recommendation was put
