REPORT RECOMMENDATIONS

That the Board of Health for the City of Ottawa Health Unit refer the following to Council, subject to the candidate providing a written acceptance of offer and proof of Fellowship from the Royal College of Physicians of Canada prior to June 22, 2017:

- 1. That Council recommend the appointment of Dr. Geneviève Cadieux as Associate Medical Officer of Health to the Minister of Health and Long-Term Care in accordance with the City of Ottawa Act, 1999 and the Health Protection and Promotion Act; and
- 2. Subject to approval of recommendation 1, that Council transmit its recommendation for approval of the appointment to the Minister of Health and Long-Term Care.

RECOMMANDATIONS DU RAPPORT

Que le Conseil de santé de la circonscription sanitaire de la ville d'Ottawa soumette ce qui suit au Conseil, à condition que la candidate présente avant le 22 juin 2017 une lettre d'acceptation de l'offre et une preuve qu'elle est une associée du Collège royal des médecins et chirurgiens du Canada :

- 1. Que le Conseil recommande la nomination de la D^r Geneviève Cadieux comme médecin adjoint en santé publique au ministre de la Santé et des Soins de longue durée conformément à la Loi de 1999 sur la ville d'Ottawa et à la Loi sur la protection et la promotion de la santé; et
- 2. Sous réserve de l'approbation de la recommandation nº 1, que le Conseil transmette au ministre de la Santé et des Soins de longue durée sa recommandation visant l'approbation de cette nomination.

BACKGROUND

Following a national recruitment campaign, Ottawa Public Health (OPH) has successfully recruited for an Associate Medical Officer of Health in order to fill a new temporary position, created as a result of internal realignment to meet the new Standards for Public Health Programs and Services.

Associate Medical Officers of Health, under the *Health Protection and Promotion Act* (*HPPA*), are empowered to write orders and have all of the statutory powers of the Medical Officer of Health.

This Associate Medical Officer of Health position is designated bilingual. This requires the candidate to be tested and meet a specific proficiency in English or French as a second language, in order to meet service delivery requirements. Dr. Cadieux's language proficiencies will enhance OPH's capacity to provide expert medical consultation in both official languages.

DISCUSSION

OPH has recruited Dr. Geneviève Cadieux, who will commence work with Ottawa Public Health on August 1, 2017. A licensed physician, Dr. Cadieux's residency in Public Health and Preventive Medicine was undertaken at the University of Toronto. She also has a PhD in epidemiology and is deeply committed to furthering evidence-based public health practice and evidence-informed policy.

City Council is required to officially recommend the qualified candidate to the Minister of Health and Long-Term Care. The Minister may then approve the proposed appointment under Section 64 of the *HPPA*.

Ontario Public Health Unit Medical Positions

There are 36 Health Units in Ontario falling under the jurisidiction of the Ministry of Health and Long-Term Care, many of which are experiencing challenges finding and appointing qualified Medical Officers of Health and Associate Medical Officers of Health.

RURAL IMPLICATIONS

There are no rural implications associated with this report.

CONSULTATION

The purpose of this report is administrative in nature and therefore no public consultation is required.

LEGAL IMPLICATIONS

There are no legal impediments to the implementation of the recommendations in this report.
