A BY-LAW TO PROVIDE FOR THE MAKING OF AN APPLICATION FOR APPROVAL TO EXPROPRIATE PROPERTY IN THE CITY OF OTTAWA, AS MORE PARTICULARLY DESCRIBED IN SCHEDULES 1A, 1B, 2A, 2B, 3A, 3B, 4A and 4B TO THIS BY-LAW.

WHEREAS the City of Ottawa requires the property described in Schedules1A and 1B hereto for the proposes of undertaking the widening and urbanization of Mer Bleue Road, between the Hydro One Corridor situated approximately 800m south of Innes Road and Renaud Road and other works and improvements ancillary thereto (the "Mer Bleue Road Widening Project");

AND WHEREAS the City of Ottawa requires the property described in Schedules 2A and 2B hereto for the proposes of undertaking the extension of Brian Coburn Boulevard between Navan Road and Mer Bleue Road and other works and improvements ancillary thereto (the "Brian Coburn Boulevard Project");

AND WHEREAS the City of Ottawa requires the property described in Schedules 3A and 3B hereto for the proposes of undertaking the widening and construction of Tenth Line Road between Southfield Road and the South Urban Boundary and other works and improvements ancillary thereto (the "**Tenth Line Road Project**");

AND WHEREAS the City of Ottawa requires the property described in Schedules 4A and 4B hereto for the proposes of undertaking the widening and renewal of Main Street between Echo Drive and the McIlraith Bridge and other works and improvements ancillary thereto (the "Main Street Widening Project");

AND WHEREAS pursuant to Section 6(1) of the *Municipal Act, 2001, S.O. 2001*, c. 25, as amended, the power of a municipality to acquire land under this or any other *Act* includes the power to expropriate land in accordance with the *Expropriations Act*, R.S.O. 1990, c.E.26, as amended (hereinafter referred to as the "*Expropriations Act*");

AND WHEREAS pursuant to Section 4 of the *Expropriations Act*, an expropriating authority, in this case, the City of Ottawa, shall not expropriate land without the approval of the approving authority, in this case, the Council of the City of Ottawa;

AND WHEREAS the City of Ottawa shall conduct expropriations in accordance with the *Expropriations Act*.

NOW THEREFORE THE COUNCIL OF THE CITY OF OTTAWA HEREBY ENACTS AS FOLLOWS:


- 1. THAT the Council of the City of Ottawa hereby approves the making of an application for approval to expropriate land by the City of Ottawa, in respect of property described in **Schedules 1A**, **1B**, **2A**, **2B**, **3A**, **3B**, **4A** and **4B**, appended hereto.
- THAT the Mayor, the City Clerk and the Director of the Real Estate Partnerships and Development Office or any one of them are hereby authorized to execute, on behalf of the City of Ottawa, an Application for Approval to Expropriate the property described in Schedules 1A, 1B, 2A, 2B, 3A, 3B, 4A and 4B appended hereto.
- 3. THAT the Mayor, the City Clerk and the Director of the Real Estate Partnerships and Development Office or any one of them are hereby authorized to execute, on behalf of the City of Ottawa, Notice of Application for Approval to Expropriate Land for the property described in **Schedules 1A, 1B, 2A, 2B, 3A, 3B, 4A** and **4B** appended hereto and that such Notice be served and published, as required by the *Expropriations Act*.
- 4. THAT, in the event an owner or registered owner requests a hearing of necessity, and a report of the inquiry officer is issued, the report of the inquiry officer shall come before Council of the City of Ottawa for consideration.
- 5. THAT the Officers and authorized agents of the City of Ottawa be and they are hereby otherwise authorized and directed to do all things required arising from the authorizations provided for by this By-law.
- 6. THAT this By-law comes into force on the day it is passed.




