BY-LAW NO. 2015 -

A by-law of the City of Ottawa to levy an annual tax upon colleges and universities for the year 2015.

WHEREAS pursuant to Section 323 (1) of the *Municipal Act*, 2001, S.O. 2001, c. 25, as amended, (the "Municipal Act, 2001"), the Council of a local municipality may by by-law levy upon a university designated by the Minister of Training, Colleges and Universities or a college of applied arts and technology, an annual tax not exceeding the prescribed amount for each full-time student enrolled in such university or college in the year preceding the year of levy, as determined by the Minister of Training, Colleges and Universities;

AND WHEREAS pursuant to Ontario Regulation 384/98, as amended, made under the Municipal Act, 2001, the prescribed amount for the purpose of Section 323 (1) of the Act is \$75.00 per full-time student, per year;

AND WHEREAS City Council has, in the past years, levied the maximum allowable amount on these institutions;

AND WHEREAS City Council considers it desirable to continue to levy the maximum allowable amount on these institutions;

AND WHEREAS the capacity of full-time student enrollment has been determined at:

- (a) Carleton University has 23,477 students;
- (b) University of Ottawa has 35,362 students;
- (c) St. Paul's University has 562 students:
- (d) Algonquin College of Applied Arts and Technology has 16,805 students;
- (e) Dominican's College of Philosophy and Theology has 83 students; and
- (f) La Cité Collégiale (CAAT) has 4,339 students.

THEREFORE the Council of the City of Ottawa enacts as follows:

- 1. There will be levied upon the Carleton University for 2015 a tax of \$75.00 for each of the 23,477 full-time students enrolled in the university, the annual tax levied being \$1,760,775.00.
- 2. There will be levied upon the University of Ottawa for 2015 a tax of \$75.00 for each of the 35,362 full-time students enrolled in the university, the annual tax levied being \$2,652,150.00.

- 3. There will be levied upon the St. Paul's University for 2015 a tax of \$75.00 for each of the 562 full-time students enrolled in the university, the annual tax levied being \$42,150.00.
- 4. There will be levied upon the Algonquin College of Applied Arts and Technology for 2015 a tax of \$75.00 for each of the estimated 16,805 full-time students enrolled in the college, the annual tax levied being \$1,260,375.00.
- 5. There will be levied upon the Dominican's College of Philosophy and Theology for 2015 a tax of \$75.00 for each of the 83 full-time students enrolled in the college, the annual tax levied being \$6,225.00.
- 6. There will be levied upon La Cité Collégiale (CAAT) for 2015 a tax of \$75.00 for each of the estimated 4,339 full-time students enrolled in the college, the annual tax levied being \$325,425.00.
- 7. The taxes levied under this by-law shall be paid to the City of Ottawa on or after July 1, 2015.
- 8. The taxes levied under this by-law are recovered in the same manner as municipal taxes are recovered and are a special lien on the lands of the universities and colleges pursuant to the provisions of section 349 of the Municipal Act, 2001.
