#### **BACKGROUND**

The current City of Ottawa membership of the Shaw Centre Board of Directors was approved at City Council on February 27, 2019 (<u>ACS2019-CCS-GEN-0023</u>). The two members' terms, being Debra Armstrong and Michael Crockatt, expired in November 2020. This report is seeking approval to extend these members to the end of the Term of Council in 2022.

The Selection Panel for the Shaw Centre Board of Directors is comprised of Councillors Jean Cloutier, Jenna Sudds, as well as Mathieu Gravel (on behalf of Mayor Jim Watson, *ex officio*).

At its meeting of February 26, 2020, City Council approved the appointment of Councillor George Darouze as the third City representative on the Shaw Centre Board of Directors for the remainder of the Term of Council.

#### DISCUSSION

In consultation with the Office of the City Clerk, the Selection Panel is recommending to the extension of appointments of the two (2) City of Ottawa members to the Shaw Centre Board of Directors as outlined in the Recommendation section of this report. The reappointment of these members, who have indicated their willingness to continue on the Board, would support the smooth functioning of the Board for the remainder of the term of Council.
