BACKGROUND

On September 14, 2016, Infrastructure Ontario informed the City of Ottawa that the City is eligible for approximately \$69.25 million through investments from both the Federal and Provincial governments – maximum federal allocation of \$46,169,042 and a maximum provincial allocation of \$23,084,521. The money will be provided through the federal Clean Water and Wastewater Fund (CWWF).

The CWWF will afford municipalities with infrastructure funding, starting in 2016-17, to help accelerate short-term investments to support the rehabilitation and modernization of drinking water, wastewater and stormwater infrastructure, as well as the planning and design of future facilities and upgrades to existing systems.

The deadline for submission is October 31, 2016.

DISCUSSION

The Federal and Provincial governments have recently announced the funding envelope for the CWWF. The City of Ottawa is eligible for approximately \$69.25 million through investments from both the Federal and Provincial governments – maximum federal allocation of \$46,169,042 (50 per cent) and a maximum provincial allocation of \$23,084,521 (25 per cent). With a contribution of \$23,084,521 (25 per cent) from the City of Ottawa the total investment could exceed \$92 million.

Municipality allocations under the CWWF are based on the amount of water, wastewater and stormwater assets owned by municipalities and their economic conditions.

Based on the criteria provided by Infrastructure Ontario, and outlined below, staff have developed a draft list of potentially eligible projects (Document 1).

Eligibility Requirements

Projects must be complete with all costs incurred prior to March 31, 2018. Where need is demonstrated, up to 25 per cent of the total amount of projects can extend beyond March 31, 2018. Extensions beyond March 31, 2018, require pre-approval by the Provincial and the Federal governments.

The projects identified for submission must be rehabilitation projects, new construction projects, optimization initiatives, or planning and design work.

The identified projects must show incrementality, which means the project must be one that would not have been completed without federal funding or the project would not have been undertaken before 2017 or 2018.

The recommendations documented in this report are consistent with the City's Comprehensive Asset Management (CAM) Program (<u>City of Ottawa Comprehensive</u> Asset Management Program) objectives.

Funded through investments from both the Federal and Provincial governments, the Clean Water and Wastewater fund (CWWF) provides the City of Ottawa with the opportunity to accelerate short –term investments to support the rehabilitation and modernization of drinking water, wastewater and stormwater infrastructure, including the planning and design of future projects.

This contribution, while advancing infrastructure investments, supports the delivery of services with the outward focus on community benefit and an inward focus on efficiency and affordability.

FINANCIAL IMPLICATIONS

Funding is available for the City's 25 per cent share of the projects identified in Document 1 of this report. The projects will be included in the 2017 Capital Budget, and those that are contingent on the approval of the Federal and Provincial funding will be identified.

ACCESSIBILITY IMPACTS

There are no accessibility impacts in this report.

ENVIRONMENTAL IMPLICATIONS

The CWWF will create a significant opportunity for the City of Ottawa to invest in key projects related to drinking water, wastewater and stormwater.

TERM OF COUNCIL PRIORITIES

This report aligns with Council's Priorities related to supporting an environmentally sustainable Ottawa and reducing long-term costs through planned investment and staging of diversion and conservation strategies.
