BACKGROUND

On February 24, 2010, Council approved the Ottawa River Action Plan (ORAP) which consists of 17 individual projects aimed at improving the health of the Ottawa River and protecting the health of Ottawa's water environment for future generations (<u>ACS2010-ICS-ESD-0007</u>, updated January 15, 2013 – <u>ACS2013-COS-ESD-0002</u>).

The Combined Sewage Storage Tunnel (CSST) is one of the key projects comprising the ORAP. As described in Report No. <u>ACS2013-PAI-INF-0002</u> detailing the results of the Class Environmental Assessment Study for the Combined Sewage Storage Tunnel, the CSST project will provide additional capacity to the City's sewer infrastructure to reduce the impact of major rainfalls on the Ottawa River and will involve the construction of two underground tunnels: one running east-west from LeBreton Flats to Stanley Park in New Edinburgh, generally running under Slater Street and Cumberland Street, and a second north-south tunnel running generally along Kent Street from Chamberlain Avenue to the Ottawa River.

In April 2015, the federal and provincial government announced joint funding for this project. Now that the detailed design is completed, the project tendering process has been initiated with contract award scheduled for early 2016.

The City must acquire from a number of property owners various property interests to support the construction, use, operation, maintenance and repair of the CSST. In order to meet construction timelines, the City requires the ability to acquire property interests by expropriation, if necessary.

The purpose of this report is to seek Council approval for the initiation of expropriation proceedings with respect to certain property interests required in connection with the CSST as more particularly described in the draft by-law attached hereto as Document 1.

DISCUSSION

The City must acquire from a number of property owners various property interests to support the construction, use, operation, maintenance and repair of the CSST. The property interests which are the subject of this Report are described in more detail in the draft by-law attached hereto as Document 1. All but a small number of these are subterranean tunnel segments or subterranean easements.

In accordance with section 4 of the *Expropriations Act*, R.S.O., 1990, c. E-26, as amended (the "*Expropriations Act*"), the City must apply to City Council, acting as the approval authority, to acquire land by expropriation.

Upon Council approval of the recommendations contained in this report, the City, as expropriating authority, can initiate expropriation procedures including the service and publication of statutory notices. A further report will be brought before Council prior to registration of Plans of Expropriation.

Notwithstanding the foregoing, and pursuant to the direction of the Infrastructure Services Department, Realty Services will contact property owners and, to the extent possible, pursue meaningful negotiations to acquire the required property interests and negotiate settlements with all affected property owners.

RURAL IMPLICATIONS

All requirements are within the Urban Boundary of the City of Ottawa. The acquisition of property required for the CSST project will not generate any rural implications.

Provided that the City follows procedures set out in the *Expropriation Act* and outlined in this report and the draft by-law attached hereto as Document 1, there are no legal impediments to implementing the recommendations set out in this report.

RISK MANAGEMENT IMPLICATIONS

Acquisition of the land requirements are required to complete the construction project. Failure to approve the expropriation may delay completion of the CSST project and could impact the City's ability to meet its contractual obligations under the CSST construction contract which is to be awarded in 2016.

FINANCIAL IMPLICATIONS

Funds for the expropriations are available within 905028 ORAP Combined Sewer Overflow Reduction.

ACCESSIBILITY IMPACTS

There are no accessibility impacts with regard to this report.
