## **BACKGROUND**

In response to a request by the Department of National Defense for amendments to the existing Branch No. 6 of the Dowdall Municipal Drain, Andy Robinson, P.Eng. of Robinson Consultants Inc. was appointed by the City of Ottawa on October 12, 2011, as the Engineer of record to prepare a report under Section 78 of the *Drainage Act*.

The purpose of the new engineer's report is to amend the existing report and By-law to enclose the drain through the Department of National Defense property (W. Pt Lot 6, Con 4, former Goulbourn Township).

To accommodate the enclosure of part of Branch No. 6 of the Dowdall Municipal Drain, amendments are required to the existing Engineers Report, entitled "Engineer's Report – Dowdall Municipal Drain – Modifications and Improvements" dated REV November 2010, by Robinson Consultants Inc. The required amendments are detailed in the Engineer's Report entitled "Amendment to the Engineer's Report for the Dowdall

Municipal Drain Branch No. 6 DND property", dated August 2015 and prepared by Robinson Consultants Inc. (the said report shall hereinafter be referred to as the "Engineer's Report dated August 2015").

The required on-site meeting with the Department of National Defense was held on June 14, 2011 and a further meeting was held with the affected landowners and regulatory agencies on July 11, 2012. All affected landowners were notified of the meeting.

## **DISCUSSION**

The Dowdall Municipal Drain is currently governed by the engineer's report entitled "Engineer's Report – Dowdall Municipal Drain – Modifications and Improvements" dated REV November 2010. The Engineer's Report dated August 2015 proposes the enclosure of a portion of the open drainage system for Branch No 6 with a pipe system and related appurtenances through the Department of National Defense secure compound area located in the west part of lot 6, concession 4, Rideau-Goulbourn Ward, former Goulbourn Township.

The proposed enclosure commences at a concrete headwall located at Station 6+480 along the current alignment of Branch No. 6 (as per the Robinson Consultants Inc. REV November 2010 Engineer's Report). The modifications terminate as a ditch inlet catch basin structure within the road allowance of Dwyer Hill Road along the current alignment of Branch No. 6 (as per the REV November 2010 Engineer's Report) at Station 6+660, for a total length of 180 metres. The remaining portions of Branch No. 6 both upstream and downstream of the modifications shall continue to be governed by the November 2010 Engineer's Report.

There are no financial implications associated with this report. Approved funding exists in capital internal order 907717 Dowdall Municipal Drain, Branch No. 6. All costs, which have initially been paid for by the City, will be assessed back to and recovered from the Department of National Defense. All costs for future maintenance are governed by and are to be distributed as per the 2010 Engineer's Report, with the exception that any cost for maintenance for the enclosed portion for the drain shall be assessed as a special

benefit to the owner of the property (W Pt. Lot 6, Con 4) for the enclosed portion of the drain (currently owned by Department of National Defense).

The *Drainage Act* prescribes the process and timelines that must be followed for any modification or construction of a municipal drain.

This report places the request for amendment to an existing drainage works before the Agriculture and Rural Affairs Committee and Council as required under Section 78 of the *Drainage Act*.

# Schedule for the Amendment to the Engineers Report for Branch No. 6 of the Dowdall Municipal Drain on the Department of National Defense property

Should the Agricultural and Rural Affairs Committee and Council adopt the Engineer's Report dated August 2015 and give 1st and 2nd reading to the provisional By-law, the estimated schedule will be as follows:

- Consideration of report and provisional By-law by Committee and Council October 2015
- Court of Revision at ARAC November 2015
- Drainage Tribunal 40 day appeal November & December 2015
- Third reading of the By-law January 2016

#### **RURAL IMPLICATIONS**

Branch No. 6 of the Dowdall Municipal Drain will continue to provide legal and sufficient outlet for rural lands and roads.

#### CONSULTATION

The required on-site meeting with the Department of National Defense was held on June 14, 2011 and a further meeting was held with the affected landowners and regulatory agencies on July 11, 2012.

The Councillor for Rideau-Goulbourn is aware of this report and the proposed drainage works.
