BY-LAW NO. 2020 -

A By-law of the City of Ottawa to provide for amendments to the existing John Taylor Municipal Drain in Lots 5 and 6, Concession VIII, Rideau-Goulbourn Ward, former Township of Rideau in the City of Ottawa.

AND WHEREAS the lands of the former Township of Rideau are now included in the City of Ottawa by virtue of the City of Ottawa Act, 1999, S.O. 1999, c.14, Sch.E;

AND WHEREAS every by-law of the Township of Rideau is deemed to be a by-law of the City of Ottawa pursuant to Section 5(6) of the said City of Ottawa Act, 1999;

AND WHEREAS, Andy Robinson, P. Eng. of Robinson Consultants Inc. (the "Drainage Engineer"), was appointed on February 11, 2015 by the Council of the City of Ottawa in accordance with the provisions of Section 78 of the *Drainage Act*, R.S.O. 1990, c. D.17 (the "*Drainage Act*") to prepare an engineer's report for realignment and modifications of the John Taylor Municipal Drain east of Proven Line Road in Lots 5 and 6, Concession VIII, Rideau-Goulbourn Ward, former Township of Rideau in the City of Ottawa;

AND WHEREAS the Drainage Engineer has prepared an engineer's report entitled Engineer's Report John Taylor Municipal Drain Realignment and Modifications dated August 2020 (the "Engineer's Report") and the report is attached hereto as Schedule "A";

AND WHEREAS the Main Drain of the John Taylor Municipal Drain is hereby abandoned from it's existing alignment from Station 302+05 to Station 314+54 in the Engineer's Report entitled John Taylor Municipal Drain dated October 1974, revised January 1975 by A.J. Graham Engineering Consultants Limited, pursuant to Subsection 84(5) of the *Drainage Act*, the City of Ottawa has no further obligation with respect thereto.

AND WHEREAS the John Taylor Municipal Drain, Main Drain from Station 10+589.1 to Station 11+101.4 and the Todd Branch from Station 0+000 to Station

0+358.7, upon enactment and passage of this by-law and shall be maintained in accordance with the Engineer's Report and provisions of the *Drainage Act*;

AND WHEREAS in accordance with the Engineer's Report the entire costs of the required drainage work shall be borne by the owners of the property requesting the modifications being the owner West ½ of Lot 6, Con VIII as described in Sections 2.0, 2.1 and 7.1 of the Engineer's Report;

AND WHEREAS Council of the City of Ottawa has considered the Engineer's Report in accordance with Section 42 of the Drainage Act, has made the decision to adopt the Engineer's Report and is therefore giving this by-law 1st and 2nd reading so that it is provisionally adopted under Section 45 of the *Drainage Act*;

THEREFORE the Council of the City of Ottawa enacts as follows:

- 1. The report entitled Engineer's Report John Taylor Municipal Drain Realignment and Modifications dated August 2020, attached hereto as Schedule "A", is hereby adopted and the drainage works as therein indicated and set forth is hereby authorized and shall be completed in accordance therewith.
- 2. The cost of future maintenance of the drainage works will continue to be in accordance with the Engineer's Report entitled John Taylor Municipal Drain dated October 1974, revised January 1975 by A.J. Graham Engineering Consultants Limited.
- 3. This by-law comes into force on the passing thereof and may be cited as the "John Taylor Municipal Drain By-law, 2020".
