DRAFT 2020 OPS BUDGET DISCUSSION

Presentation

During the presentation, the following points of clarification were made in response to questions raised:

- The draft budget contains an assumption of \$2.4M from the City's Tax Stabilization Fund however it is unclear whether this funding is confirmed.
- A new date can be added to the budget timetable for public delegations to address the Finance and Audit Committee on the budget – November 14, 2019, at 10:00am.
- City Council cannot direct the Board or Service with respect to the budget therefore the language used in the presentation should be revised to reflect this point.
- To attain a police tax rate increase of 3%, a gap of \$3.3M exists which the OPS believes it can achieve through different opportunities.
- The OPS is projecting a \$1M surplus for 2019.
- Given that OPS is a resource-based industry, it is not recommended that a cap be applied to compensation costs.
- The 500-officer hiring plan was an estimate and includes new hires and hiring for attrition. In 2018, 83 were hired and in 2019, 85.
- Fourth Class Constables begin at \$67,000 and within 4-5 years are First Class Constables with an annual salary of \$100,000.
- The OPS will work with the City to develop budget options that can achieve the 3% target without impacting planned hiring (i.e. 30 officer growth).
