PUBLIC DELEGATION

Erin Leigh, Executive Director of the Ottawa Coalition to End Violence Against Women; and,

Sunny Marriner, Project Lead of the Violence Against Women Advocate Case Review

The delegates spoke about the Canadian Framework for Collaborative Police Response on Sexual Violence, recently launched by the Canadian Association of Chiefs of Police. Their presentation focused on three areas; the need for increased: 1) awareness; 2) transparency; 3) expert guidance.

The delegates' ask of the Board was for the Board to request and receive statistics from the OPS pertaining to the number of violence against women reports and how many resulted in charges. They would like to see an increase in transparency around statistics pertaining to violence against women. They suggested Hamilton and Halton were examples of best practices in terms of data sharing. They also suggested providing annual presentations to the Board going forward and being invited to help inform the OPS' workplan.

The Chief stressed that violence against women was a priority for the Service, as was evidence-based, trauma informed, victim-centric service.
