Committee questions to the delegations and to staff were based upon the staff presentation and many of the points raised by the delegations, which included, but were not necessarily limited to: greater promotion of the quality of the City's tap water; eliminating plastic water bottle use at City facilities; additional funding for Energy Evolution and environmental infrastructure; tree replacement and reforestation; construction of energy-efficient housing; the development and implementation of bold new Strategic Priorities; greater use of a Climate Impact Lens in all decision-making; transitioning to electric transit vehicles and investing in transit infrastructure to get more vehicles off of the City's roadways.

Deliberations centred on the points raised above, and included discussions on the City's reserve funds, stormwater fees, greenhouse gas reduction targets, the value of recyclables, funding for education to foster increased recycling and green bin usage, the state of existing infrastructure, potential risks due to invasive flora and fauna, opportunities to collaborate with external organizations, and whether staffing levels are adequate to provide required services.
