BACKGROUND

On September 27, 2017, the National Capital Commission (NCC) Board of Directors approved the Capital Illumination Plan 2017-2027. The Plan is a ten-year comprehensive strategy for illuminating the nighttime landscape of the Capital core area. The Plan includes a series of principles and guidelines including tools for implementation. The Plan is available online on the NCC's website: http://ncc-ccn.gc.ca/our-plans/capital-illumination-plan.

The City was a key stakeholder in the development of the Plan. With the important role that the City has in the lighting of the area of the National Capital Region, the NCC has requested that the City be a signatory to the Charter of the Capital Illumination Plan, as contained in Document 1.

The purpose of this report is to provide a brief outline of the Capital Illumination Plan as it relates to the role of the City in partnership with the NCC, City of Gatineau and the Federal government and the obligation of being a signatory to the Charter.

DISCUSSION

Overview of the Plan

The boundaries of the Capital Illumination Plan include the Capital Core Area as defined by the NCC as well as some additional lands in the City. Specifically, within the boundaries of Ottawa, the Plan covers the Central Area, Metcalfe Street (to the Museum of Nature), the ByWard Market, Rideau River (to Porter Island), a portion of Lowertown and a portion of New Edinburgh (Rideau Hall).

Prior to the development of this Plan, there was a lack of a comprehensive nighttime lighting strategy in the core area of the Capital, with some landmarks difficult to see at

night as well as aging roadway and public lighting. The purpose of lighting has also evolved over time from primarily functional purposes for safety and security to also being an important element of architectural and urban design. The Plan is a recognition of this evolution and that the core area of the Capital presents a unique opportunity to implement new and updated lighting in a comprehensive manner, straddling both sides of the Ottawa River and at different levels of government. This approach still provides safety and security but can also contribute positively to the architecture of buildings, the design of public spaces and provide a sense of place and cohesion even at nighttime. The Plan is a guide to help manage existing lighting, identify priority lighting projects, and assist with the design and evaluation of new lighting projects.

The Plan provides a vision along with six principles which are the basis of the Plan and provide the framework for implementation. The vision of the Plan is:

"The nighttime Capital offers memorable experiences, showcases its distinctive character and contributes to a sustainable future."

The six principles of the Plan are:

- Adopt responsible environmental management practices
- 2. Reveal the beauty of the central Capital landscape
- 3. Showcase Confederation Boulevard
- 4. Strengthen the multiple identities of the Capital core area
- 5. Balance the role of light and the role of darkness
- 6. Collaborate and coordinate in support of a global nighttime image

The Plan also provides a series of guidelines for lighting projects. These guidelines provide details and guidance on the process for lighting projects, urban design, sustainable design as well as health, safety and universal accessibility. The guidelines identify key illumination zones including which buildings should be prioritized for architectural lighting as well as dark zones (waterways and greenspaces); nighttime landmarks (Confederation Boulevard, nodes, feature sites and buildings); nightlife areas (Art and innovation districts, nightlife districts and Sparks Street); and evolving areas (LeBreton Flats, Chaudières sector and Albert Island).

Charter of the Capital Illumination Plan

As previously mentioned, the Capital Illumination Plan provides a unique opportunity to

undertake a comprehensive approach to lighting design for the core area of the Capital, reaching both sides of the Ottawa River. The Charter seeks to affirm a commitment from the City to endorse the vision and principles of the Plan, to help implement the illumination concept and guidelines as well as collaborate in the development of future lighting initiatives in the area, while helping to monitor the success of the Plan.

Role of the City of Ottawa

For the City, endorsement of this Plan presents an opportunity to work collaboratively with the NCC, City of Gatineau and Federal Government departments.

In many ways, the City has been addressing the illumination of important sites in the core area. The City's Official Plan has several policies acknowledging the importance of lighting with respect to the design of buildings in Design Priority Areas, lighting along Scenic Entry Routes, cultural heritage resources, light sensitive areas, and for active transportation, safety and accessibility. There are a number of City design guidelines that also include exterior lighting, the most recent being the Urban Design Guidelines for High-rise Buildings, which was updated in 2018. These guidelines address exterior lighting for individual high-rise buildings and reference the Capital Illumination Plan but does not have any guidelines dedicated to the illumination of the entire core area. The Capital Illumination Plan fills that gap and provides the tool to implement lighting design at the municipal level, which can have a positive contribution on views and important buildings and landmarks for the core area of the Capital.

There are many ways in which the City can integrate the use of the Capital Illumination Plan in the City's development application processes. Lighting design is examined at the Site Plan application stage and the Capital Illumination Plan provides a useful resource at the municipal level. City staff, applicants and the Urban Design Review Panel (when applicable) can use the Capital Illumination Plan for guidance on illumination and to ensure that the proposed lighting design contributes positively to the area's global nighttime image.

The City also has a number of design guidelines and policies for capital projects and development on City-owned lands, which address lighting as an element of the overall project. The Transitway Design Manual, Right of Way Lighting Policy and Downtown Moves are three examples that speak to the illumination of transitways, right-of-ways, and public spaces. The intent of the Illumination Plan is not to replace City policy or

guidelines, rather it is to assist in the analysis of the lighting design and to ensure that the design contributes to the overall global nighttime image.

During design guideline and policy updates, staff can continue to consider adding references to the Capital Illumination Plan to ensure that they are considered through the Development Review and capital project design processes.

The Plan provides the City the opportunity to not only participate to implement the principles of the Plan but can also give the City the opportunity to share our successes with the other partners. The replacement of street lights to LED has introduced more sustainable and environmentally friendly lighting throughout the city and there are many advancements that are possible with the Smart City initiative in the years to come. As signatories to the Charter, the City can participate fully in the illumination plans for the core area of the Capital, sharing and gaining knowledge from the City of Gatineau, the NCC and the Federal government.

Conclusion

While lighting design has always been considered at the City level, there have not been any tools available to guide lighting design at a high-level, with a comprehensive approach that spans beyond the City's municipal boundaries and involves other levels of government. The Capital Illumination Plan provides this tool and the opportunity for the City to work with the other signatories to ensure that the nighttime Capital reveals its unique character.

Staff recommend that the City be a signatory to the Charter of the Capital Illumination Plan.
