9. PERFORMANCE REPORT: THIRD QUARTER 2018

Chief's report

Staff was asked to look back 10 to 20 years to see the history of what preoccupied police officers' time as a way to see how crime has evolved. This would provide a better picture of how policing has changed and what skills and criteria are necessary for today's work

Statistics go back to amalgamation. Historically, policing has been focused on reporting crime; so the data may show a change in crime trends. Where policing has evolved most is in the complexity of the crime and all the other social disorders and quality of life issues that officers now face on a daily basis. The Canadian Association of Chiefs of Police (CACP) has been working with partners to develop a new matrix to identify the quality of life and social disorder types of calls for service. Approximately 20 – 25% of work that officers do relates to crime the rest relates to other types of calls for service. Compared to 20 years ago, there are some very basic elements that have remained the same when hiring police officers. Education and other types of competencies are changing and the ability to deal with people in different settings.

It was suggested this information be shared with the public as it might encourage more diversified individuals to apply to policing. The findings should be a snapshot of the data, one page comparing officers of 20 years ago to today, showing how much policing has changed.
