STATEMENT REQUIRED UNDER THE PLANNING ACT

The Chair read a statement required under the *Planning Act*, which advised anyone intending to appeal the Zoning By-laws listed as Items 2 to 8 on the agenda that they must either voice their objections at the public meeting or submit comments in writing prior to the Amendments being adopted by City Council on 13 June 2012, failing which, the Ontario Municipal Board (OMB) might dismiss all or part of the appeals. In addition, it was noted that applicants could appeal the matters to the OMB if Council did not adopt amendments within 120 days for Zoning, or 180 days for an Official Plan Amendment, of receipt of the applications.
