That the Ottawa Police Services Board approve the appointment of Benjamin SPLIT, as Special Constable pursuant to Section 53 of the *Police Services Act*, in accordance with the terms and conditions set forth in the Approval of Appointment form.

## **BACKGROUND**

The employee has been hired as a Computer Forensic Examiner and is assigned to the Computer Forensic Unit. The appointment ensures that this employee can carry out his assigned duty as a Computer Forensic Examiner. An application is made to the Ministry of Community Safety and Correctional Services to have him appointed as a

Special Constable pursuant to Section 53 of the Police Services Act. The Board appoints the employee as a Special Constable upon approval by the Ministry for a five-year period or until the appointee is no longer in the employ of the Ottawa Police Service (OPS). Upon the termination of employment, the OPS advises the Ministry to terminate the appointment.

#### DISCUSSION

The Board is being asked to approve this appointment as Special Constable in accordance with the above noted process.

Some of his responsibilities include conducting investigations that deal with computer technology. He will assist in the preparation and execution of search warrants, and conduct electronic search and seizure procedures.

Approval has been obtained from the Ministry of Community Safety and Correctional Services for the appointment of this OPS member as Special Constable.
