**REPORT RECOMMENDATIONS**

- 2. That the signed audited Financial Statements of Ottawa Community Housing Corporation (OCHC) for the year 2020 as described in this report and set out in Document 2 be received; and**
- 3. That the reappointment of Rebecca Hickey and the appointment of Jennifer Mondoux to the Ottawa Community Housing Corporation (OCHC) Board of Directors as Community Members for terms of three (3) years, expiring at the 2024 OCHC Annual General Meeting (AGM) as described in this report and set out in Document 3 be approved; and**
- 4. That the Ottawa Community Housing Corporation (OCHC) By-Law No. 11 be repealed and be replaced by a new By-Law No. 12 incorporating changes to permit up to two OCHC tenants on the Board as described in this report and set out in Document 4 received Documents 5 and 6; and**
- 5. That the Mayor and the City Clerk be authorized to sign a written resolution on behalf of the City of Ottawa as Shareholder of OCHC setting out the resolutions approved by City Council.**

## **BACKGROUND**

The report provides information to support the holding of the Annual General Meeting with City Council as the sole Shareholder.

## **DISCUSSION**

### **Recommendation 1:**

Ottawa Community Housing Corporation's ten-year strategic plan is executed through a cycle of three-year action plans. The 2020 Annual Report highlights achievements and results under each of the Corporation's four strategic goals. The report summarizes the progress related to nurturing community and capacity, delivering core services to tenants, innovating to meet housing portfolio needs and leading through accountability and continuous improvement. The Annual Report is set out in Document 1.

### **Recommendation 2:**

The Shareholder Direction requires OCHC to present its audited financial statements for information to its Shareholder. The firm of Ernst and Young is OCHC's auditor. Ms. Deanna Monaghan, Ms. Brenda Lim and Ms. Mita Meyers of Ernst and Young attended the May 4, 2021 Finance and Audit Committee meeting to respond to questions and comments.

The 2020 audited financial statements approved by the OCHC Board of Directors on May 13, 2021.

The signed, audited financial statements are set out in Document 2.

**Recommendation 3:**

That Rebecca Hickey, current Chair of the Client Services Committee, be reappointed to the OCHC Board of Directors and that Jennifer Mondoux, current member of Corporate Performance Committee, be appointed to the OCHC Board of Directors as community members, for a term of three (3) years expiring at the AGM in 2024, as set out in Document 3.

**Recommendation 4:**

OCHC's Board is recommending to the Shareholder amendments to its current operating By-Law 11, see Document 4. The proposed amendments, described in Document 5, will increase the amount of tenant participation in OCHC governance by permitting up to two (2) tenants to sit on OCHC's Board of Directors. The amended By-Law 12, Document 6, becomes legally effective when approved by the Shareholder.

**Recommendation 5:**

That the Mayor and the City Clerk be authorized to sign a written resolution on behalf of the City of Ottawa as Shareholder of OCHC setting out the resolutions approved by City Council.
