BACKGROUND

This employee has been hired as a Special Constable and assigned to the Central Cellblock and Prison Care Unit. The appointment ensures that this employee can carry out his assigned duty as a Special Constable. An application is made to the Ministry of Community Safety and Correctional Services to have him appointed as Special

Constable pursuant to Section 53 of the Police Services Act. The Board appoints the employee as a Special Constable upon approval by the Ministry for a five-year period or until the appointee is no longer in the employ of the Ottawa Police Service (OPS). Upon the termination of employment, the OPS advises the Ministry to terminate the appointment.

DISCUSSION

The Board is being asked to approve this appointment as Special Constable in accordance with the above noted process.

Some of his responsibilities include the transportation and custody of prisoners being moved between detention facilities and other locations such as courts; providing security at premises or places occupied or utilized as courts; maintaining security at the courthouse, cellblock, and other OPS detention facilities.

Approval has been obtained from the Ministry of Community Safety and Correctional Services for the appointments of these OPS members as Special Constables.
