BACKGROUND

Attendance

Attached at Document 1 is information about the Canadian Association of Police Governance (CAPG) 28th Annual Conference being held in Montreal, Quebec from July 14 – 16, 2017. All members of the Police Services Board received the conference information and were canvassed regarding their interest in attending. Chair El-Chantiry, Members Hubley and Smallwood and Executive Director Ferraro have advised they wish to attend. Two have a vested interest in attending: Member Smallwood is a member of the CAPG Board of Directors.

The Ottawa Police Services Board recognizes the importance of ongoing professional development and education for its members through its policies and in particular through the training policy adopted in 2006 in response to a recommendation from the City's Auditor General. The Board also ensures that sufficient funds are included in its budget each year to support its commitment to ongoing education and to enable Board members to attend various learning opportunities throughout the year.

Sponsorship

Attached at Document 2 is a letter from CAPG Executive Director Jennifer Malloy, inviting boards to support the 2017 Conference with a financial contribution.

CONSULTATION

FINANCIAL IMPLICATIONS

The approximate cost of attending the conference is \$2,500 per person. Funds have been allocated for this expense in the 2017 Employee Development and Travel account, there are sufficient funds remaining in the Board's budget to cover this expenditure.

Discretionary funds in the amount of \$85,000 have been included in the Board's 2017 budget, with \$17,000 of that earmarked for specific purposes (\$10,000 for the Street Ambassador Program, and \$7,000 for the Police Association Scholarship Fund). Based on projected requests for discretionary funding in 2017, there are sufficient funds to cover this expenditure.
