#### Primary concerns, by individual

**Elitza Palazov** (written submission)

- safety concerns due to increased traffic
  - Brasseur Cres. is composed of townhomes of families with small children, mostly attending Maple Ridge Elementary School on Valin St.; the new units will increase traffic, which poses risks to the children walking to school
  - safety and traffic calming initiatives that should be taken under consideration, and something similar to the speed bump that was installed to mitigate traffic on Destiny Private should be considered for Brasseur Cres. Or Winsome Terr.
- concerns regarding conservation ecology of fireflies, which are currently active in the area
  - ripping the grasses and shrubs that have provided shelter to fireflies and beetles for the past years would disrupt their cycle of life; referenced an article from a reputable scientific magazine about firefly tourism that calls for sustainable practices and suggested that conservation of these beetles should be taken into consideration during this ecological devastation of grasses and shrubs

### **Primary concerns, by individual**

#### **Elitza Palazov**

- repeated previous concern about the impact of densification on the safety of kids playing on Brasseur Cres. Due to increased traffic; this is of huge concern, especially in light that Maple Ridge is an Elementary school and the children are not aware of traffic (compared to High school students); suggested that possibly diminishing the number of units could be an option or building single houses, thus diminishing traffic
- repeated previous concern about saving the current grasses that house fireflies, which are ever so popular and in need of a home; suggested possibly leaving some wild spaces, with uncut grass between yards, could accommodate these species and the numerous birds that visit back yards
