BACKGROUND

The Transportation Committee at its meeting of July 5, 2021, approved the following motion, which was added to the agenda pursuant to subsection 89(3) of the Procedure By-law:

WHEREAS the local tourism industry has suffered substantial economic impacts as a result of the COVID-19 pandemic; and

WHEREAS due to the ongoing COVID-19 situation and the anticipated capacity restrictions from the Province of Ontario and associated recommendations from Ottawa Public Health, which will limit the capacity of tourism operations in contrast to previous years; and

WHEREAS tourism operators will want to establish their tourist information kiosks as soon as provincial restrictions permit; and

WHEREAS the City of Ottawa requires permits for tourist information kiosks, in accordance with the provisions of the Encroachments on City Highways By-law (No. 2003-446); and

WHEREAS for tourist information kiosks, the City of Ottawa charges a permit processing fee and fees based on the size of the tourist information kiosk; and

WHEREAS the City of Ottawa can support the local economy by providing a one-time waiver of the tourist information kiosk permit fees.

BE IT RESOLVED that the Tourist Information Kiosk fees, as contained in Schedule B of the Encroachments on City Highways By-law (No. 2003-446), except for the permit processing fees, be waived for tourism operators; and

AND BE IT FURTHER RESOLVED that the anticipated forecasted revenue loss of \$15,000 be recovered from the Provincial Safe Restart program, and should it not be eligible, from the overall 2021 Right of Way, Heritage and Urban Design Service Area operating position; and

BE IT FURTHER RESOLVED that Council be requested to suspend the Rules of Procedure to consider this item at its meeting of July 7, 2021.

The Committee unanimously supported the aforementioned motion, which included a request and agreed that it be presented to Council on July 7, 2021.
