DISCUSSION

The City's Community and Social Services Department (CSSD) aims to improve the quality of life for our most vulnerable residents in the areas of equity and inclusiveness, Indigenous relations, social assistance and employment, long-term care, child care, housing and homelessness prevention and social development. CSSD delivers provincially mandated and Council-approved programs that provide support to families and individuals to promote their self-reliance and quality of life in collaboration with our community partners.

The majority of services and programs are governed by specific provincial legislation and are cost-shared to varying degrees. The City also has complementary programs in some areas of the social services sector that provide 100% funding under the City's

This report reaffirms for this Term of Council that the Community and Social Services Department will maintain the Essential Health and Social Supports (EHSS) Program and the Supports in Social Housing (SSH) Program, as outlined in this report and subject to annual budget allocations.

Essential Health and Social Supports Program

The Essential Health and Social Supports (EHSS) Program is 100% funded by the City of Ottawa and was established in 1998 when the Province eliminated the cost shared Special Assistance and Supplementary Aid Programs that assisted low-income residents, not in receipt of social assistance, with the purchase of essential health related items. The City of Ottawa approved budget to fund the EHSS program is \$2.185M for each of 2019, 2020 and 2021.

The EHSS program is administered by the Employment and Social Services (ESS) branch of Community and Social Services Department, in accordance with the Essential Health and Social Supports Policy and Procedures. It is an income and asset tested program that supports low-income residents who require assistance with health-related items or assistance to retain housing or employment. Essential health related items include items or services such as dental care, vision care, medical supplies such as incontinence, surgical and diabetic supplies, as well as bathroom aids, and direct disposition (burials). The program also supports eligible low-income persons to maintain independent living arrangements; avoiding hospitalization or institutionalization thus preventing future needs that could require more costly measures.

ESS staff meet with low-income applicants to assess eligibility by completing an income test using a low-income cut-off (LICO) and asset levels based on family size to determine eligibility. In order to be eligible for the EHSS program, applicants cannot be in receipt of Ontario Works or the Ontario Disability Support Program (ODSP).

The Essential Health and Social Supports Program was reaffirmed by the previous Term of Council on May 24, 2017 (ACS2017-CSS-GEN-0004).

Supports in Social Housing Program

Since 2009, municipal funding has been invested in homelessness services through the City's Supports in Social Housing (SSH) Program, which is administered by Housing Services to several community non-profit agencies. The City of Ottawa approved budget for 2021 is \$1.492M.

The program's objective is to provide case management and housing supports for clients who have a history of chronic homelessness, in order to:

- Improve the housing stability and quality of life of individuals who are experiencing chronic homelessness and individuals living in social housing who have a history of homelessness and complex needs;
- Support social housing providers and other housing providers to maintain healthy, safe living environments while offering housing to this clientele;
- Reduce the costs of providing emergency shelter in Ottawa by assisting people to avoid homelessness.

The program's design was based on consultation, and allocations were made through a competitive process in which support-service agencies partnered with a social housing provider, proposing to provide housing with suitable supports, using existing units of social housing. Five homelessness services agencies and two social housing providers (Ottawa Community Housing Corporation (OCHC) and Centretown Citizens Ottawa Corporation (CCOC)) were selected, as well as the Royal Ottawa Health Care Group, to provide half-time psychiatric nursing support.

In 2017, once Housing Services had established a related program called Housing First providing similar services to a similar clientele, four of the SSH contracts were amended to align with Housing First, as follows:

- All future new SSH clients who were not already housed at OHCC or CCOC when they joined a SSH caseload would be prioritized for service through the Coordinated Access system that had been established for Housing First.
- SSH clients being housed would be eligible for the Apartment Set-up funding provided through the provincial Home for Good funding of up to \$1,500 per Housing First client.

The Supports in Social Housing Program was reaffirmed by the previous Term of Council on April 27th, 2016 (ACS2016-COS-CSS-0004).
