## **BACKGROUND**

# **The Community Partnership Minor Capital Program**

This program was established in 2001 to implement minor capital improvements to parks and recreation facilities on a cost-sharing basis with community groups. The program focuses on smaller projects with grants up to a maximum of \$10,000 on city property and \$7,500 on other public land. The City's capital budget for the program is set annually through the budget process. Applications are reviewed and funds are allocated, under delegated authority as per the program's guidelines, with the Department reporting on grant allocations to Committee and Council annually.

As neighbourhoods change both socially and demographically, this program provides an effective means of responding quickly to the needs of communities. Community participation in fundraising, planning and installation of recreational facilities promotes community pride, ownership and stewardship of parks and recreation facilities in their communities.

# **Community Partnership Major Capital Program**

In response to significant uptake on the Community Partnership Minor Capital Program in 2004, Council approved the Community Partnership Major Capital Program.

The Community Partnership Major Capital Program is an initiative to implement major capital improvements to parks and recreation facilities on a cost-sharing basis with community partners. The City's annual budget process sets the capital budget amount for the program and while there is no set limit on the maximum grant available, total project values are restricted to actual funds available. Applications are evaluated against the approved criteria and staff recommendations are brought forward annually

to Committee and Council for approval.

This larger program seeks to achieve the following objectives:

- Develop capital projects that respond to priority needs as identified through Departmental and City planning documents
- Support community initiatives in developing and improving facilities that serve the community
- Develop cost effective capital projects that leverage funding from other sources

The Program provides opportunities to partner with community organizations to implement major capital projects. Eligible projects include capital initiatives for new development, renovations and expansions of parks and recreation facilities. These projects are typically larger in scale and cost more than what could be financed through the Community Partnership Minor Capital Program.

### DISCUSSION

### **Community Partnership Minor Capital Program 2020**

The Department received 10 applications as part of the 2020 application process, of which six (6) met the program criteria and were approved. Two (2) projects have been completed, four (4) are in progress, and four (4) were deemed ineligible or withdrawn by the applicant.

Refer to Supporting Document 1 for details. Staff continue to work with applicants to ensure projects are completed in compliance with City standards and guidelines. Given the challenges of fundraising by community groups to raise matching funding, it is acknowledged that not all projects will be completed within a 1-year time period.

# **Community Partnership Major Capital Program 2021**

Due to challenging financial pressures in 2020, related to the pandemic, the 2020 major capital budget provision was returned to source as part of the July 7, 2020 Capital Budget Adjustments and Closing of Projects Report to Committee and Council (ACS2020-FSD-FIN-0015).

As funds were not available to fund the program in 2020, the March 1, 2020 proposals were deferred to 2021. Proposals received in 2020 and new proposals received up to the March 1, 2021 deadline were evaluated as per the criteria detailed in the guidelines.

The Department received fifteen (15) proposals in 2021, as detailed in Supporting Document 2.

There are eleven (11) projects recommended for approval in principle with the total requested City contribution approximated at \$1,229,800. There are four (4) projects not recommended for approval, all are listed in Document 2.

Updates to the status of projects previously approved by Council are listed in Supporting Document 3.

The Arcadia Splashpad project in Ward 4 was approved in principle in 2018 during the previous term of Council. The community association has since disbanded, consequently the project is not proceeding. As such, the funds will be returned to the major capital partnership balance to allocate towards new projects.

As per previous council approval received on July 21, 2021 for report number: <a href="ACS2020-RCF-GEN-0007">ACS2020-RCF-GEN-0007</a>; the Ottawa South United Soccer Association (OSU) Fieldhouse project in George Nelms Sports Park will return \$350,000 to the major capital partnership balance to allocate towards new projects.

### FINANCIAL IMPLICATIONS

Sufficient funds are available in the existing RCFS Minor and Major capital funding program budgets for the 2021 projects.

### **LEGAL IMPLICATIONS**

There is no legal impediment to receiving the information described in report recommendation numbers 1 and 3 and there are no legal impediments to the implementation of the report recommendations.
