## BACKGROUND

*The Transportation Committee at its meeting of November 1, 2021, approved the following motion, which was added to the agenda pursuant to subsection 89(3) of the Procedure By-law:*

*WHEREAS the City of Ottawa provides crossing guards for children going to elementary schools at intersections that meet the City's criteria as posing a risk to the safety of children crossing,*

*WHEREAS City staff have studied the necessity for crossing guards at warranted intersections for the 2021-2022 School year and determined that 8 locations currently meet the City's criteria and therefore warrant a crossing guard;*

*WHEREAS funding will be requested in the 2022 Budget for the installation of new crossing guard locations for the 2021-2022 school year that meet warrant criteria beginning in January 2022,*

*WHEREAS additional funding is required to install the 8 newly warranted crossing guards as soon as possible to align with current needs of various communities to ensure children's safe travel to and from schools,*

*WHEREAS Council is not permitted to pre-commit funds in advance of the tabling and adoption of the 2022 budget; and,*

*WHEREAS schools across the City of Ottawa were closed due to the Covid-19 pandemic resulting in crossing guards not being in place in May and June 2021 providing a surplus in the Traffic Services 2021 Adult School Crossing Guard Program.*

*THEREFORE BE IT RESOLVED, that the Transportation Committee recommend Council approve the implementation of the 8 new warranted school crossing guard locations for the remainder of the 2021 budget year, with the one-time cost of \$15,000 to be funded from the Traffic Services 2021 Adult School Crossing Guard Program.*

## DISCUSSION

The Committee unanimously supported the aforementioned motion and agreed that it would be presented to Council on November 10, 2021.
