The Committee then heard from the following delegations offering their views and suggestions for the Committee's portion of the 2022 City Budget:

Ken Holmes\* opined that a long-term plan is required to fix Ottawa's roads infrastructure and highlighted some of the consequences of insufficient funding of roads maintenance and renewal work.

Neil Saravamutto spoke to active transportation, dedicated cycling infrastructure and the benefits of completing work on the cycling network over three years as opposed to over 25.

Sally Thomas, Healthy Transportation Coalition\* touched on accessible pedestrian infrastructure, inclusive 15-minute neighbourhoods, poor sidewalk maintenance, the impact of insufficient snow and ice clearing on people using a mobility device and the need for more investments to improve pedestrian infrastructure.

Érinn Cunningham, Bike Ottawa touched on the lack of adequate funding for existing roads, the need for dedicated funding for high-risk intersections and to prioritize bike infrastructure. Cycling is the fastest growing mode of transportation and noted that active transportation is important for reducing green house gas emissions.
