That Council approve an amendment to Zoning By-law 2008-250 for 2256 Burnt Lands Road for the purposes of rezoning the lands from Agricultural Zone (AG1) to Agricultural Zone, Subzone 5 (AG5), to prohibit residential use on the retained farmlands, as detailed in Document 2.

#### **Description of site and surroundings**

The subject property is located on the northeast side of Burnt Lands Road, north of the Vaughan Side Road and Burnt Lands Road intersection. The lands to be rezoned have a frontage of approximately 468.11 metres on Burnt Lands Roads and a lot area of approximately 35.57 hectares. The site is currently zoned Agricultural Zone, subzone 1 (AG1) and contains two existing barns and a detached shed. The property is surrounded by similar agricultural parcels.

#### Summary of requested Zoning By-law amendment proposal

The application has been submitted in order to fulfill a condition of severance approval imposed by the Committee of Adjustment with respect to applications D08-01-21/B-00165. The intent is to prohibit residential uses on the retained lands.

#### Brief history of proposal

An application for a Severance (D08-01-21/B-00165) of a surplus farm dwelling at 2256 Burnt Lands went before the Committee of Adjustment Panel 3 on July 7, 2021. Planning staff requested an adjournment to allow for the applicant to reduce the size of the proposed residential lot and to address concerns about Minimum Distance

Separation (MDS) requirements. The applicant and Committee agreed to staff's request. The applicant's subsequent investigation of the MDS requirements determined that the residential lot required a minor variance.

At an August 18 hearing, the Committee granted the Consent (D08-01-21/B-00165) and Minor Variance application (D08-02-21/A-00264). Staff were in support of both applications. Once the severance is finalized, the retained farmland will become known as 2220 Burnt Lands Road.

### DISCUSSION

#### **Public consultation**

Notification and public consultation were undertaken in accordance with the Public Notification and Public Consultation Policy approved by City Council for Zoning By-law amendments. No concerns were identified.

#### Official Plan designation(s)

Because this application was deemed complete after the day before the new Official Plan was adopted (on October 27, 2021), but before the Minister's approval of the new Official Plan, it must be evaluated against the <u>existing Official Plan</u>, and staff's report must also include an evaluation of the application against the Council approved <u>new Official Plan</u> (and new Secondary Plan, where applicable). In this current period, between Council approval of the New OP and the Minister's approval of the new Official Plan (OP), staff are to apply whichever provision, as between the existing and new OPs, is more restrictive.

### Existing Official Plan

The property is designated as Agricultural Resource Area as per Schedule A of the existing Official Plan. The Agricultural Resource Area designation protects prime agricultural areas from loss of lands to other uses. Severances are permitted for a surplus dwelling due to farm consolidation under Section 3.7.3.9 and 10. Section 3.7.3.10.b requires the vacant agricultural parcel be rezoned to prohibit any future residential use, and (10 c) stipulates that the size of the severed lot be a size that minimizes the loss of agricultural lands. This Zoning By-law amendment application

satisfies the requirements of the Official Plan [Section 3.7.3.10.b] as conditioned by the Committee of Adjustment.

### New Official Plan

The property is designated Agricultural Resource Area as per Schedule B9. The Agricultural Resource Area designation protects lands with Land Evaluation and Area Review (LEAR) Class 1, 2, and 3 soils for long terms agricultural production. Protection of lands identified through LEAR is accomplished through limiting development that would compromise productivity of agricultural operations. Section 9.1.3 of the New Official Plan "Protect farmland from uses that would impede productive farming operations" Policy 3) prohibits lot creation unless the lot contains a habitable dwelling made surplus through farm consolidation. In such cases, as a condition of severance, the agricultural parcel is required to be zoned to prohibit residential uses. Surplus farm dwelling severances must fulfill other criteria which are assessed at the point of severance application.

### **Planning rationale**

This Zoning By-law amendment will affect approximately 35.57 hectares of agricultural land, as shown in Document 1. This change is to rezone the severed parcel identified as Part of 2256 Burnt Lands Road in Document 1, from Agricultural Zone, Subzone 1 (AG1) to Agricultural Zone, Subzone 5 (AG5) fulfills a condition relating to the approval of surplus farm dwelling severance application granted by the Committee of Adjustment on August 18, 2021. Staff had no concerns with the severance application or the related minor variance and have determined that the proposed rezoning is consistent with both the existing Official Plan and the new Official Plan. No new development is proposed.

### **Provincial Policy Statement**

Staff have reviewed this proposal and have determined that it is consistent with the 2020 Provincial Policy Statement.

### **RURAL IMPLICATIONS**

This Zoning By-law amendment will restrict new residential development and prevent the loss of agricultural land to other competing uses. This application protects the


