# Civic and Commemorative Events Fund

## 1. Civic Events Funding

The Civic Events Funding Program provides an opportunity for local non-profit organizations to deliver one to two-day community events in Ottawa that are free for residents to attend. These events encompass a broad range of activities and family entertainment.

In 2020, because of the impact of COVID-19, most of the planned Civic Events were cancelled. Of the 29 successful applicants, eight were able to hold their events. Of these, six were held prior to the COVID-19 lockdowns and two held on-line events.
